Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Pohlad Companies Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Pohlad Companies Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Pohlad Companies Retirement Savings Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Pohlad Companies Retirement Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

NOTE 1 DESCRIPTION OF PLAN

The following is not a comprehensive description of Pohlads Companies Retirement Savings Plan (the Plan) and, therefore, does not include all situations and limitations covered by the Plan. Participants should refer to the Plan agreement for more complete information.

General

The Plan is a single-Employer defined contribution plan providing retirement benefits to eligible employees of a number of related companies that are in one control group and have elected to participate under the terms of the Plan. The Company, as defined by the Plan, is Pohlads Companies, LLC, a Minnesota limited liability company, and any successor Employer thereof. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

The Company is a participating Employer in the Plan. With the consent of the Company, any other Employer affiliated with the Company may become a participating Employer in the Plan effective as of the date specified by it in its adoption of the Plan. Any successor Employer to a participating Employer shall also be a participating Employer in the Plan. An Employer shall automatically cease to be a participating Employer, in accordance with the provisions of Securities and Exchange Commission (SEC) Rule 13.8, when the entity ceases to be under common control with the Company.

Plan Operations

The Company is the Plan Sponsor and Plan administrator. The Plan Sponsor has appointed a Retirement Plan Committee to manage the Plan. The Plan's trustee is Empower Trust Company, LLC. The trustee is responsible for holding the assets of the Plan, executing asset transactions, making disbursements to participants, and providing the Plan Sponsor with a list of the Plan's assets and changes in assets.

Eligibility

All regular (nontemporary) employees in a job classification in which they are scheduled to work at least 1,000 hours per year are eligible to participate on the first day of the month coinciding with or after they have reached age 18. All employees in a job classification in which they are scheduled to work less than 1,000 hours per year are able to participate on the first January 1 or July 1 after they have reached one year of eligibility (at the end of a 12-month period beginning on their date of hire or any subsequent anniversary of that date, if they complete 1,000 hours or more of service during that period) and have reached age 18.

Effective January 1, 2024, it was approved to:

- Change eligibility service to immediate for all eligible employees,
- Change to elapsed time/no hours requirement for employee deferrals, and
- Change the entry date to monthly.

Contributions

Participating employees may elect to make contributions to the Plan based on a percentage of their compensation, up to a maximum of 75% or as limited by the Internal Revenue Code (IRC). New participants are automatically enrolled in the Plan with a pretax contribution election of 5%. Participants have the option to opt out of automatic enrollment or make an affirmative election of a different contribution percentage. Participants may also contribute amounts representing distributions from other qualified plans. Each participating Employer currently contributes as a matching contribution an amount equal to 100% of the participant's first 3% and 50% of the next 2% of pretax and Roth contributions up to a maximum of 4% of the participant's annual compensation, as defined by the Plan.

The participating Employers may also make a discretionary nonelective contribution to participants who have worked 1,000 hours during the Plan year and were employed by the participating Employer on the last day of the Plan year. These requirements are waived for participants who retired after age 65, became disabled, or died during the year for which a discretionary contribution is made. Discretionary nonelective contributions of \$3,766,096 were made for 2024 and are included in Employer contributions receivable in the 2024 statement of net assets available for benefits, net of forfeitures of \$308,606.

Effective January 1, 2024, it was approved to remove the allocation condition of 1,000 hours and employed on the last day of the plan year for discretionary nonelective contributions.

Forfeited Accounts and Vesting

Participants' accounts are fully vested at all times, except for the participating Employers' nonelective discretionary contributions and related earnings thereon, which are vested on a graded scale over five years of benefit service, as defined by the Plan. At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$450,000 and \$110,000, respectively. These amounts may be used to fund future Employer contributions to the Plan. During 2024, the Plan used approximately \$138,000 of forfeited nonvested accounts to fund Employer contributions.

Participant Accounts

Each participant's account is credited with the participant's contributions, matching contributions, allocations of the nonelective discretionary contributions, if any, and allocations of investment results. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Investment results for each fund are allocated to each participant's account in accordance with each participant's average proportionate investment in that fund. The discretionary contributions of the participating Employers are allocated proportionately to each participant's account according to each participant's share of total qualified compensation, as defined by the Plan. Participants may direct their accounts into any of the investment options offered by the Plan, which are more fully described in the Plan's literature. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants in the Plan are entitled to obtain a note from the Plan for a minimum of \$1,000 up to a maximum of 50% or \$50,000 of their vested account balance, subject to certain restrictions. The maximum note term is five years, unless the note is for the purchase of a primary residence, with principal and interest paid in level amortized payments through payroll deductions. As of December 31, 2024, participant notes had interest rates ranging from 3.25% to 8.5%, with maturities through April 2039. Notes receivable from participants are secured by the balance in the participant's account and bear interest at the rate in effect on the date the note request is processed.

Effective January 1, 2024, any loan that qualifies as a "home loan" may be repaid over 15 years.

Payment of Benefits

Upon retirement, death, permanent disability, or other termination of employment, a participant, or the participant's beneficiary, has an option to receive the vested portion of his or her account balance as a lump-sum payment or as installment payments as described in the Plan agreement. The Plan allows in-service withdrawals after age 59½ for any reason and financial hardship withdrawals, as defined, before age 59½. Distribution of benefits upon termination becomes automatic if the participant's account balance is less than \$5,000. Unless otherwise elected, participants with an account balance less than \$5,000, but greater than \$1,000, receive a direct rollover into a qualified individual retirement account. Those with a balance of less than \$1,000, receive a lump-sum payment. Upon termination, participants may elect to leave their funds in the Plan up to the current minimum required distribution age as defined in the Plan agreement.

NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Retirement Plan Committee determines the Plan's valuation policies utilizing information provided by the Plan's investment advisors and trustee. See Note 4 for a discussion of fair value measurements.

Investment Valuation and Income Recognition (Continued)

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in supplemental schedule, schedule H, line 4i—schedule of assets (held at end of year).

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

The majority of the administrative expenses are paid by the Plan; however, the Company may also pay certain administrative expenses of the Plan. Administrative expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Effective in 2025, it was approved to add an automatic increase provision for those automatically enrolled of 1% per year up to 10%.

The Plan administrator has evaluated subsequent events through September 4, 2025, the date on which the financial statements were available to be issued.

NOTE 3 INFORMATION CERTIFIED OR PROVIDED BY THE PLAN TRUSTEE

The following is a summary of the Plan’s asset information as of December 31, 2024 and 2023, and for the year ended December 31, 2024, included throughout the Plan’s financial statements and ERISA-required supplemental schedule, obtained by management and agreed to or derived from information certified by Empower Trust Company, LLC and Empower Annuity Insurance Company of America, the qualified institutions of the Plan. The Plan administrator has obtained certifications from the qualified institutions that the information provided to the Plan administrator by the qualified institutions relating to the following assets and liabilities is complete and accurate. Accordingly, as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA, the Plan administrator instructed the Plan’s independent auditors not to perform any auditing procedures with respect to the information that appears throughout the financial statements and ERISA-required supplemental schedule relating to the following assets:

The Plan’s trustee also certified as to the completeness and accuracy of \$40,404,678 of net appreciation in fair value of investments, \$4,343,357 of interest and dividend income relating to the aforementioned investments and \$110,709 of interest income on notes receivable from participants for the year ended December 31, 2024.

NOTE 4 FAIR VALUE MEASUREMENTS

Accounting standards established the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and 2023.

Registered Investment Companies – Registered investment companies are valued at quoted market prices for identical assets in active markets.

Collective Trust Funds – Collective trust funds are valued based on the NAV of units (or equivalents). NAV is a readily determinable fair value and is the basis for current transactions.

Pooled Separate Accounts – The pooled separate accounts are valued at the NAV of units as determined by the insurance company. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchases and sales) may occur daily.

The methods described above may produce fair values that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The valuation method for Galliard Stable Return Fund C and SSGA S&P Midcap Index Class C Fund previously used NAV as a practical expedient. Management determined the fund has a readily determinable fair value based on no liquidity restrictions and daily valuation procedures. Accordingly, the accounting change has been retrospectively applied to the prior period presented as if the policy had always been used. The change in valuation method did not impact the amount recorded at fair value.

NOTE 5 INCOME TAX STATUS

The Plan constitutes a qualified plan under section 401(a) of the IRC and is therefore exempt from federal income taxes under provisions of section 501(a). A tax qualification letter was received from the Internal Revenue Service (IRS) dated April 18, 2015. The letter stated that the Plan and Trust, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended subsequent to this date, the Plan administrator believes the Plan and Trust is currently designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 PLAN TERMINATION

Although they have not expressed any intention to do so, each participating Employer reserves the right under the Plan to terminate the interests of its employees in the Plan at any time. An Employer shall automatically cease to be a participating Employer when the entity ceases to be under common control with the Company. In the event that the interest of a participating Employer in the Plan is terminated, each affected participant shall become 100% vested and shall be entitled to a benefit equal to the value of his or her account at the date of termination.

NOTE 7 RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of investments, as they are paid through revenue sharing, rather than a direct payment. The Plan made direct payments of \$125,145 not covered by revenue sharing to Empower Trust Company, LLC, the third-party administrator, and other service providers. The Plan Sponsor pays directly any other fees related to the Plan's operations.
