Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

The supplemental schedule of assets held at end of year as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with auditing standards generally accepted in the United States of America. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024

1. Description Of The Plan

The MCA Connect, LLC 401(k) Retirement Savings Plan (the Plan) is sponsored by MCA Connect, LLC (the Company). Effective April 14, 2023, the Company acquired substantially all of the assets of Pervicta, LLC (Pervicta). The Company amended the Plan, effective on the acquisition date, to add employees of Pervicta to Plan and recognize prior service with Pervicta as it pertains to eligibility and vesting requirements of the Plan.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The following description of the Plan provides only general information. Participants and all others should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering employees of the Company and its wholly owned subsidiaries with the exception of residents of Puerto Rico, leased employees and nonresident aliens with no income from a U.S. source. The Company adopted the Plan effective January 1, 2014. Employees of the Company become eligible to participate in the Plan immediately upon hire as long as they have attained the age of 21.

Participant Contributions

Participants can contribute up to 80% of their compensation as defined by the Plan Agreement, not to exceed the annual permissible dollar limit under the Internal Revenue Code (the IRC). Salary deferral contributions can be made as either pre-tax or Roth (after-tax) contributions. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions of \$7,500 in 2024. Employees may contribute rollover contributions from other qualified plans. Participants may change their tax-deferred contribution percentage as of any payroll period and may discontinue their election on the first day of each payroll period. Once discontinued, the participant may reelect to make contributions on the first day of any payroll period. Participants may redesignate the investment options in which their allocated shares of the total Plan are invested to be effective on any day.

Company Matching Contributions

After six months of employment, the Company makes a matching contribution to the Plan equal to 100% of the first 3% of compensation and 50% of the next 2% to 5% of compensation contributed per pay period by participants.

The Company may also make a discretionary profit-sharing contribution in addition to the basic matching contributions of the Plan. There were no discretionary profit-sharing contributions for the year ended December 31, 2024.

Participant Accounts

Participant accounts are credited with participant contributions, the Company's contributions, an allocation of Plan earnings and administrative expenses. The allocation of earnings is determined by the earnings of the participant's investment selection based on each participant's account balance and the investments selected by the participant.

Investment Options

Participants may direct their deferrals, rollovers and employer contributions into various investment options maintained by Transamerica Retirement Solutions (Transamerica).

Vesting

Participants are immediately vested in their elective deferral contributions, rollover contributions, Company discretionary profit-sharing contributions and earnings thereon. Company-matching contributions are vested as follows:

Forfeitures

Upon termination of employment, participants forfeit their nonvested balances. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or reduce plan expenses. During 2024, there was \$70,000 of forfeitures used to reduce employer contributions. There was \$25,503 and \$5,931 of unallocated forfeitures as of December 31, 2024 and 2023, respectively.

Notes Receivable From Participants

A participant may borrow from their account the lesser of \$50,000 or 50% of their vested account balance with a minimum loan amount of \$1,000. Participants may only have 2 loans outstanding at any given time. Loans are secured by the participant's vested account. The loans are to be repaid over a 5-year period unless they are for the purchase of a principal residence, which allow for up to a 30-year period. Principal and interest are collected ratably through bi-weekly payroll deductions.

Payment Of Benefits

A participant's entire vested interest in the Plan is payable in the event of termination, upon death of the participant, attaining normal retirement age of 59½ or becoming totally disabled, as defined in the Plan Agreement. A participant's benefits are payable in a lump-sum payment or periodic cash installments. In addition, hardship distributions are permitted if specified criteria are met.

Administrative Expenses

The majority of Plan expenses are paid by the Company. Plan expenses not paid by the Company are deducted from Plan assets. Administrative expenses paid by the Plan include recordkeeper fees, service fees and transaction fees.

2. Significant Accounting Policies

Basis Of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Estimates And Assumptions

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets during the reporting period. Actual results could differ from those estimates.

Investment Valuation And Income Recognition

Investments held in a defined contribution plan, other than fully benefit-responsive investment contracts, are reported at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for a discussion of fair value measurements.

The net realized and unrealized investment gain or loss (net change in fair value of investments) is reflected in the accompanying statement of changes in net assets available for benefits, and is determined as the difference between fair value at the beginning of the year (or date purchased if during the year) and selling price (if sold during the year) or year-end fair value. Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Contributions Receivable And Credit Loss Policy

The Plan is required to record an estimate of expected losses on financial assets for the remaining estimated life of the asset. This estimate must include consideration of historical experience, current conditions and reasonable and supportable forecasts. The requirement applies to the Plan's contributions receivable.

The Company has concluded that no allowance for current expected credit losses was necessary at December 31, 2024 or 2023.

Payment Of Benefits

Benefits are recorded when paid.

Subsequent Event

Management evaluates subsequent events through the date the financial statements were available for issue, which is the date of the Independent Auditors' Report.

3. Certified Financial Information

Certain information related to investments, notes receivable from participants and investment income disclosed in the accompanying financial statements and supplemental schedule, as of December 31, 2024 and 2023, and for the year ended December 31, 2024 was obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Reliance Trust Company.

4. Fair Value Measurements

The Plan utilizes an established framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value:

Registered Investment Companies

Assets are valued at the daily closing price as reported by the registered investment company. Registered investment companies held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (the NAV) and to transact at that price. The registered investment companies held by the Plan are deemed to be actively traded and are classified as Level 1 within the fair value hierarchy.

Common Collective Trust

These are valued at the unit value or the NAV of shares held by the Plan at year end. The NAV, as provided by Transamerica, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities, divided by the number of shares outstanding. The common collective trust held by the Plan is not required to be reported in the fair value hierarchy, and it files an annual report on Form 5500 as a direct filing entity.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6. Risks And Uncertainties

Investments, in general, are subject to various risks, such as significant world events, interest rates, market volatility and credit risks. Due to the level of risk associated with certain investments, it is reasonably possible that changes in the value of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statement Of Net Assets Available for Benefits.

7. Income Tax Status

The Plan uses a volume submitter defined contribution plan sponsored by Transamerica. The volume submitter has obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service (the IRS) stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability or asset if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. Party In Interest Transactions

Plan investments consist of certain registered investment companies managed by Transamerica. These transactions qualify as party in interest transactions allowable under ERISA.

The Plan incurs expenses related to general administration and recordkeeping. These expenses and certain accounting and auditing fees related to the Plan are paid by the Company, and the Company performs certain administrative functions at no cost to the Plan.

Certain participants in the Plan have outstanding loans with the Plan as of December 31, 2024 and 2023. These loans are considered party in interest transactions in accordance with Department of Labor guidelines.
