### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of AVMA Employees' 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of December 31, 2024, and for the year then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### Opinion on the 2024 Financial Statements

In our opinion, based on our audit and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

### **Basis for Opinion on the 2024 Financial Statements**

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

## **Other Matters**

#### Note 1. Description of Plan

The following description of AVMA Employees' 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan covering substantially all full-time and part-time employees who have attained the age of 18 (except for self-employed individuals, collectively-bargained employees, nonresident aliens who receive United States source income, resident of Puerto Rico or a temporary employee) of American Veterinary Medical Foundation and AVMA Association Management Services, LLC (collectively, the Association). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The AVMA Employees' Retirement Plan Administrative Committee (the Committee) is responsible for oversight of the Plan. The Committee determines the appropriateness of the Plan's investment offerings and monitors investment performance. T. Rowe Price Trust Company (T. Rowe Price) serves as trustee of the Plan.

**Eligibility:** An employee must be 18 years of age to participate in the Plan and receive employer's contributions. A temporary, or seasonal employee may participate in the Plan after reaching age 21 and completing at least 1,000 hours of service during the plan year.

**Contributions:** Each year, participants may elect to make contributions to the Plan by means of a salary deferral agreement, up to 90% of their compensation, as defined in the Plan, subject to maximum dollar limitations established by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the plan year are eligible to make catchup contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). The Plan includes an auto-enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they affirmatively elect not to have 401(k) contributions made or to make 401(k) contributions in a different amount. Automatically enrolled participants have their deferral rate set at 4% of eligible compensation. Unless elected otherwise, the employer will automatically increase employee's contributions each year by an additional 1% of compensation until a maximum of 10% is reached. The automatic increase will apply on the first day of each calendar year.

The Plan allows participants to designate certain salary deferral contributions as Roth elective contributions. Designated Roth contributions will be currently included in the gross taxable income of the participant, but distributions of designated Roth contributions and earnings thereon, will be excludable from gross taxable income for that participant.

The Plan provides for a matching contribution for a calendar year based on each participant's compensation in an amount equal to 100% of each participant's deferral contributions, subject to a maximum of 3% of each participant's compensation. Catch-up contributions are not eligible for matching contributions. Additionally, each plan year the Association is required to make a safe harbor non-elective contribution on behalf of eligible participants in an amount equal to 3% of compensation. The Plan also allows the Association to make a discretionary standard non-elective contribution. For 2024 and 2023, the discretionary standard non-elective contribution was 4% of the participant's compensation. The Association contributed \$652,884 and \$615,663 of matching contributions for 2024 and 2023, respectively, and \$668,785 and \$630,917 of safe harbor non-elective contribution for 2024 and 2023, respectively. Additionally, the Association also made \$856,969 and \$822,909 of discretionary standard non-elective contribution for 2024 and 2023, respectively. The Association may also make a discretionary qualified non-elective employer contribution to the Plan as approved by management. The Association did not make any discretionary qualified non-elective contribution during 2024 and 2023.

#### Note 1. Description of Plan (Continued)

**Participant accounts:** Each participant's account is credited with the participant's contributions and the Association's matching contributions, as well as allocations of safe harbor non-elective contributions, discretionary standard non-elective contributions and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting:** Participants are immediately vested in all contributions plus actual earnings thereon, except for the discretionary standard non-elective contributions, which are vested based on years of service. Participants become 20% vested after completing two years of service with another 20% for each additional year of service. Participants will also become 100% vested if any of the following conditions apply: attaining normal retirement age, plan termination, death or disability.

**Notes receivable from participants:** Participants may borrow from their fund account a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Notes receivable terms range from one to five years or longer if used to purchase a principal residence. The notes receivable are collateralized by the balance in the participant's account and bear interest at prime rate at the time of loan origination, plus 1%. Principal and interest payments are paid ratably through payroll deductions.

**Investment options:** Upon enrollment in the Plan, a participant may direct all contributions into a variety of investments as more fully described in the Plan's literature. Participants may change their investment options daily.

**Payment of benefits:** On termination of service due to death, disability, retirement or any other reason, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account or installment payments. Participants may request hardship distributions, as defined. Participants can request in-service distributions upon reaching the Plan's normal retirement age.

If the participant's vested account balance exceeds \$5,000, no distribution will be made from the Plan without the participant's consent. If a participant's vested account balance upon termination of service, death, disability or retirement is less than \$5,000, their account will be cashed out by distributing their vested interest in their account in a single-sum payment or by direct rollover to an Individual Retirement Account or other eligible retirement plan.

**Forfeited accounts:** At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$68,393 and \$11,978, respectively. These accounts will first be used to reduce future Association contributions. Any remaining amounts will be used to pay administrative expenses, and if they cannot be used to pay administrative expenses, will be allocated among participants. During 2024 and 2023, forfeitures amounting to \$12,032 and \$27,802, respectively, were used to reduce employer contributions or to pay administrative expenses.

#### Note 2. Summary of Significant Accounting Policies

**Basis of accounting:** The financial statements of the Plan are prepared on the accrual basis of accounting.

#### Note 2. Summary of Significant Accounting Policies (Continued)

**Use of estimates:** The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP) requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

**Investment valuation and income recognition:** Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Contributions:** Contributions from Plan participants and the related matching contributions from the Association are recorded in the year in which participant contributions are withheld from compensation. Non-elective contributions are recorded in the year in which employee compensation is paid.

**Notes receivable from participants:** Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the ERISA-required supplemental schedule H, line 4i—schedule of assets (held at end of year).

**Payment of benefits:** Benefits are recorded when paid.

**Expenses:** Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Association. Expenses that are paid by the Association are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

Plan participants pay the recordkeeping/administrative fees through fund revenue sharing. The Plan has a Revenue Credit Program with T. Rowe Price whereby any excess revenue generated by the underlying funds is credited back to the Plan. Therefore, if the excess revenue is greater than the recordkeeping/administrative fees for the Plan year, the Plan will receive a credit and, therefore, pay no fees to the trustee for the Plan year. For 2024 and 2023, the Plan earned \$12,162 and \$13,036, respectively, under this agreement. As of December 31, 2024 and 2023, the balance in the fee credit account, which holds these revenue-sharing payments, amounted to \$4 and \$7, respectively. These funds are available to allocate to participants. During 2024 and 2023, \$12,185 and \$13,052, respectively, of these excess revenue credits were allocated to participants.

**Subsequent events:** The Plan has evaluated subsequent events through July 30, 2025, the date the financial statements were available to be issued.

#### Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

#### Note 4. Fair Value Measurements (Continued)

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

**Shares of registered investment companies and money market fund:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Units of collective investment fund:** Valued based on the NAV of units of the collective investment fund. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based upon the fair value of the underlying investments comprising the trust less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

#### **Note 4. Fair Value Measurements (Continued)**

**Changes in fair value levels:** To assess the appropriate classification of investments within the fair value hierarchy, the availability of market data is monitored. Changes in economic conditions or valuation techniques may require the transfer of investments from one fair value level to another.

Plan management evaluated the significance of transfers between levels based upon the nature of the investment and size of the transfer relative to total net assets available for benefits. For the year ended December 31, 2024, there were no transfers in or out of Level 3.

#### **Note 5. Related-Party and Parties-in-Interest Transactions**

T. Rowe Price is the trustee and recordkeeper of the Plan; therefore, transactions with this company qualify as party-in-interest transactions. The Plan paid \$37,188 and \$31,719 to T. Rowe Price in 2024 and 2023, respectively.

Certain employees of the Association are performing services to the Plan and are not compensated by the Plan. Certain other expenses of the Plan are by the Association.

#### **Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Association has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

#### **Note 7. Tax Status**

The Plan has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated August 19, 2020, stating that the form of the pre-approved plan document was in compliance with applicable requirements of the IRC. The Plan has been amended since adopting the pre-approved plan document; however, the Plan Administrator believes that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
