We have performed an audit of the financial statements of Community Care 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's 2024 financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Notes to Financial Statements

December 31, 2024 and 2023

1. Description of Plan

The following description of Community Care 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions, including vesting and benefit options.

The Plan is a tax-exempt defined contribution plan covering all employees of Community Care (the Company). The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the prototype plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (the Code). The Plan has been amended since receiving the prototype letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Employees are eligible to make salary deferrals to the Plan upon date of hire and reaching age 21. Employees are eligible to receive an employer match after completing one year of service (at least 1,000 hours) and reaching age 21.

Contributions

Participants may contribute the maximum permissible under Section 401(g) of the Code not to exceed the limits of Code Sections 401(k), 404, and 415. The Plan permits Roth Elective Deferrals. The Company contributes a match of 100% of the deferred compensation of each participant up to 3% of salary reductions and a match of 25% of the deferred compensation of each participant on the next 2% of salary reductions. The Company may elect to make a discretionary profit sharing contribution in any plan year. There were no discretionary profit sharing contributions made in 2024. Participants direct the investment of their contributions into various investment options offered by the Plan. Contributions are subject to certain limitations. Participants are always 100% vested in salary deferrals, rollover contributions, and employer match contributions. Participants' vesting in discretionary profit sharing contributions is subject to a four-year vesting schedule based on years of service.

2. Summary of Significant Accounting Policies

Use of Estimates

The preparation of financial statements in conformity with U.S. generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities, at the date of the financial statements. Accordingly, actual results could differ from those estimates.

Investments

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

Sub-accounts through pooled separate accounts are valued at net asset value (NAV) of the underlying assets in each separate account. The NAV is multiplied by the number of shares owned. The number of shares owned in the underlying investments reflect all contributions and disbursements traded through the end of the prior day to reach the value per share.

Contributions to the John Hancock Stable Value Fund, a collective investment trust, are invested solely in shares of the John Hancock Stable Value Trust (the Trust), a trust managed by John Hancock Life Insurance Company. The fair value is based on the NAV of the underlying assets in the collective investment trust. The net asset value per unit for each unit class of the Trust is calculated daily by dividing the net assets applicable to each unit class by the respective number of units outstanding for that class. Deposits to and withdrawals from the Trust may be made daily at the current net asset value per unit. The John Hancock Stable Value Fund seeks to provide stability of principal while earning current income that exceeds money market rates over the long term. A delay of up to 12 months may be experienced for plan level withdrawals.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance, plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the plan document.

Administrative Expenses

Substantially all administrative expenses are paid by the Company.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Subsequent Events

Management has considered transactions or events occurring through August 8, 2025, the date that the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

3. Information Certified by Custodian

4. Related Party Transactions

Certain Plan investments are sub-accounts through pooled separate accounts and a collective investment trust managed by John Hancock Life Insurance Company. John Hancock Life Insurance Company is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their employer contributions.

6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

7. Fair Value Measurement

Financial Accounting Standards Board Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

Quoted prices for similar assets or liabilities in active markets;
Quoted prices for identical or similar assets or liabilities in inactive markets;
Inputs other than quoted prices that are observable for the asset or liability;
Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value at December 31, 2024 and 2023:

Sub-accounts through pooled separate accounts: Valued at fair value using the market approach based on the NAV of the underlying investments.

Collective investment trust: Valued at fair value using the market approach based on the underlying NAV of units held by the Plan. NAV is used as a practical expedient to measure fair value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
