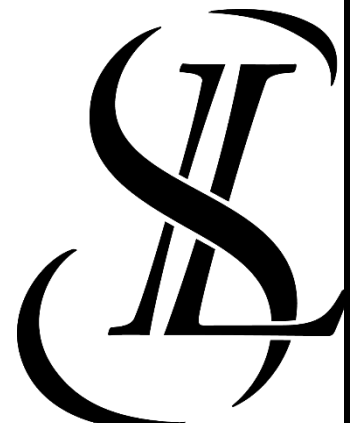

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the Ace/Avant 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements ("financial statements").

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. ### 1. Description of Plan

The following description of the Ace/Avant 401(k) Retirement Plan (the "Plan") provides only general information. Participants should refer to the summary plan description for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all full-time employees of Ace/Avant Concrete Construction Co., Inc. and its affiliates Ace Technology Holdings, LLC and Crew Console, LLC (collectively, the "Company" or "Employer"), who have completed one year of service with over 1,000 hours of service and are age 18 or older. Employees may begin participation as of the first day of the month coinciding with or subsequent to meeting the eligibility requirements. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

#### **Contributions**

Eligible employees are automatically enrolled at a 2% pre-tax deferral percentage, which will increase by increments of 1% annually up to a maximum of 6%, unless they elect an alternative percentage or decline participation. Participants may elect to contribute up to 90% of their pre-tax or after-tax ("Roth") annual compensation as defined by the Plan, not to exceed limits set by the Internal Revenue Service ("IRS"). Participants who have attained age 50 are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans ("rollovers"). During 2024 and 2023, the Company made safe harbor matching contributions equal to 100% of the first 3%, plus 50% of the next 3% of compensation each participant contributes to the Plan. The Company may also make a discretionary non-elective contribution to be determined annually. However, no discretionary non-elective contributions were made for 2024 or 2023.

Upon enrollment in the Plan, a participant may direct contributions in any of the investment options offered through the Plan. Participants may modify their investment options and deferral percentages at any point in time.

#### **Participant Accounts**

Each participant's account is credited with the participant's and the Company's contributions and an allocation of the Plan's net earnings and administrative expenses. Allocations are based upon participant contributions, earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are immediately vested in their contributions and the Company's safe harbor matching contributions plus actual earnings thereon. Company discretionary non-elective contributions vest at 25% per year starting after two years of service.

#### **Payment of Benefits**

Upon termination of service due to death, disability, retirement, or separation, a participant may elect to receive the value of the vested interest in his or her account in a lump-sum, partial, or installment payments. In-service distributions may be made to participants who have reached age 59½. Withdrawals may also be made upon circumstances of financial hardship, as specified by the Plan.

### 1. Description of Plan (Concluded)

#### ***Forfeited Accounts***

Forfeitures from non-vested participant accounts may be used to offset administrative expenses or future Company contributions. No forfeitures were utilized during 2024 and 2023. Forfeited non-vested accounts of approximately \$6,900 and \$5,500 were available as of December 31, 2024 and 2023.

#### ***Administrative Expenses***

The Company absorbs certain expenses incidental to the administration of the Plan, including internal administrative costs. Certain plan expenses, such as recordkeeping expenses, are permitted to be paid from the Plan's assets. Distribution fees are paid from the affected participant's account.

### 2. Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The accompanying financial statements have been prepared under the accrual basis of accounting.

#### ***Use of Estimates***

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

#### ***Investment Valuation and Income Recognition***

Investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

#### ***Payment of Benefits***

Benefits are recorded when paid.

#### ***Subsequent Events***

Management has evaluated events occurring subsequent to the date of the financial statements through August 29, 2025, the date the financial statements were available to be issued and has determined that no events have occurred that require adjustments to or additional disclosure in the financial statements.

### 3. Certified Investment Information

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan.

### 4. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 5. Income Tax Status

The Plan has adopted a prototype plan document sponsored by FMR LLC. The IRS has determined and informed FMR LLC on June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code ("IRC"). The Plan has been amended since the date of the determination letter; however, the plan administrator believes that the Plan is currently designed and being operated in compliance with applicable provisions of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

### 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

### 7. Party-in-Interest Transactions

Certain plan investments are shares of mutual funds managed by Fidelity, the trustee of the Plan. As such, these transactions qualify as party-in-interest. Fees paid to Fidelity by the Plan for administrative services were \$17,362 and \$13,421 in 2024 and 2023.

### 8. Self-Directed Brokerage Accounts ("SDB")

The Plan allows participants to transfer money into an SDB. This account is held by the trustee and is participant-directed. The investments shown on the statements of net assets available for benefits include the following SDB investments.

### 9. Fair Value Measurements

The Plan has adopted Accounting Standards Codification 820, "Fair Value Measurements and Disclosures" ("ASC 820"), which establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The three levels of the fair value hierarchy under ASC 820 are as follows:

#### Basis of Fair Value Measurement

- Level 1: Unadjusted quoted prices in active markets that are accessible at the measurement date for identical, unrestricted assets or liabilities;
- Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly;
- Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual and money market funds:* Valued at the net asset value ("NAV") of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market and is classified within Level 1 of the valuation hierarchy.

*Common collective trusts:* Valued at NAV as determined by the issuer based on the fair market value of the underlying investments, minus liabilities, which are valued primarily through the use of directly and indirectly observable inputs. As the value of these investments is readily determinable, these funds are classified within Level 2 of the valuation hierarchy.

*Self-directed brokerage accounts:* These are comprised primarily of mutual funds, money market funds and common stocks. Mutual funds and money market funds are valued at quoted market prices which represent the NAV of shares held by the Plan at year-end. The NAV for these investments is a quoted price in an active market. Common stocks are valued at the closing price reported on the active market on which the securities are traded. These investments are classified as Level 1 of the valuation hierarchy.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
