Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of the Perinatal Associates of New Mexico, LTD 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of an ERISA Section 103(a)(3)(C).

Basis for Opinion

Notes to Financial Statements December 31, 2024 and 2023

1) Description of Plan

The following description of the Perinatal Associates of New Mexico LTD, 401(k) Profit Sharing Plan and Trust (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all full-time employees of Perinatal Associates of New Mexico Ltd. (the “Company”), who have one year of service and are age twenty-one or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is a volume submitter profit sharing plan with CODA designed by Sentinel Benefits Group Inc. The Plan administrator is the Company and operates under the authority of the Company.

Contributions

Participants may contribute up to the maximum percentage of allowable compensation, as defined by the Plan, not to exceed annual limits set by the Internal Revenue Code. For 2024 and 2023, the annual limit was \$23,000 and \$22,500, respectively. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investments of their contributions into various investment options offered by the Plan. Currently, the Plan offers more than thirty investment options for participants. Participants may also contribute amounts representing rollovers from other qualified plans. Discretionary employer matching contributions may also be made to the Plan and the employer also has the option of making safe harbor non-elective contributions, as defined by the Plan.

To receive a non-safe harbor matching contribution, safe harbor matching contribution and profit-sharing contribution the participant must meet eligibility requirements. The Plan elected to make a basic non-elective 3% safe harbor 401(k) contribution for each of the 2024 and 2023 Plan years.

1) Description of Plan — continued

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested account balance, whichever is less. The loans are secured by the balance in the participants' account and bear interest ranging from 4.25% to 9.5%, which are commensurate with prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably at least quarterly. Participants are not allowed to have more than two loans outstanding at any one time.

Participant Accounts

Each participant's account is credited with the participant's deferrals, the Company's matching contribution, plan earnings and an allocation of the Company's nonelective contribution, if any. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Forfeited Accounts

Each Plan year, forfeitures are used to reduce any matching or nonelective contributions or to pay non-settlor expenses of the Plan. There were no significant forfeited accounts at December 31, 2024 and 2023.

Vesting

Vesting in the Plan's discretionary matching contribution portion of a participant's account plus earnings thereon is based on years of service, as defined by the Plan. A participant is 100% vested after three years of credited service according to the following schedule:

Upon termination of service due to death, disability or retirement, vested benefits are distributed in accordance with specific requirements outlined in the Plan agreement.

2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Administrative Expenses

Administrative expenses include administration and investment management expenses. The Plan permits, but does not require, the Company to pay costs of Plan administration.

Payment of Benefits

Benefit payments are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan's administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Valuation of Investments

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA, the Plan values its investments at fair value. If available, quoted market prices are used to value investments. In accordance with valuing investments at fair value, the net unrealized appreciation or depreciation is presented in the statements of changes in net assets available for benefits.

Date of Management's Review

Subsequent events were evaluated through August 18, 2025 which is the date the financial statements were available to be issued.

5) Plan Termination

Although it has not expressed intent to do so, the Company, as the Plan's sponsor, has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

6) Tax Status

The Plan is operating as a tax-exempt plan under a prototype document with a nonstandardized adoption agreement. The Internal Revenue Service has determined and informed the prototype plan sponsor by letter dated November 30, 2020, that the prototype plan, as then designed, was in compliance with the applicable sections of the Internal Revenue Code. The Plan is relying on the opinion letter of the prototype sponsor. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the accompanying financial statements. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

Accounting principles generally accepted in the United States of America require the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more than likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress.

7) Fair Value Measurement

The Plan's investments are reported at fair value in the accompanying statements of net assets available for benefits. The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

7) Fair Value Measurement – continued

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 3 inputs are only used when Level 1 or Level 2 inputs were not available.

Level 1 Fair Value Measurements - The fair value of pooled separate accounts and the brokerage accounts are measured using quoted prices in an active market.

8) Brokerage Accounts

A portion of the Plan's assets were held by Merrill Lynch, which were not subject to the custodian's certifications as presented in Note 4. At December 31, 2024 and 2023, assets held by Merrill Lynch totaled \$7,599,836 and \$6,600,280, respectively.

The amount of investment income certified by the custodian did not include net investment gains in fair value and interest and dividends for the years ended December 31, 2024 and 2023 of \$761,571 and \$804,762, respectively.

9) Related Party Transactions

Certain Plan investments are managed by John Hancock. John Hancock is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions.

10) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
