### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of H.A.P. ## NOTES TO FINANCIAL STATEMENTS

---

### 1. DESCRIPTION OF THE PLAN

The following brief description of H.A.P. Enterprises, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

#### GENERAL

The Plan is a defined contribution plan covering substantially all employees of H.A.P. Enterprises, Inc. (the “Company”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

#### CONTRIBUTIONS

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan subject to limitations of the Internal Revenue Service. The Plan provides for a safe harbor matching contribution of 100% on the first 5% of compensation that a participant contributes to the Plan. There are no age or service requirements for a participant to make a salary deferral and receive a safe harbor match. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans.

The Company may also make annual discretionary profit sharing contributions to the Plan as approved by the Board of Directors. To be eligible to receive profit sharing contributions, a participant must have attained age 21, completed one (1) year of service, completed one (1) hour of service during the Plan year, and be employed the last day of the Plan year. There was no profit sharing contribution made during the years ended December 31, 2024 and 2023.

Participants direct the investment of all contributions into various investment options offered by the Plan.

#### PARTICIPANT ACCOUNTS

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, and (b) Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a person is entitled is the benefit that can be provided from the participant’s vested account.

#### VESTING

Participants are immediately vested in their contributions, the safe harbor match, and actual earnings thereon. Vesting in the Company’s discretionary profit sharing contribution portion of their accounts plus actual earnings thereon is based on years of credited service. A participant is 100% vested after five years of credited service.

### **NOTES RECEIVABLE FROM PARTICIPANTS**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 9.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest is paid ratably through bi-weekly payroll deductions. Terms range from three (3) months to five (5) years depending on the purpose of the note receivable. Notes receivable from participants are stated at their unpaid principal balance plus accrued interest.

### **PAYMENT OF BENEFITS**

Upon termination of service, death, disability, or retirement, a participant may elect to receive the vested interest in their account either in the form of a lump-sum payment, a ten-year annuity, or a life annuity.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

### **BASIS OF ACCOUNTING**

The accompanying financial statements of the Plan are presented under the accrual method of accounting.

### **USE OF ESTIMATES**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

### **INVESTMENT VALUATION AND INCOME RECOGNITION**

Investments are reported at fair value. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **PAYMENT OF BENEFITS**

Benefits are recorded when paid.

### **FORFEITED ACCOUNTS**

When certain terminations of participation in the Plan occur, the non-vested portion of the participant's account represents a forfeiture. Forfeitures may be used to offset Plan expenses, reduce future employer contributions, or allocated to participant accounts. Forfeited non-vested accounts totaled \$8,446 and \$6,146 as of December 31, 2024 and 2023, respectively. Forfeitures of \$16,231 were utilized to reduce Plan expenses for the year ended December 31, 2024.

### **SUBSEQUENT EVENTS**

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosure through August 22, 2025, the date the financial statements were available to be issued.

## **3. FAIR VALUE MEASUREMENTS**

The Plan measures its investments at fair value on a recurring basis in accordance with accounting principles generally accepted in the United States of America. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The framework that authoritative guidance establishes for measuring fair value includes a hierarchy used to classify inputs used in measuring fair value. The hierarchy prioritizes the inputs used in determining valuations into three levels. The level in the fair value hierarchy within which the fair value measurement falls is determined based on the lowest level input that is significant to the fair value measurement.

The levels of the fair value hierarchy are as follows:

Level 1 – Fair value is based on unadjusted quoted prices in active markets that are accessible to the Plan for identical assets. These generally provide the most reliable evidence and are used to measure fair value whenever available.

Level 2 – Fair value is based on significant inputs, other than Level 1 inputs, that are observable either directly or indirectly for substantially the full term of the asset through corroboration with observable market data. Level 2 inputs include quoted market prices in active markets for similar assets, quoted market prices in markets that are not active for identical or similar assets, and other observable inputs.

Level 3 – Fair value is based on significant unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

- Registered investment companies (mutual funds) are valued at the quoted net asset value of shares held by the Plan at year end.

The preceding methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 4. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan's assets are administered under a contract with Capital Bank and Trust Company (the "Trustee"), a party-in-interest as defined by ERISA. Contributions are held and managed by the Trustee, who invests cash received. The Trustee invests investment income and makes distributions.

Participants may borrow from their accounts and therefore these transactions also qualify as party-in-interest transactions.

Except for loan origination fees associated with notes receivable from participants, withdrawal fees associated with benefit payments, and investment advisory fees, all reasonable expenses of maintaining the Plan are paid by the Company.

Certain administrative functions are performed by officers and employees of the Company. No such officer or employee receives compensation from the Plan.

## **5. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become one hundred percent vested in their accounts.

## **6. TAX STATUS**

The Company adopted a prototype non-standardized defined contribution plan which the Internal Revenue Service has determined and informed the prototype plan author by a letter dated September 18, 2001, that the prototype plan was designed in accordance with section 401 of the Internal Revenue Code ("IRC") for use by employers for the benefit of their employees. Although the Plan has been amended since receiving this determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related custodial accounts are tax exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate Plan tax positions and recognize a tax liability (or asset) if the Plan has entered into an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Company analyzed the tax positions taken by the Plan, and possible recognition of a liability (or asset) or disclosure in the financial statements. Additionally, the Plan has not incurred any penalties by any taxing jurisdictions for any reason. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in projects for any tax periods.

## **7. INFORMATION CERTIFIED BY TRUSTEE**

The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2502.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, the Trustee has certified to the completeness and accuracy of all investments reported in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023 and the supplemental Schedule H, Line 4(i) – Schedule Of Assets (Held At End Of Year) as of December 31, 2024, and the related investment activity reported in the statement of changes in net assets available for benefits for the year then ended.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedules.

## 8. RISKS AND UNCERTAINTIES

The Plan provides for various investment options in various combinations of investment funds. Investment funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

## 9. DELINQUENT PARTICIPANT CONTRIBUTIONS

For the years ended December 31, 2018 through December 31, 2023, the Company did not properly calculate contributions based on eligible compensation and remit them to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Delinquent Participant Contributions Disclosure under ERISA. Untimely remittances are identified on the schedule of delinquent participant contributions.

The Plan Sponsor took corrective action upon discovery of this issue. During 2024, lost earnings from the delinquent contributions were calculated and the account of each affected participant was credited.

New policies have since been implemented to ensure correct and proper calculation and timely deposits for future participant contributions.
