Except as discussed in the following paragraph, in planning and performing our audit of the financial statements of Advanced Programs, Inc. 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as of and for the year ended December 31, 2024, in accordance with auditing standards generally accepted in the United States of America, we considered Advanced Programs, Inc. 401(k) Plan’s system of internal control over financial reporting (internal control) as a basis for designing audit procedures that are appropriate in the circumstances for the purpose of issuing our report on the financial statements, but not for the purpose of expressing an opinion on the effectiveness of the Plan’s internal control. Accordingly, we do not express an opinion on the effectiveness of the Plan’s internal control.

We were engaged to perform an ERISA Section 103(a)(3)(C) audit of those financial statements as permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. As permitted by ERISA Section 103(a)(3)(C), our audit did not extend to any statements or information related to assets held for investment of the Plan (investment information) by Fidelity Management Trust Company, LLC that prepared and certified the statements or information regarding assets so held in accordance with 29 CFR 2520.103-5. Our audit also did not include a consideration of internal control relating to the investment information.

Our consideration of internal control was for the limited purpose described in the preceding paragraphs and was not designed to identify all deficiencies in internal control that might be material weaknesses or significant deficiencies and therefore, material weaknesses or significant deficiencies may exist that have not been identified. However, as discussed below, we identified certain deficiencies in internal control that we consider to be a material weakness.

A deficiency in internal control exists when the design or operation of a control does not allow management or employees, in the normal course of performing their assigned functions, to prevent, or detect and correct, misstatements on a timely basis. A material weakness is a deficiency, or a combination of deficiencies in internal control, such that there is a reasonable possibility that a material misstatement of the Plan’s financial statements will not be prevented, or detected and corrected, on a timely basis.

We consider the following deficiency in Advanced Programs, Inc. 401(k) Plan's internal control to be a material weakness:

**Preparation of Financial Statements**

An integral component of a sound internal control environment is the ability to prepare annual financial statements, including required disclosures, in accordance with accounting principles generally accepted in the United States of America. The client personnel do not appear to have the necessary competencies to prepare employee benefit plan financial statements in accordance with generally accepted accounting principles. The Plan sponsor relies on assistance from the independent auditors to prepare the annual financial statements and to complete and update the notes to the financial statements.

**Management's Response**

Based on the size of the company, the Plan Sponsor does not feel it is necessary to have personnel on staff that can prepare employee benefit plan financial statements and related disclosures in accordance with accounting principles generally accepted in the United States of America.

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and ERISA-required supplemental schedules, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP. #### *Qualitative Aspects of Accounting Practices*

The significant accounting policies used by Advanced Programs, Inc. 401(k) Plan are described in Note 2 to the financial statements. No new accounting policies were adopted, and the application of existing policies was not changed during 2024. We noted no transactions entered into by the Plan during the year for which there is a lack of authoritative guidance or consensus. All significant transactions have been recognized in the financial statements in the proper period.

Accounting estimates are an integral part of the financial statements prepared by management and are based on management's knowledge and experience about past and current events and assumptions about future events. Certain accounting estimates are particularly sensitive because of their significance to the financial statements and because of the possibility that future events affecting them may differ significantly from those expected. There were no significant estimates affecting the financial statements.

Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

The disclosure of Certified Information in Note 3 to the financial statements regarding investments certified to be complete and accurate by the custodian of Plan assets.

The financial statement disclosures are neutral, consistent, and clear.

#### *Form 5500 Procedures*

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

#### *Difficulties Encountered in Performing the Audit*

We encountered no significant difficulties in dealing with management in performing and completing our audit.

#### *Corrected and Uncorrected Misstatements*

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management. No significant corrections were made, and no uncorrected items were noted.

#### *Disagreements with Management*

For purposes of this letter, a disagreement with management is a disagreement on a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

#### *Management Representations*

We have requested certain representations from management that are included in the management representation letter dated August 4, 2025.

*Management Consultations with Other Independent Accountants*

In some cases, management may decide to consult with other accountants about auditing and accounting matters, similar to obtaining a “second opinion” on certain situations. If a consultation involves application of an accounting principle to the Plan’s financial statements or a determination of the type of auditor’s opinion that may be expressed on those statements, our professional standards require the consulting accountant to check with us to determine that the consultant has all the relevant facts. To our knowledge, there were no such consultations with other accountants.

*Other Audit Findings or Issues*

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan’s auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

*Other Matters*

Our responsibility for the ERISA-required supplemental schedules accompanying the financial statements is to perform adequate procedures to evaluate whether the form and content of the ERISA-required supplemental schedules, other than that agreed to or derived from the certified investment information, is presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA, and whether the information in the supplemental schedules related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

#### **1. Description of Plan**

The following is a description of the Advanced Programs, Inc. (the “Company”) 401(k) Retirement Benefit Plan (the “Plan”) that provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

##### **General**

The Advanced Programs, Inc. 401(k) Retirement Benefit Plan is a defined contribution salary deferral pension plan which provides an individual account for each participant and provides benefits upon retirement that are based on amounts contributed by the employer and employee plus earnings on those contributions less any Plan administrative expenses. The Plan was established on December 1, 2002.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

##### **Participation**

All employees of Advanced Programs, Inc. are eligible to participate in the Plan, except union and non-resident alien employees. A participant becomes eligible once they have completed three months of service and are age 21 or older.

##### **Contributions**

Eligible participants may defer up to a maximum of 90% of their eligible compensation, not to exceed the limits of Internal Revenue Code (“IRC”) Sections 401(k), 402(g), 404 and 415 of \$23,000 and \$22,500 for 2024 and 2023, respectively. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. The Plan contains a provision for an employer matching contribution. The employer match is 100% of the first 3% of eligible compensation and 50% of the next 3% of eligible compensation that a participant contributes to the Plan. The Plan Sponsor may make discretionary nonelective contributions in an amount determined by the Board of Directors for each Plan year. Discretionary nonelective contributions, if any, made to the Plan will be allocated to participant accounts in the ratio that their total compensation bears to the total eligible compensation paid to all eligible participants. These discretionary nonelective contributions are fully vested immediately.

All employees over the age of 50 before the close of the Plan year are eligible to make catch-up contributions of \$7,500 per employee, per year under IRC Sections 401 (a)(30), 402(g) and 414(v) for 2024 and 2023.

Participant and Company contributions are directed by the participant into various investment options offered by the Plan.

#### **1. Description of Plan (continued)**

##### **Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Plan Sponsor's matching and additional contributions and Plan earnings less an allocation of any administrative expenses. The additional contribution is allocated based on the participant's eligible compensation as compared to total eligible compensation. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. The participant may redirect their investments at any time to any of the available funds in the Plan.

##### **Vesting**

Participants are immediately vested in their voluntary contributions, matching contributions, discretionary nonelective contributions, and roll over accounts, plus actual earnings thereon.

##### **Notes Receivable from Participants**

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance, whichever is less. Note terms range from one to five years; however, this limit can be extended if the note is used by the participant for the purchase of a primary residence. The notes are secured by the balance in the participants' accounts and bear a reasonable rate of interest as negotiated between the Plan administrator and the participant. The interest rates on current outstanding notes range from 5.25% to 10.5%. The Plan may charge a fee for the administrative expenses of processing the new note. Principal and interest is paid ratably through payroll deductions. A participant is not able to borrow from their account balance if they have an existing outstanding note balance.

##### **Payment of Benefits**

Upon termination of service, death, disability, retirement at age 59½, a lump sum of the participants' vested account balance may be distributed to the participant or beneficiary. Involuntary distributions can be made by the Plan if the vested balance was less than \$5,000 through December 31, 2023 and \$7,000 effective January 1, 2024.

A terminated or retired participant may elect to receive payment from their account soon after it is valued or postpone payment until a later date. If payment is postponed, the account will continue to share in investment earnings. However, payment must start on April 1 of the year following the year the participant reaches 72 years of age, unless they are still working.

#### **1. Description of Plan (continued)**

##### **Payment of Benefits** (continued)

Upon the death of a participant before retirement or termination of employment, the current balance of such participant's individual account shall become payable as of the valuation date coincident with or next following his or her death.

In-service withdrawals and hardship withdrawals are permitted if certain criteria are met.

##### **Forfeited Accounts**

The Plan allows for forfeitures to be used to reduce the contributions of the employer. To the extent that forfeitures are not used for this purpose they may be used to pay Plan expenses. Forfeited nonvested accounts totaled \$704 and \$623 at December 31, 2024 and 2023, respectively. No amounts were applied to expenses during 2024 or 2023.

#### **2. Significant Accounting Policies**

##### **Basis of Accounting**

The financial statements of the Plan are prepared under the accrual method of accounting.

##### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

##### **Notes Receivable from Participants**

The Plan follows the accounting guidance for "participant notes in defined contribution plans" in accordance with generally accepted accounting principles. Under that guidance, participant notes are to be measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based on the terms of the Plan document. Participant notes are reported in the Statements of Net Assets Available for Benefits as "Notes receivable from participants" rather than included as investments as reported under prior guidance.

**Investment Valuation and Income Recognition**

See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Realized gains and losses from security transactions and unrealized appreciation and depreciation of investments are determined using an average cost basis.

The Plan invests in mutual funds and money market funds. Such investments are exposed to various risks such as market and credit risks. Due to the level of risk associated with such investments, and the level of uncertainty related to changes in the value of such investments, it is at least reasonably possible that changes in risk in the near term could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits. Plan assets are not FDIC insured.

**Plan Expenses**

The Company sponsors the Plan. Personnel within the employer organization perform certain administrative services for the Plan, including maintenance of participant records. The payroll and related overhead costs associated with these services are not included in Plan expenses. The Plan pays for certain administrative and trustee fees. Investment related expenses are included in net appreciation or depreciation in fair value of investments. Effective May 1, 2023, Fidelity shall pay quarterly, in arrears, an annual revenue credit of \$42,000 deposited to a Revenue Credit Account. The funds in the Revenue Credit Account will be used to pay Plan expenses.

**Funding Policy**

Employee deferrals and loan repayments are funded as soon as practical after withheld from payroll. Employer matching is funded with regular payroll payments.

**Payment of Benefits**

Benefit payments are recorded when paid.

**3. Certified Information**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, realized gain on investments, interest and dividends, and interest income receivable from participant loans for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, LLC (the trustee of the Plan).

#### **4. Fair Value Measurements**

In accordance with generally accepted accounting principles, the Plan has adopted the provisions, which establish a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of the observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Money market funds: Valued at the closing price reported in the active market.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Party-in-Interest Transactions**

Certain Plan investments at December 31, 2024 and 2023 are shares of mutual funds held by Fidelity Management Trust Company, LLC. The Fidelity Management Trust Company, LLC was the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees for asset management services are paid by the Plan and/or the Plan Sponsor. Effective May 1, 2023, Fidelity will make quarterly Revenue Credit deposits into a Revenue Credit Account. The balance in the Revenue Credit Account as of December 31, 2024 and 2023 is \$65,292 and \$21,239, respectively. The Company may direct Fidelity to use these funds to reimbursement of fees and expenses associated with services provided to the Plan or to allocate funds to eligible participant accounts on a pro rata basis.

**6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

**7. Tax Status**

Effective November 22, 2020, the Plan adopted a non-standardized form of a prototype plan sponsored by Fidelity Management Trust Company, LLC. The prototype plan received an opinion letter from the Internal Revenue Service dated June 30, 2020, that states that the prototype plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code.

#### 7. Tax Status (continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities.

The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.
