## INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator and Participants of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

### NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

---

#### 1. DESCRIPTION OF PLAN

The following brief description of Avalon Copy Centers of America, Inc. 401k Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all nonunion employees of Avalon Document Services Holdings and Subsidiaries (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

##### **Administration**

The Plan is administered by the Company. Voya Financial, Inc. (the "Custodian") serves as the custodian of the Plan. Valiant Retire, Inc. (the "TPA") serves as the third-party administrator of the Plan. Administrative expenses are generally paid by the Plan. Two employees of the Company serve as the Plan's trustees.

##### **Eligibility**

Employees of the Company are eligible to contribute to the Plan and receive employer matching contributions upon completing 1 month of service and meeting the minimum age requirement of 18 years of age. Any union or nonresident alien employee is not eligible to participate in the Plan.

The Plan has also adopted and implemented an automatic enrollment provision. Participants who meet the eligibility requirements above will be automatically enrolled in a designated target date fund at a 4.00% deferral rate on a pre-tax basis until changed by the participant. There is no automatic escalation provision for participants who are automatically enrolled.

##### **Contributions**

Participants may make pre-tax or post-tax ("Roth") contributions up to the maximum percentage of compensation and dollar amount permissible under the Internal Revenue Code ("IRC"). Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions.

At the discretion of the Company's board of directors, the Company may make matching or profit-sharing contributions. During both of the years ended December 31, 2024 and 2023, participants received matching contributions of 100% of the first 3% of compensation, as well as an additional 50% match of the next 2%, totaling a maximum employer contribution of 4%.

There were no discretionary profit-sharing contributions made for the Plan during the years ended December 31, 2024 and 2023.

The Plan accepts direct rollovers as a result of eligible rollover distributions.

## 1. DESCRIPTION OF PLAN (Continued)

### Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of: (a) the Company's contribution, (b) investment earnings and losses, and c) administrative expenses paid by the Plan which have not been offset by forfeitures. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### Forfeitures

Forfeitures may be used to reduce administrative expenses or employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts amounted to \$9,166 and \$400, respectively. Forfeiture amounts of \$19,385 and \$32,511 were generated for the years ended December 31, 2024 and 2023, respectively. Forfeiture amounts of \$10,619 and \$56,718 were used to reduce employer contributions in 2024 and 2023, respectively.

### Vesting

Participants are immediately vested in their elective deferrals plus actual earnings. The Plan provides a vesting schedule based on participants' years of service to the Company for discretionary matching and profit-sharing contributions noted below:

Year 1	0%
Year 2	20%
Year 3	40%
Year 4	60%
Year 5	80%
6 or more	100%

### Investment Options

Upon enrollment in the Plan, a participant may direct their elective deferrals and employer contributions in any of the investment options offered by the custodian of the Plan, which provide diversified investment options. Participants may change their investment options at any time during the year.

### Notes Receivable from Participants

Participants may borrow a minimum of \$1,000 and up to the lesser of 50% of their vested account balances or \$50,000. Participants may choose an amortization schedule of up to five years, unless the note is used for a primary residence, in which case loans may be repaid over a term comparable to a mortgage from a local institution. Principal and interest are paid through payroll deductions. Interest on notes receivable from participants is charged at the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively) at the time of loan origination plus 1%.

### Benefit Payments

The Plan provides for benefit payments upon termination of service due to death, disability, or retirement. Benefit payments are made in the form of a lump-sum distribution or a rollover to another qualified investment. The Plan makes mandatory distributions upon termination of service for participants with vested balances less than \$5,000, which was increased to \$7,000 effective August 1, 2024.

## 1. DESCRIPTION OF PLAN (Continued)

### **Hardship Withdrawals**

Hardship withdrawals from the Plan are permitted from participant elective deferrals. Hardship withdrawals can only be made for payment of qualifying expenses to satisfy financial hardship, as defined in the plan document.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

### **Basis of Accounting**

The Plan's financial statements are prepared in accordance with accounting principles generally accepted in the United States.

### **Investments**

Money market funds, mutual funds and common collective trusts are stated at fair value based on quoted market prices. The Plan's guaranteed investment contract is stated at contract value. Purchases and sales of securities are reflected on a trade date basis. Interest income is recorded on the accrual basis. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold, as well as held, during the year.

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant account balances and the amounts reported in the accompanying financial statements.

### **Contribution Receivable**

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### **Payments of Benefits**

Benefit payments are recorded when paid.

### **Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates and assumptions that affect the reported amounts in the financial statements, supplemental schedule and accompanying notes. The most significant estimates within the Plan's financial statements are the investment values and the resulting net assets available for benefits. Actual results could differ from those estimates.

### **Income Taxes**

The Plan sponsor determines whether a tax position of the Plan is more likely than not to be sustained upon examination by the applicable taxing authority, based on the technical merits of the position. As of December 31, 2024, the Plan has not recorded any provisions for accrued interest and penalties related to uncertain tax positions. By statute, tax years 2021 through 2024 remain open to examination by the taxing jurisdictions to which the Plan is subject.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

### **Fair Value of Financial Instruments**

Generally accepted accounting principles provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described below:

- Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

The Plan's money market funds, mutual funds, and common collective trusts are valued utilizing level 1 inputs.

- Level 2 - Inputs to the valuation methodology include:
  - Quoted prices for similar assets or liabilities in active markets;
  - Quoted prices for identical or similar assets or liabilities in inactive markets;
  - Inputs other than quoted prices that are observable for the asset or liability;
  - Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified term, the Level 2 input must be observable for substantially the full term of the asset or liability.

The Plan did not have any financial assets or liabilities measured at fair value utilizing Level 2 inputs.

- Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The Plan did not have any financial assets or liabilities measured at fair value utilizing Level 3 inputs.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### **Reclassifications**

Certain reclassifications of amounts previously reported have been made to the accompanying financial statement to maintain consistency between periods presented. The reclassifications had no impact on previously reported net assets available for benefits.

### **Events Occurring After Reporting Date**

The Plan has evaluated events and transactions that occurred between December 31, 2024 and August 18, 2025, which is the date the financial statements were available to be issued, for possible disclosure and recognition in the financial statements (Note 9).

### 4. INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan is part of a guaranteed investment contract option with Voya. The account is credited with earnings on the underlying investments and charged for the Plan withdrawals and administrative expenses charged by Voya. The contract is considered to be fully benefit responsive. As such, the contract is included in the financial statements at contract value. The contract value of the investment contract was \$40,921 and \$31,283 at December 31, 2024 and 2023, respectively. The crediting interest rate to participants for the contract as of December 31, 2024 and 2023 was 3.00%. The guaranteed minimum crediting interest rate for the contract was 3.00% for both the years ending December 31, 2024 and 2023.

Voya's determination of credited interest rates reflects a number of factors, including mortality and expense risks, interest rate guarantees, the investment income earned on invested assets and the amortization of any capital gains and/or losses realized on the sale of invested assets. A market value adjustment may apply to amounts withdrawn at the request of the contract holder.

Certain events might limit the ability of the Plan to transact at contract value with the contract issuer. These events may be different under each contract. Examples of such events include the following:

1. The Plan's failure to qualify under Section 401(a) of the Internal Revenue Code or the failure of the trust to be tax-exempt under Section 501(a) of the Internal Revenue Code 66
2. Premature termination of the contracts
3. Plan termination or merger
4. Changes to the Plan's prohibition on competing investment options
5. Bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spinoffs of a subsidiary) that significantly affect the Plan's normal operations.

#### **4. INVESTMENT CONTRACT WITH INSURANCE COMPANY (Continued)**

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contracts with the Plan and settle at an amount different from contract value. Those events may be different under each contract. Examples of such events include the following:

1. An uncured violation of the Plan's investment guidelines
2. A breach of material obligation under the contract
3. A material misrepresentation
4. A material amendment to the agreements without the consent of the issuer

#### **5. SUMMARY OF INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN**

The Plan administrator has elected the method of annual reporting permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and interest and dividends, as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes, excluding notes receivable from participants, as of December 31, 2024 as shown on Schedule I.

#### **6. TAX STATUS**

The Plan has obtained an opinion letter for the prototype of the Plan, dated March 31, 2014, in which the Internal Revenue Service stated that the form of the Plan was in compliance with the applicable provisions of the IRC. The Plan has been amended since receiving that determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

#### **7. EXEMPT PARTY-IN-INTEREST TRANSACTIONS**

Administrative fees paid by the Plan to the custodian and third-party administrator amounted to \$4,275 and \$7,325 for the years ended December 31, 2024 and 2023, respectively.

The Plan invests in certain investments managed by Voya Financial, Inc. Voya Financial, Inc. is the custodian of the Plan's assets and, therefore, these transactions qualify as party-in-interest. Transactions involving notes receivable from participants also qualify as party-in-interest transactions.

**8. RECONCILIATION OF THE FINANCIAL STATEMENTS TO FORM 5500**

The classification of net assets available for benefits for the year ended December 31, 2023 differs between the financial statements and Form 5500. The total net assets available for benefits for the years ended December 31, 2024 and 2023 agrees between the financial statements and Form 5500.

**9. SUBSEQUENT EVENT**

Effective January 1, 2025, the Plan merged with Tower Legal Solutions 401(k) Plan. Tower Legal Solutions, Inc. is a related party through common ownership of the Company. Avalon Copy Centers of America, Inc, 401(k) Profit Sharing Plan will be the surviving plan for the benefit of the Company's employees.
