Notes to Financial Statements

December 31, 2024

1. Description of Plan

The following description of the CRC Industries, Inc. 401(k) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document and summary plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the Company.

General

The Plan is a defined contribution plan covering all eligible employees (excluding collective bargaining employees) of CRC Industries, Inc. (CRC) (the Company). An eligible employee may participate in the Plan on the date of hire; there is no minimum service or age requirement. The entry date for participation in the Plan is the first day of the payroll period. Temporary employees must complete a year of service to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). Vanguard Fiduciary Trust Company is the trustee and The Vanguard Group, Inc. is the record keeper for the Plan (collectively, Vanguard). The 401(k) Plan Committee is responsible for the general administration of the Plan.

Contributions

Participants may contribute pretax or Roth contributions of 1% to 60% of their eligible compensation, as defined in the Plan. Participants may also contribute amounts representing distributions from other qualified plans. The Plan provides for automatic enrollment at a 3% deferral with an annual 1% increase each January up to 6%. Participants aged 50 and older may make catch-up contributions.

For each pay period the Company makes a safe harbor matching contribution of 100% for the first 1% deferred and 50% for the next 5% deferred except grandfathered participants, who are highly compensated employees and accrue a benefit under an affiliated defined benefit pension plan, who receive a reduced matching contribution equal to 50% of salary deferrals up to 4% of Plan compensation.

Notes to Financial Statements (continued)

1. Description of Plan (continued)

Additionally, the Company provides a non-elective contribution (Non-elective Contribution) for eligible participants with at least 1,000 hours of service during the Plan year at a rate of 3% of compensation. An eligible participant who dies or terminates employment due to disability or attains normal or early retirement age, as defined, during the Plan year is not required to have 1,000 hours of service to receive the Non-elective Contribution. Grandfathered participants are not eligible to receive the Non-elective Contribution. For 2024 and 2023, the Company contributed \$484,109 and \$471,477 of Non-elective Contributions, respectively.

All contributions are subject to certain Internal Revenue Code (the Code) limitations.

All investments are participant-directed. Participants may direct contributions in any of the Plan's available fund options. Participants may change their investment options at any time. Participants who are automatically enrolled have their contributions invested in the applicable Vanguard target date fund based on their age until they change their election.

Participant Accounts

Each participant's account is credited with the participant's contributions, the Company's contributions and allocations of Plan earnings and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of his or her respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are 100% vested in Company safe harbor matching and non-elective contributions on graded scales after two and five years of credited service, respectively. Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions or pay for Plan expenses. There were unallocated forfeiture balances of approximately \$44,000 and \$52,000 as of December 31, 2024 and 2023, respectively, and \$54,873 of forfeitures were used during 2024.

1. Description of Plan (continued)

Participant Loans

Participants may borrow from their participant accounts a minimum of \$1,000, up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may have only one loan outstanding at a time; however, effective July 7, 2023, the maximum number of outstanding loans was increased from one to two loans. The loan term may not exceed five years unless the loan is for the purchase or construction of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate commensurate with local prevailing rates, as determined by the plan administrator. Principal and interest are paid ratably through bi-weekly payroll deductions or directly to Vanguard.

Payment of Benefits

On termination of service, death, disability, or retirement, a participant may elect to receive a distribution in the form of installments, partial distributions or a lump-sum amount, or a rollover equal to the participant's vested interest in his or her account.

In-service withdrawals are available for participants who are age 59 ½ and for hardship withdrawals. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS).

Administrative Expenses

Administrative expenses are to be paid by the Plan unless the Company, at its discretion, elects to pay such expenses. Expenses relating to purchases, sales or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable From Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Estimates

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (U.S. GAAP) requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). The 401(k) Plan Committee determines the Plan's valuation policies utilizing information provided by the investment trustee. See Note 4 for further discussion and disclosures related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Interest income is recorded as earned. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

3. Investments

All investment information disclosed in the accompanying financial statements and supplemental schedule including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest income on notes receivable from participants, and interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the plan administrator and certified as complete and accurate by Vanguard.

4. Fair Value Measurements

Fair value is defined under Accounting Standards Codification 820, *Fair Value Measurement*, as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 – Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 – Inputs other than quoted prices in active markets for identical assets and liabilities that are observable either directly or indirectly for substantially the full term of the asset or liability. Level 2 inputs include the following:
 - quoted prices for similar assets and liabilities in active markets
 - quoted prices for identical or similar assets or liabilities in markets that are not active
 - observable inputs other than quoted prices that are used in the valuation of the assets or liabilities (e.g., interest rate and yield curve quotes at commonly quoted intervals)
 - inputs that are derived principally from or corroborated by observable market data by correlation or other means

4. Fair Value Measurements (continued)

- Level 3 – Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management’s own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based on the lowest level input that is significant to the fair value measurement in its entirety.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value by the Plan. There have been no changes in the valuation techniques and inputs used at December 31, 2024 and 2023:

Registered investment companies: Valued at quoted market prices, which represent the net asset value (NAV) of shares held by the Plan at year-end.

Common/collective trusts: Valued at the published NAV of shares held by the Plan at year-end. Participant transactions (purchases and sales) may occur daily without restrictions.

5. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market volatility and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported on the statements of net assets available for benefits.

6. Tax Status

The underlying pre-approved plan has received an opinion letter from the IRS dated June 30, 2020, stating that the written form of the underlying pre-approved document is qualified under Section 401 of the Code. Any employer adopting this form of the plan will be considered to have a plan qualified under Section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. The plan administrator believes the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Party-in-Interest Transactions

The Plan invests in shares of registered investment companies managed by an affiliate of Vanguard. The Plan also holds units of common/collective trusts managed by Vanguard. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rules under ERISA.

8. Subsequent Events

Management evaluated subsequent events for the Plan through September 3, 2025, the date the financial statements were available to be issued. Based on this evaluation, no additional disclosures or adjustments were required to be made to the financial statements as of December 31, 2024.
