### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Troy Belting and Supply Company 401(k) and Profit Sharing Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## **Note 1. Summary of Plan Provisions**

The Troy Belting and Supply Company 401(k) and Profit Sharing Plan (Plan) was formed effective July 1, 1985. The Plan is sponsored by Troy Belting and Supply Company (Troy Belting). The Plan was most recently restated effective October 21, 2021.

The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan provisions.

### *a. General*

The Plan is a defined contribution plan with a profit sharing feature covering all eligible employees of Troy Belting and its wholly owned subsidiaries, TIS Ansonia LLC (Ansonia) and TIS Brewer LLC (Brewer), collectively referred to as the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan assets are held and administered by Fidelity Management Trust Company, the Trustee of the Plan, which invests cash received and income from investments based on instructions from the Company and participants and makes distributions to participants. The Plan Trustee and investment advisor are responsible for oversight of the Plan and for determining the appropriateness of the Plan's investment offerings and monitoring investment performance.

### *b. Contributions*

Each year, participants may contribute a percentage or fixed dollar amount of their pre-tax annual compensation to the Plan subject to certain limitations as defined by the Plan and the Internal Revenue Code (IRC). Effective November 2023, participants may contribute after-tax Roth elective contributions to the Plan. The maximum participant contribution to the Plan was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who have reached age 50 before the end of the Plan year are eligible to make catch-up contributions up to a maximum of \$7,500 for the years ended December 31, 2024 and 2023. Participants may also contribute rollover amounts representing distributions from other qualified plans.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their pre-tax deferral rate set at 6% of eligible compensation and their contributions invested in a designated balanced fund until changed by the participant. Auto-enrollment deferral rates are increased each year by 1% until the participant's deferral rate reaches 10%.

The Company may make a matching contribution based on a discretionary formula, as determined by the Company. The Company contributes 50% of the first 10% of a participant's eligible compensation contributed during the Plan year, for a maximum employer contribution of 5% of a participant's eligible compensation.

The Company may also make a discretionary profit sharing contribution, determined annually by the Company. The Company did not make discretionary profit sharing contributions for the years ended December 31, 2024 or 2023.

Participants direct the investment of their contributions into various investment options offered by the Plan.

### c. Plan Eligibility

Employees are eligible to participate in the Plan upon reaching 18 years of age and completing two months of service. Eligible employees may join the Plan immediately following the date that they meet the eligibility requirements. Employees are eligible to participate in the Plan with respect to the Company's discretionary matching and profit sharing contributions, if any, after completing one year of service in which the employee worked 1,000 hours.

An eligible participant must work 1,000 hours during the Plan year and be actively employed at the end of the Plan year to share in the employer's discretionary profit sharing contribution. Participants who are not actively employed due to death, total and permanent disability, or early or normal retirement, but otherwise meet the eligibility requirements, will share in the employer's discretionary profit sharing contributions, if any.

### d. Participant Accounts

Each participant's account is credited with the participant's contribution, as well as allocations of (a) the Company's discretionary matching and profit sharing contributions, if any; (b) the Plan's investment earnings (losses), net of investment expenses; and (c) administrative expenses paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined by the Plan. The benefit to which a participant is entitled is equal to the vested portion of the participant's account.

### e. Vesting

Participants are vested immediately in their elective deferral amounts and rollover contributions, plus actual earnings thereon. Participants are fully vested in the Company's discretionary matching and profit sharing contributions after completing three years of service. There is no partial vesting of Company contributions.

### f. Participant Loans

Participant loans are not allowed under the Plan.

### g. Payment of Benefits

Upon the termination of service due to death, disability, reaching the normal retirement age, or termination of employment, a participant (or their beneficiary in the case of death) may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum payment or installment payments. The Plan also allows for hardship distributions under certain conditions and in-service distributions for participants upon reaching age 59½.

If the vested portion of a participant's account balance is less than \$7,000 (\$5,000 prior to January 1, 2024), but greater than \$1,000, and the distribution takes place before the participant's normal retirement age, the amount will be distributed to an Individual Retirement Account for their benefit as soon as possible following termination, retirement or disability, or to the beneficiary following death. If the vested portion of a participant's account balance is \$1,000 or less, this amount will be paid as a lump-sum distribution to the participant as soon as possible following termination, retirement or disability, or to the beneficiary following death.

### *h. Forfeiture Accounts*

The nonvested portion of terminated participants' accounts, as defined by the Plan, represents a forfeiture. Forfeitures are first used to pay Plan expenses. Amounts not used to pay Plan expenses can be used to reduce the employer's discretionary profit sharing contribution. Forfeitures used to pay Plan expenses totaled \$11,000 and \$5,199 during the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$16,063 and \$4,967, respectively.

## Note 2. Summary of Significant Accounting Policies

### *a. Basis of Accounting*

The accompanying financial statements have been prepared on the accrual basis in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) for defined contribution plans.

### *b. Estimates*

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities at the date of the financial statements and changes therein, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### *c. Investment Valuation and Income Recognition*

Investments are reported at fair value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The Company determines the Plan's valuation policies utilizing information provided by the investment advisors and Trustee.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes gains and losses on investments bought and sold, as well as held, during the year.

### *d. Contributions*

Contributions from Plan participants and the matching contributions from the employer are recorded in the year the employee contributions are withheld from compensation.

### *e. Payment of Benefits*

Benefits are recorded when paid.

### *f. Administrative Expenses*

Administrative expenses are paid by the Plan and the Company. Administrative expenses paid directly by the Company are excluded from these financial statements. Investment-related expenses are included in net appreciation in fair value of investments.

### *g. Subsequent Events*

The Plan administrator has evaluated subsequent events through August 26, 2025, the date the financial statements were available to be issued.

## **Note 3. Certified Investments**

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest, and dividends for the years then ended, was obtained by management and agreed to, or derived from, information certified as complete and accurate by Fidelity Management Trust Company, Trustee of the Plan.

## **Note 4. Investments and Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1) and the lowest priority to unobservable inputs (Level 3).

The following three levels of the fair value hierarchy are as follows:

*Level 1:* Inputs to the valuation methodology are unadjusted quoted prices for identical assets in active markets that the Plan has the ability to access.

*Level 2:* Inputs to the valuation methodology include:

- Quoted prices for similar assets in active markets;
- Quoted prices for identical or similar assets in inactive markets;
- Inputs other than quoted prices that are observable for the asset; and
- Inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

If the asset has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset.

*Level 3:* Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodologies used at December 31, 2024 or 2023.

*Mutual funds and money market funds:* Valued at the daily closing price as reported by the fund. Mutual funds and money market funds held by the Plan are open-end mutual funds and money market funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds and money market funds held by the Plan are deemed to be actively traded.

*Common/collective trust fund:* The NAV, which is based on the fair value of the underlying investments held by the fund less its liabilities, is used as a practical expedient to estimate fair value. The practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. Sales and redemptions of participant units are transacted at such NAVs and may occur daily. If the Plan initiates a full redemption of the fund, the Trustee reserves the right to require 12 months' notification in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 or 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes that its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### Note 5. Tax Status

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the Plan administrator believes that the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax-exempt.

The Plan's management evaluates tax positions taken by the Plan and recognizes a tax liability or asset if an uncertain tax position was taken and it is more likely than not that the tax position would not be sustained upon examination by taxing authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event that the Plan terminates, participants will become 100% vested in their accounts.

### Note 7. Related-Party and Party-in-Interest Transactions

There were no administrative expenses paid by the Company for the years ended December 31, 2024 or 2023. Certain administrative functions are performed by employees of the Company who do not receive compensation from the Plan for such functions.

Certain Plan investments are managed by Fidelity Management Trust Company, the Trustee of the Plan.
