Opinion

We have audited the financial statements of the Phoenix Communications, Inc. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

NOTE 1. DESCRIPTION OF PLAN

The following description of the Phoenix Communications, Inc. 401(k) Profit Sharing Plan (the Plan) provides general information. Participants should refer to the plan document for a more comprehensive description of the Plan's provisions.

General - The Plan is a defined contribution profit sharing plan covering all full-time employees of Phoenix Communications, Inc. (the Company) and its affiliates who have completed three months of service and are age twenty-one or older. The Plan was amended to reduce the age requirement from twenty-one to eighteen, to be eligible to participate in the Plan, effective January 1, 2023. As of December 31, 2024 and 2023 the following affiliates have adopted the plan as participating employers: Axis Engineering, LLC; Last Mile Solutions, LLC; and Coastal Fiber, LLC. The Plan was established on January 1, 2005 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan was adopted under the provisions of Section 401(a) of the Internal Revenue Code (Code) with a cash or deferred arrangement qualified under Section 401(k) of the Code.

Contributions - Each year, participants may contribute up to 100 percent of pretax annual compensation, up to IRS limits, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan allows 401(k) contributions to be made as Roth contributions. Roth contributions are 401(k) contributions that are made in the same manner as pre-tax 401(k) contributions except that Roth contributions are made to the Plan on an after-tax basis. If certain requirements are met, a "qualified distribution" from your Roth Contribution Account in the Plan will not be taxed. The Company makes a safe harbor matching contribution equal to 100 percent of the first 3 percent of base compensation that a participant contributes to the Plan, plus 50 percent of the next 2 percent of base compensation that a participant contributes to the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors. During the years ended December 31, 2024 and 2023 no profit sharing contributions were made to the Plan. Contributions are subject to certain IRS limitations. Employee and employer contributions are accounted for as exchange transactions.

Participant Accounts - Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant net earnings and account balances, as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1. DESCRIPTION OF PLAN (continued)

Forfeited balances of terminated participants' nonvested accounts are used to reduce future Company contributions. Forfeitures totaled \$-0- for both years ended December 31, 2024 and 2023.

Vesting - Participants are immediately vested in their elective deferrals and the Company safe harbor matching contribution plus net earnings thereon. Vesting in the Company non-safe harbor matching and profit sharing contribution portions of their accounts plus net earnings thereon is based on years of continuous service. A participant is twenty percent (20%) vested after two years of credited service, forty percent (40%) vested after three years of credited service, sixty percent (60%) vested after four years of credited service, eighty percent (80%) vested after five years of credited service, and fully vested after six years of credited service. Participants are fully vested upon attaining retirement age, or becoming totally and permanently disabled, or at death.

Payment of Benefits - Upon termination of service due to death, retirement, disability, or other cause a participant's entire undistributed vested interest in the Plan (reduced by any security interest held by the Plan by reason of an outstanding loan to the participant) shall be available to be distributed to him or her in a single, lump sum cash payment.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates - The preparation of financial statements, in conformity with accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Valuation of Investments and Income Recognition - The Plan's assets are stated at fair value, which is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

See Note 8 for discussion of fair value measurements.

Method of Accounting - The accompanying financial statements are prepared using the accrual basis of accounting.

Administrative Expenses - Phoenix Communications, Inc., the Plan sponsor, pays significant costs of the Plan operation including Plan administration and office expenses.

NOTE 3. PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to amend or terminate the Trust subject to the provisions of ERISA. In the event of Plan termination, each participant or beneficiary will become one hundred percent (100%) vested and have a nonforfeitable right to their accounts, after providing for all the expenses of the Plan at termination.

NOTE 4. TAX STATUS

The Plan is qualified under Section 401(a) of the Code and the related trust is exempt from federal income tax under Section 501(a).

The company adopted a Non-Standardized Pre-Approved Profit Sharing Plan and the Internal Revenue Service (IRS) stated by letter dated June 30, 2020 that the Plan, as then designed, was in compliance with the applicable requirements of the Code.

The Plan has been amended since receiving the opinion letter. However, the Plan Administrator believes that the Plan is currently designed, and is currently being operated, in compliance with the applicable requirements of the Code. Therefore, they believe that the Plan is qualified, and the related trust is tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 5. PARTICIPANT NOTES RECEIVABLE

Participants may borrow the lesser of \$50,000 or fifty percent (50%) of their vested account balance. The minimum loan amount is \$1,000. Loan terms generally range from one to five years. The loans are secured by the vested balance in the participant's account. During the year, the interest rate charged on the outstanding loans ranged from 3.25% to 8.50%. Principal and interest are paid through payroll deductions.

Interest collected on these loans, which is credited directly to the participant's account, totaled \$22,688 and \$13,752 for the years ended December 31, 2024 and 2023, respectively. These amounts are included in interest income on the statements of changes in net assets available for benefits. Under the provisions of the loan agreement, any legal fees and related costs incurred in collecting delinquent loan payments are charged directly to the delinquent participant account. There were no such fees for the years ended December 31, 2024 and 2023.

NOTE 6. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities, which are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amount reported in the statement of net assets available for benefits.

NOTE 7. PARTY IN INTEREST TRANSACTIONS

The Plan paid certain expenses related to plan operations and investment activity to various service providers. Participant loans also qualify as party in interest transactions. These transactions are party in interest transactions under ERISA.

NOTE 8. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

NOTE 8. FAIR VALUE MEASUREMENTS (continued)

The following is a description of the valuation methodologies used for assets and liabilities measured at fair value, as well as the general classification of such assets and liabilities pursuant to the valuation hierarchy. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

Registered Investment Companies: Valued at the daily closing prices as reported by the funds. Registered investment companies held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at the price. The registered investment companies held by the Plan are deemed to be actively traded.

Money Market Fund: Valued daily at the closing price as reported by the Fund. The Fund publishes its net asset value daily and seeks to maintain a stable share price of \$1.
