Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the Bill Alexander Automotive Group 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). 1. Summary of Significant Plan Provisions

The following description of the Bill Alexander Automotive Group 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of the employees of Bill Alexander Ford Lincoln Mercury, Inc. (the “Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – Employees who are not a part of an ineligible class of employees, as defined in the Plan agreement, are eligible to participate in the Plan at the next entry date after attaining age 21 and 12 months of consecutive service during which the employee is credited with 1,000 hours or more of service. Entry date is the first day of the month following the month in which eligibility requirements are met.
- c. **Contributions** – Participants may contribute up to 90% of pretax annual compensation, as defined in the Plan document. With the consent of the administrator, participants may contribute amounts from other tax-qualified plans (rollover), provided that the trust from which such funds are transferred permits the transfer, and the transfer does not jeopardize the tax-exempt status of the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. An automatic deferral equal to 4% of employee plan compensation is withheld from the participant’s paycheck each pay period upon meeting the Plan’s eligibility requirements, unless the employee declines or elects to defer a different percentage of their compensation. The automatic deferral increases by 1% in the second through eleventh year to a maximum of 15%. The Employer can, at the option of management, make discretionary contributions in the form of matching contributions and profit sharing contributions. The Employer provided a discretionary matching contribution of 50% of the employee’s contributions up to 4% of gross compensation for the year ended December 31, 2024. There were no profit sharing contributions made to the Plan for the year ended December 31, 2024. Contributions are subject to certain Internal Revenue Service (“IRS”) limitations.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Vesting** – Participants are immediately and fully vested in their elective contributions and rollovers plus actual earnings thereon. With respect to Employer contributions, the vested benefits attributable to a participant shall be fully vested and nonforfeitable upon death, becoming disabled or reaching their normal retirement age, as defined in the Plan document.

If a participant terminates employment other than because of death, disability, or retirement, they are entitled to a vested portion of contributions made by the Employer plus earnings/losses thereon according to the following schedule:

Less than 2	0%
2 but less than 3	20%
3 but less than 4	40%
4 but less than 5	60%
5 but less than 6	80%
6 or more	100%

- f. **Investment options** – Upon enrollment in the Plan, participants may direct their contributions to any of the investment options offered under the Plan. Participants may change their investment selections at any time.
- g. **Notes receivable from participants** – Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000, as reduced in accordance with the Plan agreement, or one-half of the participant’s vested account. Note terms range from one to five years, unless the note is used to purchase a primary residence, in which case the note term cannot exceed 20 years. The notes are secured by the participant’s account and bear a reasonable interest rate of the Prime rate per year. Principal and interest payments are made ratably through payroll deductions.
- h. **Payment of benefits** – Upon termination of service other than by reason of death, the balance of the participant’s vested account becomes distributable. If the vested balance is equal to or less than \$1,000, the balance will be distributed in cash as soon as administratively feasible. Vested balances over \$1,000 but less than \$7,000 will be distributed either in cash or to an individual retirement account or other qualified plan. Vested balances equal to or more than \$7,000 require written consent prior to distribution. However, the Plan administrator will distribute vested balances in a lump sum without consent after the later of (a) normal retirement age or (b) age 62. In a distribution due to death, the participant’s vested account balance must be distributed to the beneficiary by December 31 of the calendar year containing the fifth anniversary of death unless an election is made by the beneficiary to receive distributions over not greater than the life expectancy of the beneficiary. If the account has not been distributed by the date on which the participant attains age 70½, provisions in the Plan provide for minimum distributions. In-service withdrawals are available to participants who attain age 59½ or meet certain hardship requirements.

- i. **Corrective distributions** – The Plan failed the actual deferral percentage and actual contribution percentage tests for the years ended December 31, 2024 and 2023. As a result, corrective distributions in the amount of \$64,433 and \$84,362 are recorded as a liability on the accompanying statement of net assets available for benefits as of December 31, 2024 and 2023, respectively, and as a reduction of participant contributions on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024. These corrective distributions were refunded to the applicable participants in February 2025 and March 2024, respectively.
- j. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, participants will become 100% vested in their employer accounts.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.
- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Net change in fair value of investments includes the Plan’s gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.
- e. **Payment of benefits** – Benefits are recorded when paid. A benefit of \$83,395 was approved for payment as of December 31, 2024, but was not paid until January 7, 2025.
- f. **Administrative expenses** – Certain administrative expenses are allocated to participant’s accounts. Fees related to loans are charged directly to the participant’s account. Administrative expenses voluntarily paid by the Employer are not included in the Plan’s financial statements.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by John Hancock Life Insurance Company (U.S.A.) ("John Hancock"), the custodian of the Plan, and was not subjected to any audit procedures, except for comparing such information with the related information included in the financial statements and supplemental schedule:

- a. Cash - interest-bearing as shown on the accompanying statement of net assets available for benefits of \$0 and \$314 as of December 31, 2024 and 2023, respectively.
- b. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$6,746,702 and \$6,740,862 as of December 31, 2024 and 2023, respectively.
- c. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$990,594 for the year ended December 31, 2024.
- d. All investment transactions that occurred during the year ended December 31, 2024.
- e. All information included in the supplementary schedule, excluding notes receivable from participants.

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

4. Fair Value Measurements

The following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 or 2023.

Pooled separate accounts: These investments are valued based on the net asset value ("NAV") of the pooled separate account multiplied by the number of shares held by the Plan at year-end. The NAV is determined based on the fair value of the underlying investments, adjusted for expenses. The NAV is used as a practical expedient to estimate fair value.

The preceding method described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the “Plan Document”), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code (“IRC”). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan’s financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

6. Parties-in-Interest Transactions

John Hancock is the Plan’s custodian and Matthews, Gold, Kennedy & Snow, Inc. (“MGK&S”) provides third-party administrative services for the Plan. NYLIFE Securities LLC (“NY Life”) serves as broker of the Plan. The Plan pays John Hancock, MGK&S, and NY Life for their services. The Plan also holds notes receivable from participants. As a result, these notes receivable and related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.
