Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

1. Description of the Plan

The following summary description of PMW 401(k) Plan (the “Plan”) is provided for general information purposes only. Participants should refer to the Plan Document for more complete description of the plan’s provisions.

General

The Plan is a defined contribution plan covering eligible employees of Pennsylvania Machine Works, LLC and participating employers (collectively the “Company” or “Employer”). Participating employers include PMW Illinois, Inc. and Texas PMW, Inc. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective January 1, 2025, the Plan was amended to change the name of the Plan to LPW Group Holdings, Inc. Savings Plan.

Eligibility

Employees of the Company who are not a resident of Puerto Rico or covered by a collective bargaining agreement, unless the agreement requires the employees to be included under the Plan, are eligible to enter the Plan the first day of each month after obtaining the age of 18.

Contributions

Participants are permitted to contribute, on a pre-tax or Roth basis, up to 100% of their eligible compensation, subject to certain limitations under the terms of the Plan and the Internal Revenue Code (“IRC”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

The Plan includes an auto enrollment provision whereby all newly eligible participants are automatically enrolled in the Plan unless they elect not to participate in the Plan. Participants will have their deferral rate set at 4% of eligible compensation and their contributions invested in a designated fund until changed by the participant.

The Plan provides for Employer non-discretionary matching contributions of 25% of participants contributions up to 4% of participant eligible compensation, subject to certain limitations.

The Company may make discretionary Employer matching and/or profit-sharing contributions on behalf of each eligible participant. At the Company’s discretion, matching contributions may be made on behalf of each participant equal to a percentage of the elective deferrals made by the participant. At the Company’s discretion, a profit-sharing contribution may be made within the time limits required by law. In order to receive the profit-sharing contribution, the participant must be employed on the last day of the year and complete at least 1,000 hours of service during the Plan year. The Company did not make a discretionary matching or profit-sharing contributions to the Plan for the 2024 plan year.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of (a) Employer contributions and (b) Plan earnings (losses) thereon. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant is 100% vested in their elective deferrals plus allocated earnings thereon at all times. Vesting in the Employer contributions is as follows:

Payment of Benefits

Upon termination of service due to death, disability, or normal retirement, each participant will be entitled to the full value of their accounts. Upon termination of service, a participant shall be entitled to receive a single lump sum payment in cash equal to the value of the participant's vested account balance, installment payments, ad-hoc payments, or a direct rollover to an IRA or another employer retirement plan. If a participant's vested account balance is \$5,000 or less, the amount exceeding \$1,000 will be distributed to an IRA. For vested account balances less than \$1,000, the amount will be distributed in a lump-sum distribution without the consent from the participant. For vested account balances exceeding \$5,000, participants must consent to distribute their vested account balance. Participants may receive an in-service withdrawal from certain other accounts prior to termination of employment with the Company if they have attained age 59½ or incurred a financial hardship.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance in the available contribution sources or \$50,000 reduced by the highest outstanding loan balance in their account during the prior twelve month period. Loan terms cannot exceed five years, unless it is for the purchase of a principal residence in which case the loan repayment period may not extend beyond 10 years. The loans are adequately secured by the vested balance in the participant's account and bear a reasonable rate of interest. Loan principal and interest repayments are made via payroll deductions, are credited directly to the participant's account, and are invested at the participant's direction in one or more of the investment options. A participant can only have one loan outstanding at a time.

1. Description of the Plan (*continued*)

Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation in fair value of investments.

Forfeitures

Forfeited accounts are amounts forfeited by participants who have terminated their employment and who have withdrawn from the Plan. At December 31, 2024 and 2023 forfeited non-vested amounts totaled \$88,425 and \$81,654. These amounts will be used to reduce future Employer contributions and/or administrative expenses. During 2024, no forfeitures were used to reduce Employer contributions or administrative expenses.

2. Summary of Significant Accounting Policies

Basis of Accounting and Use of Estimates

The financial statements of the Plan are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Fair Value Measurements

The Plan follows U.S. GAAP guidance on *Fair Value Measurements* which defines fair value and establishes a fair value hierarchy organized into three levels based upon the input assumptions used in pricing assets. Level 1 inputs have the highest reliability and are related to assets with unadjusted quoted prices in active markets. Level 2 inputs relate to assets with other than quoted prices in active markets which may include quoted prices for similar assets or liabilities or other inputs which can be corroborated by observable market data. Level 3 inputs are unobservable and are used to the extent that observable inputs do not exist.

Pursuant to U.S. GAAP guidance, alternative investments where fair value is measured using the net asset value ("NAV") per share as a practical expedient is not categorized within the fair value hierarchy.

2. Summary of Significant Accounting Policies (continued)

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. The mutual funds, common stocks and money market fund are valued at the daily closing price on an active market. The funds held by the Plan are open-end funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The common/collective trusts are valued at the NAV of units held by the Plan. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document.

Benefit Payments

Benefits are recorded when paid.

Subsequent Events Evaluation by Management

Management has evaluated subsequent events for disclosure and/or recognition in the financial statements through the date that the financial statements were available to be issued, which date is August 29, 2025.

3. Information Certified (Unaudited)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required Schedule H, Part IV, Line 4i – Schedule of Assets (Held at End of Year) including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, a qualified institution.

The Plan has a self-directed brokerage account which allows participants to invest in various investments that are not part of the Plan's investment platform. As of December 31, 2024 and 2023, the Plan's self-directed brokerage accounts consisted of all of the Plan's investments in all common stocks, a mutual fund, and a money market fund.

5. Common/Collective Trusts

The NAVs of the Plan's interest in the common/collective trusts are calculated daily. Net investment income, if any, and realized and unrealized gains on investments are not distributed but rather are reinvested and reflected in the NAVs of the common/collective trusts. Units of the trusts are issued and redeemed at the current NAV of the applicable trust. At December 31, 2024 and 2023, the common/collective trusts have no unfunded commitments.

6. Party-in-Interest Transactions

Certain investments are managed by Fidelity Management Trust Company, the trustee of the Plan. Therefore, these transactions qualify as exempt party-in-interest transactions under ERISA. Fidelity Workplace Services LLC is the record-keeper for the Plan.

Participants who are active employees may borrow from their accounts and such loans qualify as exempt party-in-interest transactions under ERISA. These loans are recorded as notes receivable from participants in the statement of net assets available for benefits.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants would become 100% vested in their Employer contributions.

8. Tax Status

The Internal Revenue Service ("IRS") issued an opinion letter to the prototype plan document preparer, Fidelity Management & Research LLC, dated June 30, 2020, which states that the form of the prototype plan qualifies under the applicable provisions of the IRC. Although the Plan has been amended since receiving the opinion letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine examinations by taxing jurisdictions; however, there are currently no examinations for any tax periods in progress.

9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonable that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Global and domestic economic uncertainty has resulted in significant volatility in financial markets. This volatility has affected, and may continue to affect, the value of the Plan's net assets available for benefits. The effects of economic and market conditions subsequent to December 31, 2024 are not reflected in these financial statements and future effects on the Plan's net assets available for benefits cannot be predicted.
