We have performed audits of the financial statements of TorcSill 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of January 24, 2023 and December 31, 2022, and the related statements of changes in net assets available for benefits for the period of January 1, 2023 to January 24, 2023 and for the year ended December 31, 2022, and the related notes to the financial statements.

## Notes to Financial Statements

### **Note 1. Description of the Plan**

The following description of the TorcSill 401(k) Plan (the Plan) provides only general information. Participants should refer to the *Plan document* for a more complete description of the Plan's provisions, which is available from Plan management.

#### **General**

The Plan is a defined contribution plan covering all eligible employees of TorcSill Foundations, LLC (the Company) who have at least three months of service and are age twenty-one or older. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Trustees are responsible for oversight of the Plan and determine the appropriateness of the Plan's investment offerings and monitors investment performance.

On January 24, 2023, the Plan was merged into the WDP Pooled Employer Plan. Participant and loan balances of \$1,791,145 were transferred into the WDP Pooled Employer Plan and are shown as transfers out of the Plan on the statements of changes in net assets available for benefits.

#### **Contributions**

Each year, participants may contribute up to 100 percent of pretax annual compensation, as defined in the Plan. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants may also designate some of their contributions as after tax contributions to a Roth 401(k) option. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Company may contribute discretionary matching and profit sharing amounts at the option of the Company management. Company contributions are invested as directed by the participant. During the period of January 1, 2023 to January 24, 2023 and the year ended December 31, 2022, the Company made no discretionary matching or profit sharing contributions to the Plan. Contributions are subject to certain limitations.

Employer's contribution receivables noted in the statements of net assets available for benefits and employer contributions noted on the statements of changes in net assets available for benefits are related to certain corrective contributions made in regards to compliance testing conducted for the year ended December 31, 2022. A related payable to WDP Pooled Employer Plan was reported on the statement of net assets as of January 24, 2023 for the amount remitted by the Plan in February 2025.

#### **Participant Accounts**

Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) Plan earnings. Participant accounts are charged with an allocation of administrative expenses. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

#### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Prior to February 15, 2017, participants were immediately vested in their contributions and the Company's matching contributions plus actual earnings thereon. However, effective February 15, 2017, the Plan was amended to change the vesting in the Company's contribution portion of their accounts to be based on years of continuous service. A participant is 100 percent vested after six years of credited service.

## Notes to Financial Statements

### **Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at rates commensurate with local prevailing rates as determined by Plan management. Principal and interest is paid ratably through payroll deductions.

### **Payment of Benefits**

Upon separation of service due to death, disability, retirement or termination of employment, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account, or partial withdrawals or installments, but only with respect to minimum required distributions.

### **Forfeited Accounts**

At January 24, 2023 and December 31, 2022, forfeited nonvested accounts totaled \$0 and \$178, respectively. These accounts are used to reduce future Company contributions and to pay Plan expenses. The 2022 forfeiture balance of \$178 was transferred to the WDP Pooled Employer Plan.

## **Note 2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The financial statements of the Plan are prepared using the accrual basis of accounting.

### **Use of Estimates**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America (US GAAP) requires Plan management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value (except for the fully benefit-responsive investment contract, which is reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded at the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Contributions**

Contributions from Plan participants and the matching contributions from the Company are recorded in the year in which the employee contributions are withheld from compensation.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of January 24, 2023 and December 31, 2022.

### **Payment of Benefits**

Benefits are recorded when paid.

### **Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

### **Plan Management's Review of Subsequent Events**

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

### **Note 3. Certified Investments**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at January 24, 2023 and December 31, 2022, and net appreciation (depreciation) in fair value of investments, interest and dividends and interest income on notes receivable from participants for the period of January 1, 2023 to January 24, 2023 and for the year ended December 31, 2022, was obtained by management and agreed to or derived from information certified as complete and accurate by Voya Institutional Trust Company (Voya), the custodian of the Plan.

As described in Accounting Standards Codification (ASC) 962, *Plan Accounting-Defined Contribution Pension Plans*, as updated by ASU 2015-12, investment contracts held by a defined contribution plan are required to be reported at contract value. For the period of January 1, 2023 to January 24, 2023 and for the year ended December 31, 2022, the Plan had interests in The Voya Fixed Account which is available under a group annuity contract issued by Voya Retirement Insurance and Annuity Company (VRIAC). VRIAC maintains the contributions in a general account which supports insurance and annuity obligations. VRIAC's general account is managed on an aggregate basis and supports all of the Company's financial commitments. The interest rate guarantees under the contract are subject to VRIAC's claims-paying ability. Stability of principal is the primary objective of this investment option. The Voya Fixed Account guarantees minimum rates of interest and may credit interest that exceeds the minimum guaranteed rate. The current rate is subject to change at any time, but will never fall below the guaranteed minimum. Daily credited interest becomes part of principal and the investment increases through compound interest. Withdrawals from the Voya Fixed Account promise contract value for a benefit event (termination, death, disability and retirement); however, there is a possible withdrawal fee.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but it may not be less than 0%. Such interest rates are reviewed on a quarterly basis for resetting. Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan document (including complete or partial plan termination or merger with another plan); (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions; (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-off of a subsidiary) that cause significant withdrawal from the Plan; or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with participants are probable of occurring.

### Note 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at January 24, 2023 and December 31, 2022.

Pooled separate accounts. Valued at the net asset value (NAV) of the units held by the Plan at year end based on quoted market price of the underlying investments in each separate account. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value.

#### Note 5. Related Party Transactions and Party in Interest Transactions

Certain Plan investments are shares of pooled separate accounts and a guaranteed investment account provided through Voya. Voya is the record keeper and custodian for the Plan and, therefore, these transactions qualify as party in interest transactions. All investment fund earnings or losses posted to each Plan participant's account are net of investment management fees charged by each investment fund under the Plan.

#### Note 6. Tax Status

The Plan adopted a non-standardized prototype defined contribution volume submitter 401(k) profit sharing plan with Internal Revenue Code Section 401(k) Cash or Deferred Arrangement (CODA) which received a favorable opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020. The Plan has been amended since the date of the last amendment covered by the above mentioned determination letter. However, Plan management believes that the plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

US GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### Note 7. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events, which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that some changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

#### Note 8. Prior Period Adjustment/Restatement

Net assets available for benefits as of December 31, 2022 were previously overstated by \$37,215, due to an error in the calculation of employer's contributions receivable accrued by the Plan. Balances as of December 31, 2022 have accordingly been restated, and the net impact of the correction on amounts previously reported as of December 31, 2022 was as follows:
