INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

LeanTaaS, Inc. 401(k) Savings Plan Notes to Financial Statements

1. Description of the Plan

LeanTaaS, Inc. (the Company) established the LeanTaaS, Inc. 401(k) Savings Plan (the Plan) on January 1, 2015, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and recordkeeper. Fidelity holds, invests, and reinvests Plan assets in the interest and at the direction of the participants and their beneficiaries. The Company has engaged Heffernan Retirement Services (Heffernan) as a Plan advisor. The Plan is administered by an Investment Committee, consisting of Company employees, and Heffernan, which are responsible for selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Company employees, age 21 and over, as defined by the Plan agreement, are eligible to participate and make contributions to the Plan the first day of the month following their hire date.

Contributions:

Participants are permitted to make voluntary pre-tax salary and Roth post-tax contributions up to 90% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to Code regulations.

The Company may make discretionary matching and non-elective contributions to the Plan. In 2024, the Company made discretionary matching contributions to the Plan, equal to 100% of participant contributions for each pay period, up to a maximum of 3% of eligible compensation, as defined by the Plan agreement. Company discretionary matching contributions totaled \$1,339,862 in 2024.

Contributions are subject to certain limitations under the Code.

1. Description of the Plan (continued)

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert their deferral contributions to be designated as Roth balances. In 2024, no deferral contributions were converted to Roth balances.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions, rollovers and an allocation of Plan earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

In addition, participants can choose to invest in and manage a broader range of investments through participant-managed Fidelity self-managed brokerage accounts. Investment choices offered to participants in these participant-managed retirement accounts include most equity securities listed on major stock exchanges in the United States of America, additional mutual funds and over-the-counter stocks, bonds, and other fixed-income securities.

Vesting:

Participants are fully vested (100%) in their contributions, rollovers, and Company discretionary matching contributions plus earnings (less any losses) thereon. Company non-elective contributions vest 25% annually resulting in 100% vesting after four years of service.

Forfeitures:

Terminated participant's non-vested account balances will be forfeited upon the earlier of the payment of vested benefits, or when participants incur five consecutive one-year breaks in service. Forfeitures may be used to pay administrative expenses, restore forfeited accounts, reduce Company contributions, or be reallocated to participants, as elected by the Company. In 2024, forfeitures of \$159,655 were used to offset Company contributions. The Plan had \$14 of forfeitures available for future use at December 31, 2024 (\$99,291 at December 31, 2023).

1. Description of the Plan (continued)

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to acquire a principal residence for which terms up to thirty years may be granted. Participants may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the vested balance in the participant account, and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator, under the Plan's note policy. The interest rate on the notes outstanding at December 31, 2024 range from 6.50% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Payment of Benefits:

Upon termination of service, participants may elect to leave their account balances in the Plan or receive their benefits in a lump sum amount equal to the value of the vested interest in their accounts, or in partial payments. Accounts between \$1,001 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts with a balance of \$1,000 or less may be distributed directly to participants without participant approval. Benefits are recorded when paid.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance, Plan advisory, professional and transaction fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and not reflected in these financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

The Plan's investments consist of mutual funds, a money market fund and participant-managed retirement accounts. These investments are accounted for as follows:

Mutual Funds and Money Market Fund: These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Participant-Managed Brokerage Accounts: These participant-managed Fidelity self-directed brokerage accounts, may consist of shares in various interest-bearing cash accounts, mutual funds, money market funds, over-the-counter equity securities, bonds and other fixed-income securities that are valued based on quoted prices in active markets.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's investments are recorded at fair value and classified as Level I within the fair value hierarchy at December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants, reflected on the accompanying statements of net assets available for benefits as December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the income tax positions taken by the Plan and has concluded, at December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-in-Interest Transactions

Certain of the Plan's investments are offered by Fidelity, the Plan's trustee. Purchases and sales of these investments qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

6. Subsequent Events

Subsequent events have been evaluated through August 28, 2025, which is the date the financial statements were approved by the Plan Administrator and available to be issued.

1. Description of the Plan

LeanTaaS, Inc. (the Company) established the LeanTaaS, Inc. 401(k) Savings Plan (the Plan) on January 1, 2015, to provide participants with a means to fund their retirement on a tax-deferred basis. The following description of the Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General:

The Plan is a defined contribution plan under the related provisions of the Internal Revenue Code (the Code) and applicable state laws. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

The Company is the Plan sponsor and Plan administrator. The Plan is administered by Company employees, who are responsible for selecting investment options offered under the Plan and monitoring investment performance. Fidelity Management Trust Company (Fidelity) serves as the Plan's trustee and recordkeeper. Fidelity holds, invests, and reinvests Plan assets in the interest and at the direction of the participants and their beneficiaries. The Company has engaged Heffernan Retirement Services (Heffernan) as a Plan advisor. The Plan is administered by an Investment Committee, consisting of Company employees, and Heffernan, which are responsible for selecting investment options offered under the Plan and monitoring investment performance.

Eligible Participants:

Company employees, age 21 and over, as defined by the Plan agreement, are eligible to participate and make contributions to the Plan the first day of the month following their hire date.

Contributions:

Participants are permitted to make voluntary pre-tax salary and Roth post-tax contributions up to 90% of their annual eligible compensation, as defined in the Plan agreement. Participants who have reached the age of 50 may also elect to withhold additional "catch-up" contributions under the Code. Participants may also contribute amounts representing distributions from other qualified defined contribution or defined benefit plans (rollovers), subject to Code regulations.

The Company may make discretionary matching and non-elective contributions to the Plan. In 2024, the Company made discretionary matching contributions to the Plan, equal to 100% of participant contributions for each pay period, up to a maximum of 3% of eligible compensation, as defined by the Plan agreement. Company discretionary matching contributions totaled \$1,339,862 in 2024.

Contributions are subject to certain limitations under the Code.

1. Description of the Plan (continued)

In-Plan Roth Conversions:

The Plan allows participants who are active employees of the Company to convert their deferral contributions to be designated as Roth balances. In 2024, no deferral contributions were converted to Roth balances.

Participant Accounts:

Participant accounts are credited with participant contributions, Company contributions, rollovers and an allocation of Plan earnings (less any losses) thereon. Allocations are based on participant earnings or account balances, in accordance with the Plan agreement. The benefit to which participants are entitled is the benefit that can be provided from the participant vested accounts.

Participants may elect to invest their accounts in a variety of participant-directed investment options offered by the Plan that are designed to provide the participants with a wide range of investment options. Participants may authorize transfers among investment options at any time.

In addition, participants can choose to invest in and manage a broader range of investments through participant-managed Fidelity self-managed brokerage accounts. Investment choices offered to participants in these participant-managed retirement accounts include most equity securities listed on major stock exchanges in the United States of America, additional mutual funds and over-the-counter stocks, bonds, and other fixed-income securities.

Vesting:

Participants are fully vested (100%) in their contributions, rollovers, and Company discretionary matching contributions plus earnings (less any losses) thereon. Company non-elective contributions vest 25% annually resulting in 100% vesting after four years of service.

Forfeitures:

Terminated participant's non-vested account balances will be forfeited upon the earlier of the payment of vested benefits, or when participants incur five consecutive one-year breaks in service. Forfeitures may be used to pay administrative expenses, restore forfeited accounts, reduce Company contributions, or be reallocated to participants, as elected by the Company. In 2024, forfeitures of \$159,655 were used to offset Company contributions. The Plan had \$14 of forfeitures available for future use at December 31, 2024 (\$99,291 at December 31, 2023).

1. Description of the Plan (continued)

Notes Receivable from Participants:

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant notes are reclassified as distributions based upon the terms of the Plan agreement.

Participants may borrow up to one-half of their vested account balance, a minimum of \$1,000 and not to exceed \$50,000, for a period not to exceed five years, except for notes used to acquire a principal residence for which terms up to thirty years may be granted. Participants may only have one note outstanding at a time. Participant notes are evidenced by a written note, secured by the vested balance in the participant account, and bear interest at a rate commensurate with local prevailing rates, as determined by the Plan administrator, under the Plan's note policy. The interest rate on the notes outstanding at December 31, 2024 range from 6.50% to 9.50%. Repayment of principal and interest is generally made through payroll deductions.

Payment of Benefits:

Upon termination of service, participants may elect to leave their account balances in the Plan or receive their benefits in a lump sum amount equal to the value of the vested interest in their accounts, or in partial payments. Accounts between \$1,001 and \$7,000 may be automatically distributed to individual retirement accounts on behalf of the participants without participant approval. Accounts with a balance of \$1,000 or less may be distributed directly to participants without participant approval. Benefits are recorded when paid.

Administrative Expenses:

Several of the investment fund options are subject to investment fees based on a percentage of invested assets, as disclosed in the fund's prospectus. These fees are charged directly against the fund's investment performance and, thus, are not separately disclosed in the Plan's financial statements. Certain account maintenance, Plan advisory, professional and transaction fees are charged to the Plan and allocated to participant accounts. All other administrative expenses related to the Plan are paid by the Company and not reflected in these financial statements.

Risks and Uncertainties:

Participants may invest their account balances in a variety of investment options offered by the Plan. Investments are exposed to various risks, such as interest rate, market fluctuation, and credit risks. Due to the level of risk associated with certain investment options offered by the Plan, it is at least reasonably possible changes in risk in the near term could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.

Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions and to terminate the Plan at any time, subject to the provisions of ERISA. In the event of Plan termination, participants would become fully vested in their accounts and distributions would be made to participants as described in the Plan agreement.

2. Summary of Significant Accounting Policies

Basis of Accounting:

The Plan's financial statements are prepared on the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates:

The preparation of financial statements in conformity with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investments:

The Plan's investments consist of mutual funds, a money market fund and participant-managed retirement accounts. These investments are accounted for as follows:

Mutual Funds and Money Market Fund: These funds are valued at the net asset value (NAV) of shares held by the Plan at year end, as quoted in active markets.

Participant-Managed Brokerage Accounts: These participant-managed Fidelity self-directed brokerage accounts, may consist of shares in various interest-bearing cash accounts, mutual funds, money market funds, over-the-counter equity securities, bonds and other fixed-income securities that are valued based on quoted prices in active markets.

2. Summary of Significant Accounting Policies (continued)

Fair Value Measurement:

The Plan uses a three-level hierarchy for fair value measurement based on the nature of inputs used in the valuation of an asset or liability at the measurement date. The three-level hierarchy prioritizes within the measurement of fair value, the use of market-based information over entity-specific information. Fair value focuses on an exit price and is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The inputs or methodology used for valuing financial instruments are not necessarily an indication of the risk associated with those instruments.

The three-level hierarchy for fair value measurement is defined as follows:

Level I: Inputs to the valuation methodology are quoted prices (unadjusted) for identical assets or liabilities in active markets.

Level II: Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the financial instrument.

Level III: Inputs to the valuation methodology, which are significant to the fair value measurement, are unobservable.

A financial instrument's categorization within the fair value hierarchy is based upon the lowest level of input that is significant to the fair value measurement.

The Plan's investments are recorded at fair value and classified as Level I within the fair value hierarchy at December 31, 2024 and 2023.

Income Recognition:

Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual method of accounting. Dividends are recorded on the ex-dividend date. Net appreciation includes gains and losses on the Plan's investments bought, sold, or held during the year.

3. Information Prepared and Certified by the Qualified Institution

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity, the qualified institution of the Plan, has certified to the completeness and accuracy of the:

- investments and notes receivable from participants, reflected on the accompanying statements of net assets available for benefits as December 31, 2024 and 2023.
- net appreciation in fair value of investments, dividends and interest, and interest income on notes receivable from participants on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- investment information included in the footnotes and on the supplemental schedule of assets (held at end of year) as of December 31, 2024.

4. Income Tax Status

The Plan administrator has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable provisions of the Code. The Plan document has been amended and restated since receipt of the letter. However, the Plan administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code and related state statutes and is, therefore, qualified, and the trust that forms a part of the Plan is exempt from federal and state income taxes.

GAAP requires Plan management to evaluate income tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain income tax position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the income tax positions taken by the Plan and has concluded, at December 31, 2024, there are no uncertain income tax positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes the Plan is no longer subject to income tax examinations for years prior to 2021.

5. Party-in-Interest Transactions

Certain of the Plan's investments are offered by Fidelity, the Plan's trustee. Purchases and sales of these investments qualify as party-in-interest transactions. Note receivable transactions with participants also qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

6. Subsequent Events

Subsequent events have been evaluated through August 28, 2025, which is the date the financial statements were approved by the Plan Administrator and available to be issued.
