Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of PureCycle Technologies, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C), which comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. Description of Plan:

The following description of the PureCycle Technologies, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan, established on January 1, 2023, is a defined contribution plan covering all employees of PureCycle Technologies, Inc. (the “Company”) and its subsidiary PCT Managed Services, LLC, and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Eligibility

An employee is eligible to participate in the Plan on the first day of the calendar month following the date of hire. There are no exclusions for age or minimum service requirements.

Contributions

Participants may contribute pre-tax compensation to the Plan, as defined by the Plan and subject to certain limitations set by the Internal Revenue Code (“IRC”). The Plan has an automatic enrollment provision providing for a 4% salary deferral, whereby employees must elect out of the Plan if they do not wish to participate. In addition, employees who have attained age 50 by the end of the Plan year may make catch-up contributions up to limits defined by the Internal Revenue Service (“IRS”). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Company makes matching contributions to participants’ accounts. The Company has elected safe harbor provisions. Safe harbor matching contributions are 100% of a participant’s contribution up to 4% of eligible compensation, subject to certain Plan limitations. The Company at its discretion may make an employer nonelective contribution. During 2024, the Company did not make an additional employer nonelective contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, allocations of Company contributions, and participant earnings. Participant earnings are based on an allocation of Plan earnings respective to each participant’s account balances and investment selections. Any related administrative expenses based on participant earnings or account balances are deducted from the participant’s account. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested balance.

Investment Options

Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers a selection of mutual funds and a guaranteed investment contract as investment options for participants.

1. Description of Plan (Continued):

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. Participants are credited with a year of service if 1,000 hours are worked annually.

Participant vesting in employer nonelective contributions are as follows:

<u>Years of Service</u>	<u>Vesting Percentage</u>
Less than 1	0%
1 but less than 2	25%
2 but less than 3	50%
3 but less than 4	75%
4 or more	100%

Participants are immediately vested in employer contributions made under safe harbor provisions plus actual earnings thereon. All employer contributions become fully vested in the event of death, disability, or after reaching normal retirement age while under the Company's employment.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay administrative expenses, reduce employer contributions, or be allocated to eligible participants in the same manner as profit sharing contributions. As of December 31, 2024 and 2023, there were no forfeited non-vested account balances, and the Plan used no forfeited nonvested accounts to reduce employer contributions or pay Plan expenses during 2024.

Notes Receivable from Participants

Although loans are not currently offered in the Plan, any loans transferred into Plan will continue to be administered and repaid through payroll until paid in full. The loans are secured by the balance in participant's account. No new loans can be issued, and no refinances will be allowed.

Payment of Benefits

On termination of service due to death, disability, retirement or other reasons, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in their account in accordance with Plan provisions. Additionally, hardship withdrawals and certain other in-service withdrawals are also permitted by the Plan if certain criteria are met.

Account balances that are under \$5,000 may be automatically distributed upon termination of service as a lump sum without the consent of the participant.

1. Description of Plan (Continued):

Administrative Expenses

In accordance with Plan provisions, the Company or the Plan may pay administrative expenses of the Plan. Recordkeeping and other administrative services expenses are paid by the Plan and allocated to participant accounts. Plan expenses charged for transactions that are participant specific are deducted from the respective participant account.

Management fees and operating expenses charged to the Plan for investments in mutual funds and pooled separate accounts are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction in the investment return for such investments.

2. Summary of Accounting Policies:

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (“GAAP”).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are presented at fair value, except fully benefit-responsive investment contracts which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements. Contract value is the relative measurement attribute for that portion of the net assets available for benefits attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Purchases and sales of investments are recorded on a trade-date basis. Dividend income is recorded on the ex-dividend date. Interest income is recorded as earned on the accrual basis. Net appreciation (or depreciation) includes the Plan’s gains and losses on investments bought and sold as well as held during the year. Realized gains and losses on the sales of securities are reported on the average cost method.

Payment of Benefits

Benefits are recorded when paid.

2. Summary of Accounting Policies (Continued):

Notes Receivable from Participants

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Delinquent notes receivable from participants are reclassified as distributed based upon the terms of the Plan document.

Risks and Uncertainties

The Plan invests in a combination of investment securities which are exposed to various risks, such as interest rates, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances, and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

3. Fair Value Measurements:

Financial Accounting Standards Board, Statement of Accounting Standards Codification Topic 820 ("ASC 820") establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

Level 1: Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

Level 2: Quoted prices in markets that are not considered to be active or financial instruments for which all significant inputs are observable, either directly or indirectly.

Level 3: Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

In many cases, a valuation technique used to measure fair value includes inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy. The following descriptions of the valuation methods and assumptions used by the Plan to estimate the fair values of investments apply to investments held directly by the Plan.

Mutual funds: The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

4. Investment Contract with Insurance Company:

The Plan invests in a fixed account group annuity contract with Great-West Life & Annuity Insurance Company (“GWI”), which is a fully benefit-responsive investment contract. GWI maintains the contributions in a general account. The account is credited with contributions and earnings on the underlying investments and charged for participant withdrawals and administrative expenses.

The guaranteed investment contract issuer is contractually obligated to repay the principal and a guaranteed minimum interest rate of 0.10% to the Plan.

The guaranteed investment contract is fully benefit-responsive, and as such contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest contract. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Contract value of the guaranteed investment contract was \$500,229 and \$583,344 at December 31, 2024 and 2023, respectively. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Such events include but may not be limited to the following: 1) complete or partial termination of the Plan, 2) the establishment or activation of, or material change in, any Plan investment fund, or an amendment to the Plan or a change in the administration or operation of the Plan, including offering a competing fund (a fund with similar investment strategies and assets as the investment contract) without the approval of GWI. The guaranteed interest contract permits contract termination with sufficient notice or with other violations of the contractual terms.

5. Information Certified by Custodians:

Investments, except the guaranteed investment contract, included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividend and interest income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Empower Trust Company, LLC, custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

The guaranteed investment contract included in the statements of net assets available for benefits as of December 31, 2024 and 2023, and the dividend and interest income and net appreciation in fair value of investments included in the statement of changes in net assets available for benefits for the year ended December 31, 2024 have been derived from information certified as complete and accurate by Empower Annuity Insurance Company of America, custodian, in accordance with 29 CFR 2520.103-5(c) of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

6. Parties-in-Interest Transactions:

Empower Retirement, LLC is the recordkeeper for the Plan, and Empower Trust Company, LLC (“Empower”) is the custodian and manages the GWI guaranteed investment contract; therefore, transactions involving these parties qualify as party-in-interest transactions permitted under provisions of ERISA. Fees paid to Empower entities, which are subsidiaries of GWI, by the Plan for administrative expenses amounted to \$32,843 for the year ended December 31, 2024. Revenue received on investments managed by Empower related to revenue sharing may be applied to pay Plan expenses or allocated to participant accounts.

ERISA Services, Inc. (“ERISA Services”) is the contract administrator for the Plan. Accordingly, transactions with ERISA Services qualify as party-in-interest transactions. During 2024, the Plan paid ERISA Services \$4,598 for administrative services.

SageView Advisory Group, LLC (“SageView”) provides investment management and advisory services to the Plan. Accordingly, transactions with SageView qualify as party-in-interest transactions. During 2024, the Plan paid SageView \$14,340 for investment management and advisory services.

Included in the Plan assets are notes receivable from participants. At December 31, 2024 and 2023, notes receivable from participants amounted to \$5,843 and \$17,980, respectively. For the year ended December 31, 2024, interest income related to notes receivable from participants amounted to \$480. These transactions qualify as party-in-interest transactions permitted under provisions of ERISA.

7. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, all participants will become 100% vested in their accounts.

8. Tax Status:

The IRS determined and informed the Plan administrator by a letter dated June 1, 2021 that the Plan is designed in accordance with the applicable sections of the IRC and is, therefore, not subject to tax under present income tax law. The Plan is required to operate in conformity with the IRC to maintain its qualification. Management is not aware of any course of action or series of events that have occurred that might adversely affect the Plan's qualified status.

Management has evaluated the Plan's tax positions and concluded that, as of December 31, 2024, the Plan had taken no uncertain tax positions that require recognition of liability (or asset) in the accompanying financial statements. The Plan is not subject to income tax examination by the U.S. federal, state, or local tax authorities for years before 2023, the year the Plan was effective.

9. Subsequent Events:

Management has evaluated subsequent events through September 3, 2025, the date the financial statements were available to be filed, and has determined that there were no material events requiring recognition or disclosure.
