Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

Note 1. Description of the Plan

The following description of Jackson Iron & Metal Company, Inc. Profit Sharing 401(k) Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan, available to all full-time employees of Jackson Iron & Metal Company, Inc. (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"). Members of a collective bargaining unit where retirement benefits were the subject of good faith bargaining and non-resident aliens with no U.S. source income are ineligible to participate in the Plan.

Contributions

Participants may elect to contribute up to the maximum allowable by the Internal Revenue Service ("IRS"). Participants who have attained age 50 before the end of a Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Participants direct the investment of their contributions and employer contributions into various investment options offered by the Plan. The Company may make matching contributions equal to a discretionary percentage. During 2024, the Company elected to make safe harbor matching contributions in an amount equal to 100 percent of the first three percent of a participant's eligible compensation and 50 percent of the next two percent of eligible compensation, with a maximum of four percent of eligible compensation if the participant contributed at least five percent. The Company may also elect to contribute an additional discretionary contribution. No such discretionary contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, allocations of the Company's discretionary contributions and Plan earnings or losses and is charged with an allocation of administrative expenses. Allocations are based on participants' annual compensation or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and Company matching contributions plus actual earnings or losses thereon.

Participant's interest in the Company's discretionary contributions and allocated earnings or losses thereon are vested as follows:

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan terms range from 1 to 5 years or possibly longer if borrowed for the purchase of a primary residence, which is determined at the time of the loan. The loans are secured by the balance in the participant's account and bear interest at a rate of prime plus one percent at inception of the loan. The interest rates on participant loans range from 4.25 to 9.50 percent for the year ended December 31, 2024. Principal and interest is paid ratably through weekly payroll deductions.

Payment of Benefits

Benefits are generally payable on termination, retirement, death, or disability. Benefits may be paid by (a) lump-sum, (b) purchase of a joint and survivor annuity or (c) by any other method requested by the participant and approved by the Company's Board of Directors.

Participants may receive distributions from the Plan prior to their termination of employment under certain conditions. After attaining age 59 ½, participants may elect to receive a pre-retirement distribution for all or a portion of their vested balance. In addition, hardship distributions are also available from elective deferral accounts, subject to regulatory requirements.

Forfeited Accounts

Forfeitures, which generally result from participants withdrawing from the Plan prior to vesting in Company discretionary contributions and earnings or losses thereon, may first be used to pay administrative expenses of the Plan and then to reduce future employer contributions.

There were \$240 and \$0 in forfeited nonvested accounts at December 31, 2024 and 2023, respectively. Forfeitures applied to reduce employer contributions were \$0 for the year ended December 31, 2024.

Note 2. Summary of Accounting Policies

Basis of Presentation

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fixed annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Defaulted notes receivable from participants are recorded as deemed distributions based upon the terms of the Plan document.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Administrative expenses are paid by the Plan. All remaining expenses are paid by the Company. The total administrative expenses charged to the Plan during the year ended December 31, 2024, was \$54,110.

Note 3. Information Certified and Provided by Empower Trust Company, LLC ("Empower") and Empower Annuity Insurance Company of America ("EAICA")

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedule of assets (held at end of year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Empower. The contract value of the fixed annuity contract was certified by EAICA.

Note 4. Fair Value Measurements

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") Topic 820, *Fair Value Measurement* ("ASC 820") establishes a framework for measuring fair value. That framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value on a recurring basis. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded (Level 1).

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Group Annuity Contract with EAICA

The Plan maintains a traditional fully benefit-responsive guaranteed investment contract with EAICA totaling \$281,200 and \$256,825 as of December 31, 2024 and 2023, respectively. EAICA maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than zero percent. The crediting rate is reviewed on a quarterly basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by EAICA, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or depletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA (5) premature termination of the contract.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation (4) a material amendment to the agreement without the consent of the issuer.

Note 6. Related Party and Party-In-Interest Transactions

Certain Plan investments are managed by Empower. Empower is the Custodian of the Plan and, therefore, administrative fees paid to Empower for such services qualify as party-in-interest transactions. These fees paid by the Plan totaled \$54,110 for the year ended December 31, 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the accounts of all participants would become fully vested and the assets of the Plan, after payment of expenses, would be distributed to the participants.

Note 8. Income Tax Status

The IRS issued an opinion letter on the prototype plan document dated March 31, 2014, indicating the Plan, as then designed, was in compliance with applicable requirements of the Internal Revenue Code ("Code"). Although the Plan has been amended from the original prototype document, the Plan administrator believes that the Plan is currently being operated in accordance with the Code and, therefore, believes the Plan is qualified and the related trust is tax-exempt.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 10. Subsequent Events

The Plan has evaluated additional subsequent events through September 5, 2025, the date these financial statements were available to be issued.
