### **Independent Auditor's Report**

#### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Canyon Creek Cabinet Company Retirement Savings Trust [Canyon 401(k) Plan], an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

**NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - ORGANIZATION AND DESCRIPTION OF THE PLAN**

The provisions of Canyon Creek Cabinet Company (“Company”) Retirement Savings Trust (“Plan”) were effective November 1, 1987. The Plan was restated in 1998, when a prototype plan was adopted. The Plan was most recently restated effective January 1, 2022. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

***General -***

The Plan is a defined contribution plan covering all full-time employees of the Company who, prior to January 1, 2020, were 19 years of age and had completed one year of service, as defined by the Plan document.

Effective January 1, 2020, the Plan’s eligibility conditions were modified to change the age to 18 for all contributions and to decrease the level of service requirement to two months for elective deferrals. In addition, the entry date was modified for elective deferrals to the first day of the month coinciding with or next following the date the eligibility requirements are met.

Prior to January 1, 2023, eligibility for the match is one year of service which means completion of 1,000 hours of service. Effective January 1, 2023, eligibility for the match was modified to change the level of service requirement to two months.

Effective January 1, 2023, the entry date for all contributions is the first day of the month coinciding with or next following the date the eligibility requirements are met.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

***Contributions -***

The Plan includes a 401(k) feature whereby eligible employees may contribute a portion of their pre or post tax (effective January 1, 2022) compensation, as defined in the Plan and subject to statutory limitations.

The Plan provides for automatic enrollment of eligible employees at a contribution rate of 4% of eligible compensation unless another rate, including opting out, is elected. Participants may elect to contribute up to 100% of their eligible compensation as defined in the Plan document, within statutory limits. Participants may elect to stop the payroll deductions at any time. Participants may make deferral modifications at any time which become effective on the first day of each Plan year quarter. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

## **NOTE 1 - continued:**

The Company may make discretionary matching contributions equal to a uniform percentage of a participant's salary deferrals or a discretionary dollar amount. Prior to October 1, 2023, the Company matched \$.50 for each \$1.00 the employee contributes up to 5% of their earnings. Effective October 1, 2023, the Company modified the match from 5% to a maximum of 7% of participant's earnings. The Company funds employee and employer matching contributions each pay period.

The Company may also make a discretionary annual profit-sharing contribution which is allocated to all eligible employees based upon their eligible compensation. Profit sharing contributions, if any, are funded in the following Plan year and placed in participant directed investments. There were no profit-sharing contributions to the Plan in 2024 and 2023.

### ***Participant Accounts -***

Individual participant accounts are maintained by The Standard Insurance Company (The Standard), the Plan's third-party administrator. Each participant's account is credited or charged with the participant's contributions, allocations of the Company's contributions, if any, allocation of investment earnings and losses on individual account balances, and certain administrative expenses. Allocations are based on participant compensation or account balances as defined in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Investment options -***

Participants direct employee and employer contributions among mutual funds and one stable asset fund held by Reliance Trust Company ("Reliance"), the Plan's custodian.

### ***Vesting -***

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the employer contributions (match and profit-sharing) is in accordance with the following schedule: 20% after two years of service, 40% after three years of service, 60% after four years of service and 100% after five years of service. Participants become fully vested upon retirement, death, or total and permanent disability.

### ***Notes receivable from participants -***

The Plan allows participants to borrow from their account a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance. Terms of the notes receivable may not exceed five years, except for the purchase of a primary residence. The notes receivable are secured by the balance in the participant's account and bear interest at 1% above the prime rate at the time of the loan commitment. Interest rates range from 4.25% to 9.5% at December 31, 2024. Principal and interest are paid ratably through payroll deductions. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

**NOTE 1 - continued:**

***Payment of benefits -***

Benefits may be distributed upon retirement, death, disability, hardship or termination of employment. Benefits equal to the value of the participant's vested account may be paid in a lump sum or in installments, depending on certain factors as described in the Plan document and at the participant's election. Upon reaching 59 ½, and under certain hardship circumstances, participants may request a lump-sum distribution of their vested account balances prior to retirement.

***Forfeited accounts -***

Upon termination, participants' non-vested account balances are forfeited. Forfeitures from non-vested accounts may be used to pay Plan expenses or reduce employer contributions, if any. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$26,468 and \$9,021, respectively. During 2024 and 2023, forfeitures of \$28,346 and \$17,036, respectively, were used to pay Plan administrative fees.

***Administrative fees -***

Mutual fund expenses, including 12(b)1 revenue sharing fees, are deducted from each fund's earnings to arrive at net appreciation (depreciation) as reported in the accompanying statement of changes in net assets available for benefits. Revenue sharing fees are collected by The Standard and its affiliates and are used to offset Plan administrative fees charged by The Standard. The amount of any excess compensation received over and above that used to offset fees charged by The Standard is paid to the Plan. There was no excess compensation for the year ended December 31, 2024. Certain other administrative expenses are paid by the Company.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The following are significant accounting policies used by the Plan:

***Basis of accounting -***

The financial statements of the Plan are prepared using the accrual method of accounting.

***Use of estimates -***

The preparation of financial statements in conformity with generally accepted accounting principles in the United States (GAAP) requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

***Valuation of investments and income recognition -***

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or

paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measure for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the plan.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### ***Notes receivable from participants -***

Notes receivable from participants are measured at their unpaid principal balances. Delinquent participant loans that are deemed to be in default based upon the terms of the Plan document are reclassified as distributions.

### ***Payments of benefits -***

Benefits are recorded as paid.

## **NOTE 3 - FAIR VALUE OF INVESTMENTS**

Fair value is a market-based measurement determined based on assumptions that market participants would use in pricing an asset or liability. There are three levels, which prioritize the inputs used in measuring fair value as follows:

- Level 1: Observable market inputs such as quoted prices (unadjusted) in active markets for identical assets or liabilities,
- Level 2: Observable market inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs where there is little or no market data, which require the reporting entity to develop its own assumptions.

The inputs or methodology used for valuing investments is not necessarily an indication of the risk associated with investing in those securities.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**NOTE 4 - STABLE ASSET FUND**

Effective July 17, 2012, the Plan entered into a fully benefit-responsive guaranteed investment contract with The Standard. The Standard maintains the contributions in a general account that is part of the general corporate assets of The Standard. The account is credited with earnings based on a rate declared by The Standard each quarter and charged for participant withdrawals and administrative expenses. The Standard has a general liability to participants for the balance in the general account. The Standard also guarantees a minimum interest rate of 1%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by The Standard, represents contributions made under the contract, plus earnings less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of The Standard. The contract value of the investment contract at December 31, 2024 and 2023, was \$836,469 and \$692,857, respectively. On a quarterly basis, The Standard declares a crediting rate for assets in the general account based on the underlying investments of The Standard. The crediting rate for the investment contract at December 31, 2024 and 2023 was 3.04% and 2.78%, respectively.

Certain events may limit the ability of the Plan to transact at contract value with The Standard. Such events include termination of the contract, spin-offs, divestitures, layoffs, corporate relocation, partial or total plan termination, retirement incentive programs, and the liberalization of plan withdrawal or transfer rules. Upon occurrence of any of these events, a payout adjustment may apply. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are not probable of occurring.

The guaranteed investment contract does not permit The Standard to terminate the agreement prior to scheduled maturity date.

## **NOTE 5 - INFORMATION CERTIFIED BY CUSTODIAN**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, the custodian of the Plan's investments, has certified that the following data included in the accompanying financial statements, notes and supplemental schedule is complete and accurate.

- 1) Fair value of mutual funds as of December 31, 2024 and 2023.
- 2) The contract value of the stable asset fund as of December 31, 2024 and 2023.
- 3) Net appreciation in fair value of mutual funds for the year ended December 31, 2024.
- 4) Interest and dividends for the year ended December 31, 2024.

## **NOTE 6 - RELATED PARTY TRANSACTIONS**

Reliance Trust Company is the custodian of the Plan's investments; therefore, transactions with Reliance qualify as party-in-interest transactions. The Standard is the third-party administrator and co-fiduciary of the Plan and contracts with Reliance for custodial services. For the year ended December 31, 2024, the Plan paid fees of \$45,629 to The Standard and its affiliates for administration and custodial services. In addition, transactions involving the guaranteed investment contract with The Standard qualify as party-in-interest transactions.

## **NOTE 7 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

## **NOTE 8 - TAX STATUS**

The Plan trustees adopted a non-standardized pre-approved plan. The Internal Revenue Service (IRS) has determined and informed the pre-approved plan by a letter dated June 30, 2020, that the Plan is designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **NOTE 9 - RISK AND UNCERTAINTIES**

The Plan allows participants to invest in investment securities which are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with the investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

## **NOTE 10 - SUBSEQUENT EVENTS**

The date to which events occurring after December 31, 2024, have been evaluated for possible adjustment to the financial statements or disclosure therein is September 2, 2025, which is the date on which the financial statements were available to be issued.
