NOTE – A: DESCRIPTION OF THE PLAN

The following description of the Donelan's Savings & Investment Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General: The Plan is a defined contribution plan established to provide employees of Donelan's Supermarkets, Inc. (the Company), with retirement benefits in accordance with Sections 401(a) and 401(k) of the Internal Revenue Code (IRC). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Empower Trust Company, LLC and Empower Annuity Insurance Company of America serve as Trustees and record keepers for the Plan.

Effective July 23, 2024, the Plan was amended and restated to accommodate the employees of an organization that was purchased by the Company. Plan amendments included amending eligibility to allow for participation by the acquired organization's employees. Additionally, the Plan has been amended to allow years of service performed for the acquired organization to count toward the vesting requirements of the Plan.

Eligibility: All Company employees are eligible to participate in the Plan if they have completed one year of service and have attained the age of 21. Participants enter the Plan on the first day of the month coincident with or next following the date on which age and service requirements are met.

Participant Contributions: Eligible participants may make voluntary pre-tax contributions in a percentage or fixed dollar amount up to 100% of their eligible compensation, as defined by the Plan, not to exceed the limits of the IRC (\$23,000 in 2024). Participants may also contribute amounts representing distributions from other tax-qualified plans. Further, participants who are 50 years of age or older as of December 31, 2024, may contribute an additional "catch up" contribution (\$7,500 in 2024). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan offers various mutual funds, common collective trust funds and a guaranteed investment account as investment options for participants.

The Plan also allows participants to defer funds as a "Roth 401(k) deferral." These deferrals are subject to federal and state income taxes and the maximum allowable contribution is \$23,000 combined between Roth and pre-tax deferrals.

Employer Contributions: The Company may make matching contributions on behalf of active participants at the discretion of the Board of Directors. For the year ended December 31, 2024 the Board approved matching contribution was 15% of the first 5% of the participants' contribution, not to exceed \$2,000 per participant. Additionally, participants who have completed 1,000 hours of service and who are employed on the last day of the plan year are eligible to share in the Company's discretionary non-elective contributions. The Company did not make any discretionary non-elective contributions during the year ended December 31, 2024.

Participant Accounts: Each participant's account is credited with the participant's contribution and allocations of the Company's contributions and Plan earnings or losses.

NOTE – A: DESCRIPTION OF THE PLAN (Continued)

Vesting: Participants are vested immediately in their contributions plus actual earnings thereon. The Company's discretionary matching and non-elective contributions and actual earnings thereon vest based on the participant's years of service, as defined by the plan document. Vesting occurs at the rate of 20% per year after two years of service, with full vesting after six years of credited service.

Forfeited Accounts: Forfeitures are retained in the Plan and are used to offset employer contributions or certain qualifying expenses incurred by the Plan. During the year ended December 31, 2024, forfeitures totaling \$923 were used to reduce the Company's matching contributions. For the years ended December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,047 and \$891, respectively and are included in investments on the accompanying statements of net assets available for benefits.

Payment of Benefits: Upon termination of employment, retirement, death or disability, a participant will receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. Further, withdrawals from the Plan before leaving the Company are available for certain "hardship" reasons, after attaining the age of 59.5 or after attaining the age of 55 and having accumulated 6 years of credited service, as defined by the Plan. Distributions from rollover source funds are available to participants of the Plan at any time. Benefits are recorded when paid.

Notes Receivable from Participants: Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of \$50,000 or 50% of their vested interest in the Plan, whichever is less. The loans are secured by the balance in the participant's account and bear interest at 1% plus the prime rate as published in the Wall Street Journal on the first business day of the month in which the loan originated. Loan terms range from one to five years. However, if the loan is to acquire the principal residence of the participant, the term may be extended to 15 years. Principal and interest are paid ratably through payroll deductions.

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Other Income: The Plan includes a recordkeeping expense account, under which certain mutual fund expenses that are charged by the mutual fund companies to the individual participants are recaptured by the Plan and held in a guaranteed investment account. These funds are then used to pay for expenses of the Plan that benefit the Plan's participants as approved by the IRC, Department of Labor and ERISA. During the year ended December 31, 2024 these funds totaled \$3,916, and are included in other income on the accompanying statement of changes in net assets available for benefits. As of December 31, 2024 and 2023, the balance in the recordkeeping expense account totaled \$1,368 and \$1,387, respectively.

NOTE – B: SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting/Presentation: The accompanying financial statements have been prepared on the accrual basis of accounting. The financial statements and notes are representations of management who is responsible for their integrity and objectivity. These accounting policies conform to accounting principles generally accepted in the United States of America and have been consistently applied in the preparation of the financial statements.

Investment Value and Income Recognition: The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisor and trustees. See Note C for a discussion of fair value measurements.

Realized gains and losses on investments sold and the unrealized appreciation and depreciation of investments held are reported on an average current cost basis, based on fair market value of the investments at the beginning of the period or at the time of purchase during the period.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The net appreciation includes realized and unrealized gains and losses on the fair value of investments held by the Plan.

Expenses: Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment-related expenses are included in either net appreciation in fair value of investments or administrative expenses. The Plan sponsor has elected to absorb significant administrative costs of the Plan.

Use of Estimates: Management uses estimates and assumptions in preparing financial statements. Those estimates and assumptions affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities, and reported revenues and expenses. Accordingly, actual results could differ from those estimates, and such differences may be material.

NOTE – C: FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels:

Level 1 – inputs consist of unadjusted quoted prices in active markets for identical assets or liabilities.

Level 2 – inputs consist of observable inputs other than quoted prices for identical assets, such as quoted prices for similar assets or liabilities, quoted prices in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

Level 3 – unobservable inputs that are significant to the fair value measurement.

NOTE – C: FAIR VALUE MEASUREMENTS (Continued)

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 and Level 3 inputs are only used when higher level inputs are not available. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of input that is significant to the fair value measurement. There have been no changes in the methodologies used at December 31, 2024 and 2023.

NOTE – C: FAIR VALUE MEASUREMENTS (Continued)

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Guaranteed investment account: Valued using a discounted cash flow valuation methodology where the interest rate is reset on at least an annual basis and the discount rate is a risk based market rate.

Common/collective trust fund: Valued at the NAV per unit based on the underlying assets. The NAV, as provided by the trustees, is used as a practical expedient to estimate fair values. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

NOTE – D: PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of the ERISA. In the event of Plan termination, participants will become 100% vested in their accounts, any unallocated assets of the Plan would be allocated to participant accounts and account balances will be distributed in full to participants.

NOTE – E: TAX STATUS

The Plan operates under a pre-approved plan which has received a favorable opinion letter from the Internal Revenue Service dated November 14, 2022, indicating that the pre-approved plan, as then designed was in compliance with the applicable requirements of the IRC.

NOTE – E: TAX STATUS (Continued)

The Plan has been amended and restated since receiving the opinion letter. However, plan management believes and represents that the Plan is designed and is being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. Plan management has evaluated the tax positions taken or expected to be taken and has concluded that as of both December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

NOTE – F: INFORMATION CERTIFIED BY THE PLAN TRUSTEE (UNAUDITED)

The following information included in the accompanying financial statements and supplemental schedule was obtained or derived from data that has been prepared by the trustees, Empower Trust Company, LLC and Empower Annuity Insurance Company of America. Plan management has obtained a certification from the trustees as of December 31, 2024 and 2023 and for the year ended December 31, 2024, that such information is complete and accurate.

NOTE – G: RELATED PARTIES AND PARTIES IN INTEREST

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Certain plan investments are mutual funds and a guaranteed investment account managed by Empower Retirement LLC, a subsidiary of the Plan's trustee and therefore these transactions qualify as party-in-interest transactions, which are exempt from the prohibited transactions rules, as defined by ERISA. Notes receivable from participants also qualify as party-in-interest transactions that are exempt from the prohibited transactions rules, as defined by ERISA.

NOTE – H: RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE – I: CONCENTRATIONS

At December 31, 2024, four investments accounted for 58% of the Plan's total investments. At December 31, 2023, three investments accounted for 44% of the Plan's total investments.

NOTE – J: SUBSEQUENT EVENTS

Management has evaluated subsequent events through August 13, 2025, which is the date the accompanying financial statements were available to be issued.
