Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

These additional procedures included comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with US GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

NOTE 1 - PLAN DESCRIPTION

The following brief description of the U.S. Digital Corp. Profit Sharing Retirement Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

The Plan was adopted on July 1, 1997 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended. The trustees of the Plan are responsible for oversight of the Plan. The Plan's recordkeeper is Standard Insurance Company ("The Standard") and the Plan has adopted The Standard's Volume Submitter Plan Document.

General

The Plan is a defined contribution retirement plan maintained for the benefit of all eligible employees of U.S. Digital Corporation (the "Company"). Employees are eligible to make elective deferrals of a portion of their compensation and receive employer matching contributions after completion of two consecutive months of service and the attainment of age 21. Employees also become eligible for a profit-sharing contribution after completing one year of service with the Company.

Plan Amendments

There were no plan amendments in the current year.

Contributions

Employees may voluntarily contribute up to 100% of their eligible compensation limited to the maximum annual 401(k) deferral prescribed by the Internal Revenue Code ("IRC"). The maximum annual deferral for 2024 was \$23,000. Participants age 50 and over were eligible to make additional catchup contributions of up to \$7,500 in 2024. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollovers). Participants are permitted to make contributions on a before-tax or after-tax basis.

Any deferrals in excess of applicable Internal Revenue Service ("IRS") limits are distributed to the participants in accordance with the terms of the Plan and are included in "excess contributions" in the statements of net assets available for benefits, and "participants contributions" in the statement of changes in net assets available for benefits.

The Company may make discretionary matching contributions to the Plan. During the year ended December 31, 2024, the Company matched 100% of eligible employee salary deferral contributions made during a payroll period up to 5% of each employee's eligible compensation for that payroll period.

Additional employer profit-sharing contributions may be contributed to the Plan at the discretion of the Company. Profit-sharing contributions are allocated to participants' accounts in the same proportion that each participant's compensation plus compensation in excess of the Social Security taxable wage base ("Excess Compensation") bears to the total compensation plus Excess Compensation of all eligible participants.

The maximum amount which can be allocated to a participant in this step is 5.7% of compensation plus Excess Compensation. If after the first step of the allocation process, there still remains a portion of the contribution that has not yet been allocated, the remainder will be allocated to the participants in the same proportion that each participant's compensation bears to the total compensation of all participants. The Company did not elect to make additional profit-sharing contributions to the Plan for the year ended December 31, 2024.

Vesting

Participants are immediately vested in their elective contributions plus actual earnings thereon. Participants are vested in employer contributions plus actual earnings thereon at a rate of 20% after one year of credited service and 20% per year of credited service thereafter. A participant is fully vested after five years of credited service, or upon death, disability, or normal retirement age.

Participant Accounts

A separate account is maintained for each participant which is credited with the participant's contributions, allocations of employer contributions, and an allocation of plan earnings. Allocations of plan earnings is based upon participants' account balances. Allocations of matching contributions is based on participants' elective deferral contributions. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participants direct the investment of their contributions and the employer contributions into various investment options offered by the Plan. The investment options comprise a cross-section of equity, bond and balanced mutual funds, and a stable value fund. Participants may change their investment options daily.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to the lesser of \$50,000 or 50% of their vested account balance, reduced by their highest outstanding loan balance during the 12-month period prior to the date of the loan. The loans are secured by the vested balance in the participant's account or the participant's personal residence and bear interest at a rate equal to the prime rate at the time the loan is issued, plus 1%.

Interest rates range from 3.25% to 5.50% on loans outstanding at December 31, 2024 and 2023. Participants are allowed one loan in any consecutive 12-month period. Loans are only permitted for the purchase of a primary residence, with loan repayment terms of up to 30 years. Principal and interest payments are collected through bi-weekly payroll deductions.

Benefits Paid to Participants

On attainment of age 59½, termination of service, retirement, death, or disability, a participant with a vested account balance of \$1,000 or more may generally elect to receive a lump-sum amount equal to the entire vested account balance, substantially equal periodic installments of the vested account balance, partial withdrawal of no less than \$1,000, or retain their vested interest in the Plan. Participants with a vested account balance less than \$1,000 will receive a lump-sum distribution. Per Setting Every Community Up for Retirement Enhancement Act 2.0, the age at which owners of retirement accounts must start taking required minimum distributions ("RMDs") increased to 73, starting January 1, 2023.

Forfeited Accounts

Forfeitures of terminated participants' nonvested accounts will first be used to restore past forfeitures, and then pay administrative expenses of the Plan, and lastly to reduce employer contributions. During plan year ended December 31, 2024, forfeitures of \$37,753 were used to pay administrative expenses. The forfeiture non-vested balance as of December 31, 2024 and 2023, were \$1,966 and \$34,314, respectively.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value, with the exception of the Plan's interest in a fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividend income is accrued as earned. Net appreciation or depreciation in fair value is the net gain or loss on disposition of investments plus the net unrealized increase or decrease in fair value during the year of investments held at year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan's Administrator deems the participant to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Contributions

Employer and participant contributions are accrued by the Plan in the year in which they are withheld from compensation or become obligations of the Company. Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability, with a corresponding reduction to contributions. There were no 2024 excess contributions.

Administrative Expenses

Administrative expenses may be paid by the Company. Expenses not paid by the Company are deducted from investment earnings before allocation to participants' accounts. Expenses of loan administration, distributions, and transfers are allocated solely to that participant's account. In addition, certain expenses of plan administration, including computer services, professional fees, office supplies and payroll expenses of administrative and clerical personnel, are provided by the Company without charge to the Plan.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("U.S. GAAP") and the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of plan assets and liabilities, additions and deductions during the reporting period, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results may differ from those estimates.

NOTE 3 - CERTIFIED INFORMATION

The Plan Administrator elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Under this provision of ERISA, investment information and related activity certified as accurate and complete by a qualified institution need not be subjected to independent audit. The Plan Administrator has obtained certifications from Charles Schwab Trust Bank, as custodian of the Plan, that the following information included in the Plan's financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Plan transactions related to investment income, securities transactions and interest income on notes receivable from participants for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

NOTE 4 - FAIR VALUE MEASUREMENTS

The Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements).

The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 5 - GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan provides a stable value investment option issued by The Standard through the Standard Stable Asset Fund that simulates the performance of a guaranteed investment contract. The contributions are maintained in a general account, which is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is declared quarterly and cannot be less than 1.0%.

Certain events may limit the ability of the Plan to transact at contract value with the issuer. Examples of such events include withdrawals prompted by certain events (e.g., spin-offs, divestitures, corporate relocations, layoffs, retirement incentive programs, partial or total plan terminations, or the liberalization of plan withdrawal or transfer rules). The Plan Administrator does not believe that any events which would limit the Plan’s ability to transact at contract value with participants are probable of occurring.

NOTE 6 - INCOME TAX STATUS

The Plan document is a volume submitter defined contribution plan sponsored by Standard Retirement Services Inc. In an opinion letter dated June 30, 2020, the IRS stated that the volume submitter plan, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since receiving the opinion letter, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 7 - PARTY-IN-INTEREST TRANSACTIONS

The Plan's stable assets investment is in a stable value investment option issued by The Standard. The Standard is the recordkeeper for the Plan, therefore these transactions qualify as party-in-interest transactions. Notes receivable from participants are also considered party-in-interest transactions.

NOTE 8 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event that the Plan is terminated, all participants will become fully vested in employer contributions allocated to their account.

NOTE 9 - RISKS AND UNCERTAINTIES

The Plan provides for investment options that are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits and therefore participants' account balances.

NOTE 10 - SUBSEQUENT EVENTS

Management has evaluated subsequent events through September 3, 2025, which is the date the financial statements were available to be issued. There were no identified events that require consideration for adjustment to, or disclosure in the financial statements.
