INDEPENDENT AUDITOR'S REPORT

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Sterling Ridge Orthopaedics 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. NOTE A - DESCRIPTION OF THE PLAN

The following description of the Sterling Ridge Orthopaedics 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

1. General

The Plan is a defined contribution plan established by Sterling Ridge Orthopaedics & Sports Medicine, PLLC (the “Employer”) under the provisions of Section 401(a) of the Internal Revenue Code (“IRC”) and is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). The Plan provides for a qualified cash or deferred arrangement as described in Section 401(k) of the IRC, for the benefit of eligible employees of the Employer. The plan administrator, appointed by the Employer, is responsible for the oversight of the Plan. The 401(k) Plan Committee determines the appropriateness of the Plan’s investment offerings and monitors investment performance. Charles Schwab Trust Bank (the “Custodian”) and Matrix Trust Company (the “Sub-custodian”) are responsible for the custody and management of the Plan’s assets. Effective January 1, 2024, Ascensus, LLC (the “Recordkeeper”), became the authorized agent for the Custodian and Sub-custodian and took over recordkeeping responsibilities on April 18, 2024. Prior to April 18 2024, the Custodian utilized TD Ameritrade Trust Company (the “Prior Recordkeeper”) for recordkeeping purposes. The change in recordkeeper initiated a black-out period from April 15, 2024 through April 22, 2024, during which time no transactions were processed.

2. Eligibility

All non-union and non-leased employees who are U.S. residents may participate in the Plan upon three months of employment with the Employer and attainment of age 18, prior to the entry dates on the first day of each quarter. Eligible participants may receive an Employer discretionary matching contribution or Employer non-elective safe harbor contribution. In addition, eligible participants may also receive an Employer discretionary profit-sharing contribution upon one year of service.

3. Contributions

Participants may elect to contribute, on a tax-deferred basis or Roth 401(k), compensation up to the maximum amount of the IRC limitation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may direct contributions, as desired, in any of several investments offered by the Custodian or Sub-custodian and may change their investment options daily. In addition, the Employer may make a non-elective safe harbor contribution equal to 3% of the participant’s wages.

The Employer may also make discretionary matching and/or profit-sharing contributions for each active and eligible participant, in an amount determined annually by the Employer.

4. Participant Accounts

Each participant's account is credited with the participant's contributions and the Employer's non-elective safe harbor contribution and discretionary matching contributions, as well as allocations of the Employer's discretionary profit-sharing contribution, if applicable, and Plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

5. Vesting

Employee contributions, Employer nonelective safe-harbor contributions, Employer qualified nonelective contributions, rollovers and actual earnings on all such contributions are fully vested at all times. Vesting of Employer discretionary matching contributions, Employer discretionary profit-sharing and actual earnings thereon, are based upon the participant's years of service with the Employer as follows:

6. Benefit Payments

Effective January 1, 2023, the Plan was amended to allow rollover balances to be included in the vested balance for determining the automatic disbursement threshold. In addition, if the vested account balance is less than \$5,000, a lump sum will be distributed directly to an individual retirement account unless the participant elects otherwise (see Note I). For balances greater than \$5,000, the participant is entitled to a lump sum amount. In the event of death or total and permanent disability, a participant's beneficiary or the participant is entitled to the total value of the participant's account. In addition, upon attaining age 59½, participants may receive distributions. Hardship withdrawals are also permitted if certain criteria are met.

7. Administrative Expenses

Certain expenses of maintaining the Plan are paid from the assets of the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Investment related expenses are included in the net appreciation in fair value of investments.

8. Forfeitures

Forfeitures of terminated participants' nonvested accounts will first be applied to reinstate separated participants, then to pay plan expenses, and then to reduce Employer contributions. During the year ended December 31, 2024, \$7,229 of forfeitures was applied against Employer contributions. As of December 31, 2024 and 2023, there was \$53,787 and \$65,072, respectively, of unallocated forfeitures included in net assets available for benefits.

9. Plan Amendments and Termination

Although it has not expressed such intent, the Employer, by action of its Board of Directors, reserves the right, at any time, to amend or terminate the Plan. Upon termination of the Plan, further contributions to the Plan shall cease and all participants who are affected by such termination shall become 100% vested. Net assets available for benefits would be distributed to the participants based on each participant's interest in the Plan.

NOTE B - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

1. Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

2. Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

3. Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's management determines the Plan's valuation policies utilizing information provided by the Custodian. See Note D for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

4. Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Internal Revenue Service (“IRS”) are recorded as a liability with a corresponding increase to deductions from net assets.

5. Benefit Payments

Benefits are recorded when paid.

6. Subsequent Events

Plan management has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued.

NOTE C - CERTIFICATION BY RECORDKEEPER AND SUB-CUSTODIAN

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, all of the investment information, including investment income, included in the accompanying financial statements and supplemental schedule has been certified as complete and accurate by the Recordkeeper, as authorized agent for the Custodian and Sub-custodian of the Plan.

NOTE D - FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets
- quoted prices for identical or similar assets or liabilities in inactive markets
- inputs other than quoted prices that are observable for the asset or liability
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest bearing cash account: Valued at cost which is determined to equal fair value.

Exchange traded funds: Valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The exchange traded funds held by the Plan are deemed to be actively traded.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Unitized managed accounts: Valued at net participants interest of the net asset value of multiple securities reported daily as a single unit value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different value measurement at the reporting date.

NOTE E - RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Custodian, Sub-custodian, Recordkeeper, and Prior Recordkeeper are parties-in-interest with respect to the Plan. Investments are held with and managed by the Sub-custodian. Fees incurred by the Plan for the investment management services are included in net appreciation in fair value of the investments, as they are paid through revenue sharing rather than direct payment. Additional fees may be paid directly to the Custodian, Sub-custodian or other parties-in-interest.

NOTE F - INCOME TAX STATUS

The IRS has issued an opinion letter to the entity acquired by the parent company of the Custodian dated June 30, 2020, that the non-standardize pre-approved plan and related trust are designed in accordance with applicable sections of the IRC. Although the Plan did not seek a favorable determination letter with respect to the initial adoption of the plan document, nor with any plan amendments, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expect to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE G - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
