Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees' ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees (the “Plan”) is provided for general informational purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General: The Plan was established by Lamb Weston, Inc. (the “Company” or “Plan Sponsor”) effective September 25, 2017 (the “Effective Date”), and is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is generally available to salaried and hourly non-exempt employees immediately upon hire. Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily. Effective in June 2018, the Plan was amended to include eligible employees of Lamb Weston Sales, Inc. and Puerto Rico. Responsibility for administration of the Plan has been delegated to the Employee Benefits Administrative Committee (the “Committee”). Responsibility for oversight of Plan investments has been delegated to the Employee Benefits Investment Committee (the “EBIC”). The EBIC determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions: The Plan allows participants to contribute an amount up to Plan-specified maximum percentages, subject to Internal Revenue Code (“IRC”) limitations, of their annual compensation through compensation deferrals, in addition to catch-up deferrals up to Plan-specified maximum percentages, subject to IRC limitations, for participants who are at least 50 years old by the end of the applicable plan year. Participants may also contribute amounts representing distributions, or rollovers, from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan allows for a matching contribution equal to 100% of the first 6% of the participant’s eligible compensation that the employee contributes as elective deferrals. The employee must make the elective deferrals in order to receive the matching contribution. The matching contribution is invested into participant-directed investment options.

The Company makes a nonelective profit sharing contribution on behalf of each eligible employee equal to 3% of such eligible employee’s eligible compensation per pay period. During the years ended December 31, 2024 and 2023, the Company made profit sharing contributions to the Plan of approximately \$6,767,000 and \$8,524,000, respectively.

Participant accounts: Each participant’s account is credited with the participant’s contributions and Company contributions, which generally include employer matching contributions and employer non-elective profit-sharing contributions, as well as allocations of Plan earnings, and is charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their compensation deferral contributions, and rollover contributions, if any, and the earnings thereon. Participants become vested in the Company contributions, and the earnings on those amounts, at 20% for each year of credited vesting service, with participants fully vested in those contributions after five years of credited vesting service. If a participant terminates employment due to death or disability, or if a participant attains age 65 while employed with the Company, the participant will be 100% vested in their total account balance.

Notes receivable from participants: Participants are allowed to borrow from the Plan amounts not to exceed the lesser of 50% of the participant's vested account balance or \$50,000. The minimum loan allowed is \$1,000, and loans must be fully paid within five years unless the loan was issued for the purchase of a primary residence, in which case the loan must be fully paid within 10 years.

No more than one loan may be outstanding for a participant at any given time, and loans may not be refinanced. Loans must bear interest at a reasonable rate, determined as of the first of each month. The interest rate charged is the prime rate plus 1% and remains the same for the life of the loan. Principal and interest are paid ratably through payroll deductions. Interest rates ranged from 4.25% to 9.50% at December 31, 2024.

Transfer of assets: Assets are transferred between the Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees and the Lamb Weston, Inc. 401(k) Plan for Plant Hourly Employees based on changes in employees' roles within the Company.

Payment of benefits: Except for certain withdrawal rights under the Plan, distributions of Plan benefits are made commencing no earlier than the participant's retirement, disability, death or termination of employment.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$1,505,000 and \$817,000, respectively. These accounts will be used to restore prior forfeitures, reduce future employer contributions and pay Plan administration expenses. During the years ended December 31, 2024 and 2023, \$1,090,000 and \$440,000, respectively, of forfeited nonvested funds were used to restore prior forfeitures, pay Plan administrative expenses, and/or reduce employer contributions.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, Part IV, Line 4i—Schedule of assets (held at end of year). Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payments of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

New and recently announced laws and regulations: The SECURE Act 2.0 was passed by the US Congress and signed by the President in 2022 and is designed to improve retirement savings and encourage participation in workplace retirement plans. This includes, but is not limited to, expanding access to plans for part-time workers, promoting automatic enrollment in new plans, and increasing the age of required minimum distributions. The Plan is currently reviewing all requirements of the SECURE Act 2.0 and will update the Plan documents as required by December 31, 2026.

Subsequent events: The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Fidelity Management Trust Company (the Trustee)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market mutual funds: Money market funds are valued at cost, which approximates fair value. The goal of the money market fund is to achieve a \$1.00 NAV.

Common/collective trusts: Common/collective trusts are valued at the NAV of units of a bank collective trust. The NAV is provided by the trustee as a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

Party-in-interest transactions include certain of the Plan's investments being managed by the trustee, investment management services provided by Mercer d/b/a Mercer Investments, auditor fees, and legal fees. Total expenses paid for these services were \$371,438, and \$327,079, for the years ended December 31, 2024 and 2023, respectively. These transactions are exempt prohibited transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor, by a favorable determination letter dated March 6, 2019, that the Plan is qualified, and the trust established under the Plan is tax-exempt under the appropriate section(s) of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan and trust are operating in a manner that does not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees' financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees' ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees' ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Notes to Financial Statements

Note 1. Description of the Plan

The following description of Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees (the “Plan”) is provided for general informational purposes only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

General: The Plan was established by Lamb Weston, Inc. (the “Company” or “Plan Sponsor”) effective September 25, 2017 (the “Effective Date”), and is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan is generally available to salaried and hourly non-exempt employees immediately upon hire. Upon enrollment to the Plan, a participant may direct deferrals and employer contributions in any of the funds offered by the Plan. Participants may change their investment options daily. Effective in June 2018, the Plan was amended to include eligible employees of Lamb Weston Sales, Inc. and Puerto Rico. Responsibility for administration of the Plan has been delegated to the Employee Benefits Administrative Committee (the “Committee”). Responsibility for oversight of Plan investments has been delegated to the Employee Benefits Investment Committee (the “EBIC”). The EBIC determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions: The Plan allows participants to contribute an amount up to Plan-specified maximum percentages, subject to Internal Revenue Code (“IRC”) limitations, of their annual compensation through compensation deferrals, in addition to catch-up deferrals up to Plan-specified maximum percentages, subject to IRC limitations, for participants who are at least 50 years old by the end of the applicable plan year. Participants may also contribute amounts representing distributions, or rollovers, from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an auto enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant. The Plan allows for a matching contribution equal to 100% of the first 6% of the participant’s eligible compensation that the employee contributes as elective deferrals. The employee must make the elective deferrals in order to receive the matching contribution. The matching contribution is invested into participant-directed investment options.

The Company makes a nonelective profit sharing contribution on behalf of each eligible employee equal to 3% of such eligible employee’s eligible compensation per pay period. During the years ended December 31, 2024 and 2023, the Company made profit sharing contributions to the Plan of approximately \$6,767,000 and \$8,524,000, respectively.

Participant accounts: Each participant’s account is credited with the participant’s contributions and Company contributions, which generally include employer matching contributions and employer non-elective profit-sharing contributions, as well as allocations of Plan earnings, and is charged with an allocation of certain administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Vesting: Participants are immediately vested in their compensation deferral contributions, and rollover contributions, if any, and the earnings thereon. Participants become vested in the Company contributions, and the earnings on those amounts, at 20% for each year of credited vesting service, with participants fully vested in those contributions after five years of credited vesting service. If a participant terminates employment due to death or disability, or if a participant attains age 65 while employed with the Company, the participant will be 100% vested in their total account balance.

Notes receivable from participants: Participants are allowed to borrow from the Plan amounts not to exceed the lesser of 50% of the participant's vested account balance or \$50,000. The minimum loan allowed is \$1,000, and loans must be fully paid within five years unless the loan was issued for the purchase of a primary residence, in which case the loan must be fully paid within 10 years.

No more than one loan may be outstanding for a participant at any given time, and loans may not be refinanced. Loans must bear interest at a reasonable rate, determined as of the first of each month. The interest rate charged is the prime rate plus 1% and remains the same for the life of the loan. Principal and interest are paid ratably through payroll deductions. Interest rates ranged from 4.25% to 9.50% at December 31, 2024.

Transfer of assets: Assets are transferred between the Lamb Weston, Inc. 401(k) Plan for Salaried and Hourly Employees and the Lamb Weston, Inc. 401(k) Plan for Plant Hourly Employees based on changes in employees' roles within the Company.

Payment of benefits: Except for certain withdrawal rights under the Plan, distributions of Plan benefits are made commencing no earlier than the participant's retirement, disability, death or termination of employment.

Forfeited accounts: At December 31, 2024 and 2023, forfeited nonvested accounts totaled approximately \$1,505,000 and \$817,000, respectively. These accounts will be used to restore prior forfeitures, reduce future employer contributions and pay Plan administration expenses. During the years ended December 31, 2024 and 2023, \$1,090,000 and \$440,000, respectively, of forfeited nonvested funds were used to restore prior forfeitures, pay Plan administrative expenses, and/or reduce employer contributions.

Note 2. Summary of Accounting Policies

Basis of accounting: The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates: The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from those estimates.

Investment valuation and income recognition: Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the trustee. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

Notes receivable from participants: Notes receivable from participants are measured at their unpaid principal balance plus any accrued, but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Notes receivable from participants have been classified as an investment asset for Form 5500 reporting purposes and, accordingly, have been included as an investment in the supplemental schedule, Schedule H, Part IV, Line 4i—Schedule of assets (held at end of year). Delinquent notes receivable are recorded as distributions based upon the terms of the Plan document.

Payments of benefits: Benefits are recorded when paid.

Administrative expenses: Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Certain investment-related expenses are included in the net appreciation in fair value of investments.

New and recently announced laws and regulations: The SECURE Act 2.0 was passed by the US Congress and signed by the President in 2022 and is designed to improve retirement savings and encourage participation in workplace retirement plans. This includes, but is not limited to, expanding access to plans for part-time workers, promoting automatic enrollment in new plans, and increasing the age of required minimum distributions. The Plan is currently reviewing all requirements of the SECURE Act 2.0 and will update the Plan documents as required by December 31, 2026.

Subsequent events: The Plan has evaluated subsequent events through September 4, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by Fidelity Management Trust Company (the Trustee)

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplementary information, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company (the trustee of the Plan).

Note 4. Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board (“FASB”) Accounting Standards Codification (“ASC”) Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following are descriptions of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market mutual funds: Money market funds are valued at cost, which approximates fair value. The goal of the money market fund is to achieve a \$1.00 NAV.

Common/collective trusts: Common/collective trusts are valued at the NAV of units of a bank collective trust. The NAV is provided by the trustee as a readily determinable fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

Mutual funds: Mutual funds are valued at the daily closing price, as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5. Related-Party Transactions and Party-in-Interest Transactions

Party-in-interest transactions include certain of the Plan's investments being managed by the trustee, investment management services provided by Mercer d/b/a Mercer Investments, auditor fees, and legal fees. Total expenses paid for these services were \$371,438, and \$327,079, for the years ended December 31, 2024 and 2023, respectively. These transactions are exempt prohibited transactions.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 7. Tax Status

The Internal Revenue Service ("IRS") has determined and informed the Plan Sponsor, by a favorable determination letter dated March 6, 2019, that the Plan is qualified, and the trust established under the Plan is tax-exempt under the appropriate section(s) of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan and trust are operating in a manner that does not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
