### **Report on the Audit of the Financial Statements**

#### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We were engaged to perform audits of the accompanying financial statements of UMMS Voluntary 403(b) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of UMMS Voluntary 403(b) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

#### ***Disclaimer of Opinion***

We do not express an opinion on the financial statements referred to above of UMMS Voluntary 403(b) Plan. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, we have not been able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on the financial statements.

***Basis for Disclaimer of Opinion***

UMMS Voluntary 403(b) Plan has not maintained sufficient accounting records and supporting documents relating to certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009. Accordingly, we were unable to apply auditing procedures sufficient to determine the extent to which the financial statements referred to above may have been affected by these conditions.

Further, as described in Note 1 to the financial statements, the UMMS Voluntary 403(b) Plan has excluded from investments in the accompanying statements of net assets available for benefits certain annuity contracts and custodial accounts issued to current and former employees prior to January 1, 2009, as permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans*. The investment income and distributions related to such accounts have also been excluded in the accompanying statements of changes in net assets available for benefits. The amount of these excluded annuity contracts and custodial accounts and the related income and distributions are not reasonably determinable. Accounting principles generally accepted in the United States of America require that these accounts and the related income and distributions be included in the financial statements referred to above.

***Responsibilities of Management***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about UMMS Voluntary 403(b) Plan's ability to continue as a going concern for one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

***Auditors' Responsibilities for the Audit of the Financial Statements***

Our responsibility is to conduct audits of UMMS Voluntary 403(b) Plan's financial statements in accordance with auditing standards generally accepted in the United States of America and to issue an auditors' report. However, because of the matters described in the Basis for Disclaimer of Opinion section of our report, we were not able to obtain sufficient appropriate audit evidence to provide a basis for an audit opinion on these financial statements.

We are required to be independent of UMMS Voluntary 403(b) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audit.

***Other Matter***

***Supplemental Schedules Required by ERISA***

The supplemental schedule of assets (held at end of year) and schedule of delinquent participant contributions as of and for the year ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. Because of the significance of the matters described in the Basis for Disclaimer of Opinion section of our report, it is inappropriate to and we do not express an opinion on the supplemental schedules.

**NOTE 1 DESCRIPTION OF PLAN**

The following description of the UMMS Voluntary 403(b) Plan (the Plan) provides only general information. Participants should refer to the Summary Plan Description or the plan document for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

**General**

The Plan covers eligible employees of University of Maryland Medical System Corporation (UMMS), University of Maryland Medical Center (UMMC), Maryland General Hospital, Inc. (dba: University of Maryland Medical Center Midtown Campus), James Lawrence Kernan Hospital, Inc. (dba: University of Maryland Rehabilitation & Orthopaedic Institute), University of Maryland Baltimore Washington Medical System, Inc., Shore Health System, Inc., Chester River Hospital Center, Inc. (dba: University of Maryland Shore Medical Center at Chestertown), Chester River Home Care and Hospice, LLC, University of Maryland St. Joseph Medical Center, LLC, University of Maryland St. Joseph Medical Group, LLC, University of Maryland St. Joseph Orthopaedics, LLC, University of Maryland Medical Regional Professional Services LLC (dba: Towson Sports Medicine), University of Maryland Medical Regional Supplier Services, LLC (dba: University of Maryland St. Joseph Medical Equipment), Civista Medical Center, Inc. (dba: University of Maryland Charles Regional Medical Center), Upper Chesapeake Health System (dba: University of Maryland Upper Chesapeake Health) (Upper Chesapeake Health), Harford Memorial Hospital, Inc., Baltimore Washington Emergency Physicians, Inc., Baltimore Washington Medical Center, Inc. (dba: University of Maryland Baltimore Washington Medical Center) (Baltimore Washington Medical Center (BWMC)), Baltimore Washington Healthcare Services, Inc., and University of Maryland Community Medical Group, Inc., collectively the Corporation. All eligible employees are immediately eligible to participate in the Plan upon hire. Employees who are leased employees, and any person not classified as a common law employee, and directors are excluded from participation in the Plan.

Effective January 1, 2017, the Plan was frozen to new entrants.

Effective January 1, 2018, the Plan was amended to exclude from participation employees of Chester River Home Care and Hospice, LLC (Shore Home Care), Chester River Hospital Center, Inc. (dba: University of Maryland Shore Medical Center at Chestertown) (Shore Medical Center (Chestertown)), and Baltimore Washington Emergency Physicians, Inc., and employees of Baltimore Washington Medical Center, Inc. who affirmatively elected to cease participation in the Plan in exchange for eligibility to participate in the University of Maryland Medical System 403(b) Retirement Savings Plan (BWMC Selectors).

Effective December 31, 2022, participants of BWMC who (a) are participants in the University of Maryland Medical System Corporation Pension Plan (Pension Plan) as of December 31, 2022 and (b) whose accruals under the Pension Plan are frozen as of December 31, 2022 are no longer eligible to participate in the Plan and shall have their accounts merged into the University of Maryland Medical System 403(b) Retirement Savings Plan.

**General (continued)**

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

**Annuity Contracts and Custodial Accounts Excluded From Financial Statements**

After reasonable and good faith efforts, management is unable to obtain sufficient accounting records and supporting documents for certain pre-January 1, 2009, annuity contracts and custodial accounts. As permitted by the Department of Labor's Field Assistance Bulletin No. 2009-02, *Annual Reporting Requirements for 403(b) Plans* (FAB 2009-02), the Plan administrator has elected to exclude these annuity contracts and custodial accounts from the Plan's financial statements. The annuity contracts and custodial accounts were limited to employee contributions held under a voluntary 403(b) plan arrangement prior to January 1, 2009. The investment income and distributions related to these annuity contracts and custodial accounts and the related investments and fair value measurements disclosures cannot be determined for the years ended December 31, 2024 and 2023. The Plan administrator has concluded that the annuity contracts and custodial accounts have met the criteria required under FAB 2009-02 and as such, have been excluded from the Plan's financial statements.

**Contributions**

Participants may elect to defer a percentage (or dollar amount for some participants) of their annual compensation to the Plan provided that the election is (a) an amount greater than \$200 per plan year, (b) does not exceed 80% (100% for employees of Midtown Campus) of the participant's eligible compensation, and (c) does not exceed annual Internal Revenue Service (IRS) limits. Effective January 1, 2024, participants will be allowed to elect to make Roth contributions to the Plan. Participants who have attained the age 50 before the end of the Plan year are eligible to make catch-up contributions up to annual limits set by the IRS. Participants may also contribute amounts representing distributions from other qualified defined contribution plans. In accordance with plan provisions, the Corporation does not make any contributions to the Plan.

**Participant Accounts**

Each participant's account is credited with the participant's contribution, and an allocation of administrative expenses, ERISA spending account participant reimbursements, and plan earnings (losses). Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses and ERISA spending account participant reimbursements are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account. All accounts are participant directed.

**NOTE 1 DESCRIPTION OF PLAN (CONTINUED)**

**Vesting**

Contributions are fully vested at all times and nonforfeitable when such plan contributions are made.

Effective July 29, 2016, BWMC 403(b) Plan employer contributions were transferred into the Plan and are 100% vested.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loans must be repaid in five years unless the proceeds are used to acquire a primary residence, which then must be re-paid in fifteen years. The loans are collateralized by the balance in the participants' account and bear interest at a reasonable rate as determined by the Plan administrator. Loans are repaid directly to the custodian. Loan offset will not occur following termination until the end of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment.

**Payment of Benefits**

Upon termination of service, a participant may elect to receive the value of the vested interest in his or her account in the form of a lump sum distribution, partial distribution, or installments. Participants may elect to receive benefit payments in monthly, quarterly, semi-annual, or annual installments over a fixed period not to exceed the life expectancy of the participant. The Plan allows for in-service distributions if a participant reaches age 59 1/2 and hardship distributions subject to Plan provisions. If a participant terminates employment and the participant's account balance does not exceed \$1,000, the Plan administrator will authorize the benefit payment without the participant's consent. If the balance of the terminated participant's account is between \$1,000 and \$7,000 during the year ended December 31, 2024 and \$5,000 during the year ended December 31, 2023, the Plan Sponsor may authorize that the benefit payment be rolled into an individual retirement account in the participant's name.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan have been prepared on the accrual basis of accounting.

**Use of Estimates in Preparing Financial Statements**

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**NOTE 2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED)**

**Investment Valuation and Income Recognition**

Investments held by the Plan are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Contributions**

Contributions from participants are recorded in the year in which participant compensation is paid.

**Payment of Benefits**

Benefits are recorded when paid.

**Administrative Expenses**

Administrative expenses of the Plan are paid from excess revenue sharing, the forfeitures account, or by charging participants' accounts. Included in administrative expenses are fees paid to investment managers and auditors, as well as for Plan administration. Expenses related to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. The Plan received \$155,560 and \$643,979 of ERISA spending account revenue, for which \$40,294 and \$151,618 was used to pay plan expenses, and \$0 and \$517,048 was allocated to participants during the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the ERISA spending account totaled \$643,442 and \$510,057, respectively.

**Subsequent Events**

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued.

**NOTE 3 CERTIFIED INVESTMENTS**

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company, Empower Trust Company, LLC, and Prudential Bank & Trust, F.S.B., the qualified institutions of the Plan. Empower Annuity Insurance Company was the qualified institution as of and for the years ended December 31, 2024 and 2023, Prudential Bank & Trust, F.S.B. was the qualified institution for the period January 1, 2023 to March 31, 2023, and Empower Trust Company, LLC was the qualified institution as of December 31, 2024 and 2023, for the year ended December 31, 2024, and for the period April 1, 2023 to December 31, 2023.

**NOTE 4 FAIR VALUE MEASUREMENT**

The framework for measuring fair value establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

*Level 1* – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

*Level 2* – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

**NOTE 4 FAIR VALUE MEASUREMENT (CONTINUED)**

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023 except for the pooled separate account. Management re-assessed the valuation method based on new information available and determined the pooled separate account should be reported as a level 2 investment in the fair value hierarchy.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Self-Directed Brokerage Account:* Self-directed brokerage accounts consist of mutual funds and cash. See above for the valuation methodology for mutual funds. Cash is valued at a stable \$1.00 NAV, which is based on the fair value of the underlying investments and considered a level 2 investment.

*Pooled Separate Account:* Valued at NAV of shares, which are valued daily by the qualified institution at accumulation unit value based on the estimated value of the underlying investments, held by the Plan at year-end. The account publishes their daily NAV and transacts at that price.

**NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY**

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company. Empower Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.0%, nor greater than 3%. The crediting rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the plan. Contract value, as reported to the Plan by Empower Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption under ERISA, or (5) premature termination of the contract. The Plan administrator believes that any events that would limit the Plan's ability to transact at contract value with participants are probable of not occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include: (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, and (4) a material amendment to the agreement without the consent of the issuer.

**NOTE 6 PLAN TERMINATION**

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will receive distributions of their vested accounts in accordance with Plan terms and IRS requirements.

**NOTE 7 RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are units of a fully benefit responsive investment contract and a pooled separate account managed by the qualified institutions as of December 31, 2024 and 2023. These investments, including any interest and dividends, qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

**NOTE 8 TAX STATUS**

The Plan has been designed to qualify under Section 403(b) of the Internal Revenue Code. UMMS continues to evaluate whether or not it will file for a determination letter pursuant to the IRS's determination letter program for 403(b) plans. The Plan is required to operate in conformity with the Code to maintain its qualification under Section 403(b). The plan administrator believes that the Plan is operating in accordance with the applicable requirements of Section 403(b) of the Code and, therefore, believes the Plan is qualified and the related custodial accounts and tax-deferred annuities are tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to certain laws and regulations including those set forth by the U.S. Department of Labor. The Plan is subject to routine audits by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**NOTE 9 RISK AND UNCERTAINTIES**

The Plan invests in various investment securities, which are exposed to various risks such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**NOTE 10 NONEXEMPT TRANSACTION**

The Corporation failed to remit employee deferrals for one participants within the time frame prescribed by the Department of Labor for the year ended December 31, 2024. These are deemed prohibited transactions in accordance with ERISA and the Code. The Corporation corrected the prohibited transaction by depositing lost earnings in accordance with the principles outlined in the DOL's voluntary fiduciary compliance program.
