Report on the Audit of the Financial Statements

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Shore Health System, Inc. 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Shore Health System, Inc. 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Shore Health System, Inc. 401(k) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. NOTE 1 DESCRIPTION OF PLAN

The following description of the Shore Health System, Inc. 401(k) Plan (the Plan) provides general information about the Plan's provisions. Shore Health System, Inc. is the plan sponsor. Participants should refer to the summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution profit sharing plan established October 1, 1997, restated effective January 1, 2017, by Shore Health System, Inc., the Memorial Hospital at Easton, MD, Inc., Care Health Services, Inc., Shore Health Services, Inc., Memorial Hospital Foundation, Inc., Shore Clinical Foundation, Inc., Dorchester General Hospital, Inc., Shore Health Enterprises, Inc., Shore Health Land Development, and Baltimore Washington Health Enterprises, Inc. (the Organization).

Effective January 1, 2017, the Plan was frozen to individuals hired after December 31, 2016. All employees of participating employers were eligible to participate in the Plan, except the following employees who were excluded from participation: members of a collective bargaining unit unless the collective bargaining agreement provided for participation in the Plan; leased employees; employees of Shore Health, Inc. who held an executive position of Vice President or above; and relief, temporary, per diem, limited part-time and non-benefitted employees.

Effective December 31, 2017, the Plan was frozen for contributions. Any employee who was not yet a participant in the Plan as of December 31, 2017 is unable to become a participant in the Plan. In addition, participant contributions and the Organization's matching, fixed, and supplemental contributions are no longer permitted in the Plan as of December 31, 2017.

The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

After the plan was frozen for contributions effective December 31, 2017, participants may only contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with an allocation of plan earnings and charged with an allocation of administrative expenses and ERISA spending account participant reimbursement. Plan earnings are allocated based on the participant's share of net losses and earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Accounts are participant directed.

Vesting

Participants are immediately vested in pretax and catch-up contributions, rollover contributions, the Organization's fixed, supplemental, and qualified nonelective contributions plus actual earnings thereon. Participants are vested in the Organization's matching contributions and earnings thereon according to the following vesting schedule:

Participant account balances merged in from the Baltimore Washington Health Enterprises, Inc. 401(k) Plan are 100% vested. Upon death, retirement or a termination of employment due to disability, participants will automatically be 100% vested in the Organization's matching contributions.

Notes Receivable from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of 50% of their vested account balance or \$50,000. Loan terms range from 1-5 years or up to 15 years for the purchase of principle residence. The loans are collateralized by the balance in the participant's account and bear interest at prime rate plus 1% on the first day of the quarter of the inception date of the loan. Loan offset will not occur following termination until the end of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment.

Payment of Benefits

Participants or their beneficiaries are eligible for distribution upon the participant's termination, death, termination due to disability, or retirement upon attainment of age 65. Participants whose vested account balance exceeds \$7,000 during the year ended December 31, 2024 and \$5,000 during the year ended December 31, 2023 may elect to receive a lump-sum or may elect monthly, quarterly, semi-annual, or annual installment payments or partial payments. Terminated, deceased, or disabled participants whose account balances do not exceed \$7,000 during the year ended December 31, 2024 and \$5,000 during the year ended December 31, 2023 and have not commenced receiving installment payments will be automatically distributed in the form of a lump sum, as soon as is practicable.

The Plan also allows for in-service withdrawals and hardships. In-service withdrawals can occur from a participant's vested account balance if the participant is at least 59½ of age and still employed with the Organization. Hardship distributions can only be withdrawn from participants rollover accounts or pretax and catch-up contribution accounts. Hardship withdrawals are allowed for participants incurring an immediate and heavy financial need, as defined by the Plan. Hardship withdrawals are strictly regulated by the Internal Revenue Service (IRS), and a participant must exhaust all available distributions prior to requesting a hardship withdrawal.

Forfeitures

Upon termination of employment, participants forfeit their non-vested balances. Forfeitures resulting from the termination of nonvested or partially vested participants may be used to first pay Plan expenses or reimburse the Organization for administrative expense paid by the Organization and then shall be allocated to the participant's account. No forfeitures were used to pay the Plan's administrative expenses or were allocated to Plan participants for the years ended December 31, 2024 and 2023. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$21,109 and \$3,549, respectively.

NOTE 2 SUMMARY OF ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the Plan administrator deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Administrative expenses of the Plan are paid by the Organization, from the ERISA spending account, the forfeitures account, or charged to the participant's account. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) of fair value of investments. The Plan received \$25,046 and \$105,271 of ERISA spending account revenue, for which \$5,420 and \$31,223 was used to pay Plan expenses and \$0 and \$81,987 was allocated to participants during the years ended December 31, 2024 and 2023, respectively. As of December 31, 2024 and 2023, the ERISA spending account totaled \$104,006 and \$84,247, respectively.

Subsequent Events

The Plan has evaluated subsequent events through August 11, 2025, the date the financial statements were available to be issued.

NOTE 3 CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and supplemental schedule, including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023 was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Empower Annuity Insurance Company, Empower Trust Company, LLC, and Prudential Bank & Trust, F.S.B., the qualified institutions of the Plan. Empower Annuity Insurance Company was the qualified institution as of and for the years ended December 31, 2024 and 2023, Prudential Bank & Trust, F.S.B. was the qualified institution for the period January 1, 2023 to March 31, 2023, and Empower Trust Company, LLC was the qualified institution as of and for the year ended December 31, 2024, as of December 31, 2023 and for the period April 1, 2023 to December 31, 2023.

NOTE 4 FAIR VALUE MEASUREMENT

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; or
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair market value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the valuation methodologies used at December 31, 2024 and 2023 except for the pooled separate account. Management re-assessed the valuation method based on new information available and determined the pooled separate account should be reported as a level 2 investment in the fair value hierarchy.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled Separate Account: Valued at NAV of units, which are valued daily by the bank at accumulation unit value based on the estimated value of the underlying investments held by the Plan at year-end. The account publishes their daily NAV and transacts at that price.

Collective Trust Funds: Valued at NAV of units of the bank collective trust. NAV is a readily determinable fair value and is the basis for current transactions. Participant transactions (purchase and sales) may occur daily.

NOTE 5 GROUP ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan has entered into a traditional fully benefit-responsive guaranteed investment contract with Empower Annuity Insurance Company. Empower Annuity Insurance Company maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.5%. The crediting rate is reviewed on a semi-annual basis for resetting.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan Sponsor or other Plan Sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) expenses have not been paid by the Plan and alternative arrangements for paying expenses have not been made, (2) a breach of material obligation under the contract, (3) the class of business to which the agreement belongs is no longer commercially desirable, and (4) the Plan provides written notification the agreement will be terminated.

NOTE 6 PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their entire accounts and will receive distributions of their vested accounts in accordance with Plan terms and IRS requirements.

NOTE 7 RELATED PARTY TRANSACTIONS AND PARTY IN INTEREST TRANSACTIONS

Certain Plan investments are units of a fully benefit-responsive investment contract and a pooled separate account managed by the qualified institution as of December 31, 2024 and 2023. These investments, including any interest and dividends, qualify as party-in-interest investments/transactions. Fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 8 TAX STATUS

The Internal Revenue Service (IRS) has determined and informed the Organization by a letter dated September 15, 2014, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). The Plan has been amended since receiving this determination letter; however, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 9 RISK AND UNCERTAINTIES

The Plan invests in various investment securities which are exposed to various risks such as interest rate, market volatility, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
