INDEPENDENT AUDITOR'S REPORT

To the Board of Trustees of the
Office and Professional Employees
International Union Welfare Trust Fund

Opinion

We have audited the accompanying financial statements of the Office and Professional Employees International Union Welfare Trust Fund (the Trust Fund), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits (cash basis) as of February 28, 2025 and February 29, 2024, and the related statement of changes in net assets available for benefits (cash basis) for the year ended February 28, 2025, and the related notes to the financial statements.

In our opinion, the financial statements referred to above present fairly, in all material respects, the net assets available for benefits of the Office and Professional Employees International Union Welfare Trust Fund as of February 28, 2025 and February 28, 2024, and the changes in its net assets available for benefits for the year ended February 28, 2025 in accordance with the cash basis of accounting described in Note 1.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Trust Fund and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Basis of Accounting

We draw attention to Note 1 of the financial statements, which describes the basis of accounting. The financial statements are prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.





Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the cash basis of accounting described in Note 1; this includes determining that the cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error.


Management is responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. NOTES TO FINANCIAL STATEMENTS

YEAR ENDED FEBRUARY 28, 2025

NOTE 1. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Method of Accounting - The accompanying financial statements have been prepared on the cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Under this basis, the only asset recognized is cash, and no liabilities are recognized. Additionally, revenue is recognized when received rather than earned, and expenses are recognized when paid rather than when the obligation is incurred.

Administrative Expenses - The Office and Professional Employees International Union (OPEIU) provides the use of office space and equipment as well as postage costs to the Office and Professional Employees International Union Welfare Trust Fund (the Trust Fund) and pays for professional fees incurred by the Trust Fund. The value of these services is not readily determinable and is therefore not recorded in the accompanying financial statements.

NOTE 2. DESCRIPTION OF THE TRUST FUND

The Trust Fund was established on November 1, 1953 to hold in Trust the assets of the plan and to pay such benefits as may be earned by plan participants in accordance with the plan provisions.

NOTE 3. DESCRIPTION OF THE PLAN

The plan is available to all eligible employees of contributing employers. The plan is also available to eligible retired employees of OPEIU, Local Unions and Councils who were participants in the OPEIU's pension plan on the day before their retirement, if the Local Union or Council elects to continue such coverage. Benefits provided by the plan are funded through contributions made by contributing employers on behalf of their employees.

Effective November 30, 2021, OPEIU as well as Local Unions were billed directly for premiums covered under the Trust Fund. Amounts paid directly by OPEIU and Local Unions to the insurance company for premiums totaled \$300,986 for the year ended February 28, 2025 and are not included in the accompanying financial statements.



NOTE 3. DESCRIPTION OF THE PLAN (CONTINUED)

Additional Information

- a. Eligibility for coverage of both employees and eligible dependents is effective on the first day of the month following the completion of one calendar month of employment with a contributing employer, except for disability benefits, for which benefits require the completion of six months of employment.
- b. Insurance is effective on the date of eligibility, if an employee is actively at work on that date and normally works at least 30 hours a week or in some cases 75% of the contributing employers work week.
- c. The plan provides for dental, life insurance, and disability benefits for employees. If the employee loses his eligibility for the continuance of his life insurance coverage, the employee has the privilege of converting coverage to an individual policy within 31 days. The conversion privilege is also available to eligible dependents. The employee and dependents also have the privilege of temporarily extending dental coverage through self-pay contributions.

Group Insurance Premiums - Life, accidental death and dismemberment, dental, and disability benefits are provided by a non-experience rated insurance contract with the Union Labor Life Insurance Company.

Unpaid Claims - Claims reported but not paid and claims incurred but not reported at year end will be paid by the insurance company and, therefore, are not included as obligations in the financial statements. Claim reserves required and held by the insurance company are also not included in the financial statements.

NOTE 4. PRIORITIES UPON TERMINATION

It is the intent of the Board of Trustees (Trustees) to continue the Trust Fund in full force and effect. However, to safeguard against any unforeseen contingencies, the right to discontinue the plan and the Trust Fund is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Trust Fund. Any remaining fund assets will be distributed in such manner as will in the opinion of the trustees bring about the purpose of the Trust Fund. Termination shall not permit any part of the Trust Fund to be used for or diverted to purposes other than the exclusive benefit of the participants.



NOTE 5. TAX STATUS

The Trust Fund is exempt from federal income tax under provisions of Section 501(c)(9) of the Internal Revenue Code (IRC). The Trust Fund obtained its latest determination letter on February 25, 1983, in which the Internal Revenue Service stated that the Trust Fund, as then designed, was in compliance with the applicable requirements of the IRC. The Trust Fund has been amended since receiving the determination letter. However, the Trust Fund's administrator and legal counsel believe that the Trust Fund is currently designed and being operated in compliance with the applicable requirements of the IRC.

The Trust Fund adheres to the authoritative guidance relating to accounting for uncertainty in income taxes included in Accounting Standards Codification Topic *Income Taxes*. These provisions provide consistent guidance for the accounting for uncertainty in income taxes recognized in an entity's financial statements and prescribe a threshold of "more likely than not" for recognition and derecognition of tax positions taken or expected to be taken in a tax return. The Trust Fund's administrator and counsel performed an evaluation of uncertain tax positions for the years ended February 28, 2025 and February 29, 2024, and determined that there were no matters that would require recognition of a liability (or asset) or disclosure in the financial statements.

NOTE 6. FUNDING POLICY

Participating employer contributions are determined by the rates charged by the insurance provider for the various premiums.

NOTE 7. SUBSEQUENT EVENTS REVIEW

Subsequent events have been evaluated through August 21, 2025, which is the date the financial statements were available to be issued. This review and evaluation revealed no material event or transaction which would require an adjustment to or disclosure in the accompanying financial statements.
