NOTE 1 - PLAN DESCRIPTION

General

The SEIU-USWW and San Diego County Employers Trust Fund (the “Plan”) is a health and welfare plan established by labor and employers through collective bargaining. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Active employees are eligible for those benefits specified in their collective bargaining agreement. Dependents of eligible active employees are also eligible for certain benefits.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by the Consolidated Omnibus Budget Reconciliation Act (COBRA), has been adopted by the Plan.

The Plan documents include detailed rules for each situation. Participants should refer to the Plan Agreement and any amendments regarding specific provisions of the plan.

Plan Benefits

Benefits provided include a plan of insurance for hospital, medical, surgical, dental benefits, vision and group life insurance for eligible active members. All hospital and medical coverage are provided by Kaiser and MediExcel; life, accidental dismemberment and disability insurance is provided by Mutual of Omaha; vision is provided by Vision Service Plan; and dental coverage is provided by MediExcel and Liberty Dental.

The Plan offers two type of benefits, Plan “A” and Plan “B”. Plan “A” provides for preventive care at no charge, which includes immunizations, routine physicals, eye and hearing examinations. Plan “A” provides coverage through Kaiser Permanente at a lower level of benefits than existing Kaiser coverage. A member becomes eligible on the first day of the second calendar month following, 1) the month a member completes 1200 hours of work for a participating employer, or 2) January 1, 2014, whichever is later. However, a member may waive coverage by completing a waiver form on or before the 20th day of the month prior to the beginning of coverage.

Plan “B” offers a higher level of benefits than Plan “A” and is for longstanding employees. In order to be eligible for Plan “B” a full-time employee in a qualified position must work 130 hours per month continuously for a defined period of time (10 to 12 months depending on jobsite) and each month thereafter. Employees must also meet certain service requirements before being eligible. The service requirements range from 14 to 37 months depending on jobsite and date of hire. At some jobsites single or family coverage is immediate upon meeting the eligibility requirements however at some jobsites additional service is required prior to family coverage being paid by the employer. Any employee with employer paid employee only coverage has the option to elect, at his/her own cost, coverage for his/her eligible dependent children.

Insured Benefits

The plan fully insures the medical, dental, vision, and life insurance benefits (basic, supplemental and dependent), through insurance contracts. The plan purchases annual insurance contracts for these insured benefits.

NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis Of Presentation

The financial statements of the Fund are prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United State of America. The use of the accrual basis recognizes revenue when earned or otherwise available and benefits and expenses are recognized when incurred.

Employer Contributions

Employer contributions are reported on the financial statements on the accrual basis. Employer contributions as reported are contributions made by employers on behalf of employees for hours worked during the year.

The Plan has an employer payroll audit system in place in which the employers are randomly audited to verify that they are contributing in accordance with their signed agreement. Delinquencies may arise due to these payroll audits, but due to the uncertainty of collections, no estimates of the contributions will be accrued.

Investments

If available, quoted market prices are used to value investments. Many factors are considered in arriving at that fair value. In general, however, shares of mutual and exchange traded funds are valued at quoted market prices which represent the net asset value of shares held by the Plan at year end. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis.

FASB Accounting Standards Codification (ASC) 820, which defines fair value, establishes a framework for measuring fair value and expands disclosures about fair value measurements. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). ASC 820 emphasizes that fair value is a market-based measurement that should be determined based on the assumptions market participants would use in pricing the asset or liability. As a basis for considering market participant assumptions in fair value measurements, ASC 820 establishes a fair value hierarchy that distinguishes between (1) market participant assumptions developed based on market data obtained from sources independent of the Plan (observable inputs) and (2) the Plan's own assumptions about market participant assumptions developed based on the best information available in the circumstances (unobservable inputs). Valuation techniques used to measure fair value shall maximize the use of observable inputs and minimize the use of unobservable inputs.

The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value into three broad levels, as follows:

Level 1 inputs are quoted prices (unadjusted) in active markets for identical assets or liabilities the Plan has the ability to access at the measurement date. An active market for the asset or liability is a market in which transactions for the asset or liability occur with sufficient frequency and volume to provide information on an ongoing basis.

Investments (Continued)

Level 2 inputs are inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly. If the asset or liability has a specified (contractual) term, a Level 2 input must be observable for substantially the full term of the asset or liability. Level 2 inputs include the following:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in markets which are not active;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

Level 3 inputs are unobservable inputs for the asset or liability. Unobservable inputs are used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at the measurement date. Unobservable inputs reflect the Plan's own assumptions that market participants would use in pricing the asset or liability (including assumptions about risk). Unobservable inputs are developed based on the best information available in the circumstances, which might include the Plan's own data. However, market participant cannot be ignored and, accordingly, the Plan's own data used to develop unobservable inputs are adjusted if information is reasonably available without undue cost and effort that indicates that market participants would use different assumptions.

The methods of valuation described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Following is a description of the valuation methodologies used for investments measured at fair value. There have been no changes in valuation methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Exchange traded funds: Valued at the daily closing price as reported by the fund. Exchange traded funds held by the Plan are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily net asset value (NAV) and to transact at that price. The Exchange traded funds held by the Plan are deemed to be actively traded.

The plan does not have any Level 3 investments and there were no significant transfers between Level 1 and Level 2 investments during the year ended December 31, 2024.

The fair value hierarchy of ASC 820 gives the highest priority to Level 1 and the lowest priority to Level 3 inputs.

Use of Estimates and Assumptions

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, benefit obligations, and changes therein, claims payable, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 3 - PRIORITIES UPON TERMINATION

It is the intent of the Trustees to continue the Plan in full force and effect. The Plan will remain in effect as long as there are employers who are obligated under any collective bargaining agreements to make contributions to the Plan. In the event of termination, the Trustees shall first satisfy, or make provisions to satisfy, the obligations of the Plan. Any remaining Plan assets shall be paid or used for the continuance of one or more of the benefits provided under the Plan. Termination shall not permit any part of the Plan to be used for, or diverted to, purposes other than the exclusive benefit of the participants.

NOTE 4 – CONTINUATION COVERAGE

The Plan is designed to offer continuation coverage through the Consolidated Omnibus Budget Reconciliation Act (COBRA). Under Federal Law the Plan is required to offer a temporary extension of health coverage, referred to a COBRA. This type of arrangement is paid to the Plan monthly.

NOTE 5 - SIGNIFICANT CONCENTRATIONS OF CREDIT RISK

The Fund's cash and cash activities are with American Business Bank. The accounts are insured by the Federal Deposit Insurance Corporation up to \$250,000. At times, such cash balances may be in excess of the insurance limit.

NOTE 6 - SIGNIFICANT TRANSACTIONS WITH PERSONS KNOWN TO BE PARTIES IN INTEREST

The Fund has contracted for administrative services with Pacific Southwest Administrators. The administrative fees paid for the years ended December 31, 2024 and 2023 was \$92,771 and \$98,615, respectively.

The fund also contracts with investment managers, consultants, attorneys, and auditors who are all known to be parties in interest.

NOTE 7 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

NOTE 8 - INCOME TAXES

The Internal Revenue Service issued a favorable determination pursuant to Internal Revenue Code Section 501 (c) (9), and accordingly, the trust's net investment income is exempt from income taxes. The Plan sponsor believes that the Trust, as amended, continues to qualify and to operate in accordance with applicable provisions of the Internal Revenue Code. Generally Accepted Accounting Principles require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income examination for years prior to 2022.

NOTE 9 - SUBSEQUENT EVENTS

In preparing these financial statements, the Plan has evaluated events and transactions for potential recognition or disclosures through August 20, 2025, the date the financial statements were available to be issued.


