Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Fortis Construction, Inc. Employees Savings Trust and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Fortis Construction, Inc. Employees Savings Trust's ability to continue as a going concern within one year after the date that the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Notes to Financial Statements

Note 1 – Description of Plan

The following description of the Fortis Construction, Inc. Employees Savings Trust (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

General – The Plan is a defined contribution plan covering all employees of Fortis Construction, Inc. (the Company), excluding employees covered under a collective bargaining agreement, non-resident aliens, leased employees, merger and acquisition employees, interns, skilled labor, and casual labor. The Plan is subject to the requirements of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Company is the Plan's sponsor and serves as the plan administrator.

Eligibility – Employees may enter the Plan, make elective contributions and receive employer contributions on the first day of the quarter following the first day of employment with the Company.

Contributions – The Plan provides for employee pre-tax deferral contributions, after-tax Roth deferral contributions, or a combination of both. At January 1, 2024, participants entering the Plan are automatically enrolled at a deferral rate of 3% of eligible wages. Beginning April 1, 2024, participants entering the plan are enrolled at a deferral rate of 6%. The automatic enrollment can be declined by the employee upon request to change the deferral percentage to zero. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may increase their deferral contributions, up to the maximum allowed under the Internal Revenue Code (IRC) or 75% of eligible compensation, which is \$23,500 for 2024. Participants who have attained age 50 before the end of the Plan year are eligible for catch-up contributions of \$7,500 in 2024. The amount deferred, pre-tax, will not be subject to income tax until it is actually distributed to the participant. The amount deferred is, however, subject to Social Security tax at the time of the pre-tax deferral. Participants may also contribute amounts representing distributions from other qualified defined contributions plans (rollover).

In 2024, the discretionary employer match consisted of a 100% match of employee contributions up to 6% of the participants' eligible compensation. The Company made discretionary matching contributions of \$2,333,371 for 2024.

The Company may contribute a discretionary profit-sharing contribution to be determined annually by the Company's board of directors. The Company did not make a profit-sharing contribution in 2024.

Contributions are subject to regulatory limitations.

Investment elections – Each participant may choose from several combinations of investments offered through Voya Retirement Insurance and Annuity Company (Voya), as selected by the plan administrator. Upon enrollment in the Plan, participants may direct contributions to various investment funds and individually direct their investments. Employees have the opportunity to change their investments daily.

Participant accounts – Each participant's account is credited with the participant's contribution and an allocation of the Company's contributions, and Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan Agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance. Asset management fees are deducted from the earnings of the various funds.

Vesting – Participants are immediately vested in their voluntary contributions and any matching contributions used to satisfy safe harbor contribution criteria, plus actual earnings thereon. Vesting in the remainder of their account is based on years of service and occurs gradually.

Forfeited accounts – Forfeitures are the non-vested portion of a participant's account that are lost upon termination of employment. Forfeitures are retained in the Plan and must be used before year end. Forfeitures may be used to reduce employer contributions or pay reasonable Plan expenses. During the year ended December 31, 2024, forfeitures of \$250,870 were used to reduce employer contributions and pay Plan expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$62,909 and \$89,793, respectively. These accounts will be used to reduce future employer contributions and pay Plan expenses.

Payment of benefits – Upon termination of service due to termination of employment, disability, retirement, or death a participant will receive a lump sum payment or may elect to receive equal monthly, quarterly, or annual installments over a period not to exceed the reasonable life expectancy of the participant or death beneficiary. The Plan may also make hardship distributions to participants in certain situations subject to defined limitations.

Notes receivable from participants – Participants may borrow against their Plan accounts subject to certain limitations. Loan amounts are subject to a minimum of \$1,000 and a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. Loans are secured by the balance in the participant's account and bear interest at a rate comparable with rates charged by commercial lenders for loans under similar circumstances. Loan terms generally range from one to five years. However, if the loan is used to acquire a principal residence the loan may be up to twenty years. The interest rates on loans range from 4.25% to 10.50% as of December 31, 2024, with maturity dates through November 2042. Principal and interest are paid ratably through semi-monthly payroll deductions.

Reclassification – Certain reclassifications have been made to the prior year financial statements to conform to the current year presentation. There was no impact on the change in net assets or net assets available for benefits.

Note 2 – Summary of Accounting Policies

Basis of accounting – The financial statements of the Plan are prepared using the accrual method of accounting in accordance with the generally accepted accounting principles in the United States of America (GAAP).

Use of estimates – The preparation of financial statements in accordance with GAAP requires the Plan administrator to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Risks and uncertainties – The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Investment valuation and income recognition – The Plan's investments are reported at fair and contract value. The Plan's trustee, Voya, certifies the fair and contract value of all investments. If available, quoted market prices are used to value investments. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan administrator and trustee determine the Plan's valuation policies utilizing information provided by the investment advisor and custodian. See Note 3 for discussion of fair value measurements.

Contract value is the relevant measure for assets invested in fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Income recognition – Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend rate. Net appreciation consists of both the realized gains and losses and unrealized appreciation and depreciation of those investments.

Payment of benefits – Benefits are recorded when paid.

Expenses – Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants, distributions, and investment management services are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Contributions – Contributions from participants and corresponding discretionary matching contributions are recorded in the year in which the related participant compensation is earned.

Notes receivable from participants – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based on the terms of the Plan Agreement. Interest income is recorded on the accrual basis. No allowance for doubtful credit losses has been recorded as of December 31, 2024 and 2023.

Subsequent events – The Plan has evaluated subsequent events through June 16, 2025, which is the date the financial statements were issued.

Note 3 – Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include: 1) quoted prices for similar assets or liabilities in active markets; 2) quoted prices for identical or similar assets or liabilities in inactive markets; 3) inputs other than quoted prices that are observable for the asset or liability; 4) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Registered investment companies (mutual funds) – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Mutual funds held by the Plan are deemed to be actively traded.

The techniques previously described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. While the Plan believes its valuation techniques are appropriate and consistent with other market participants, the use of different techniques or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The availability of observable market data is monitored to assess the appropriate classification of financial instruments within the fair value hierarchy. Changes in economic conditions or model-based valuation techniques may require the transfer of financial instruments from one fair value level to another.

The Plan administrator evaluates the significance of transfers between levels based upon the nature of the financial instrument and size of the transfer relative to total net assets available for benefits. There were no significant transfers between levels.

Note 4 – Guaranteed Investment Contract

The Plan invests in a fully benefit-responsive investment contract (FBRIC) with Voya. Voya maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is based on a formula established by the contract issuer but may not be less than 1.0%. The crediting rate is reviewed on a quarterly basis for resetting. The FBRIC does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The contract meets the FBRIC criteria and is therefore reported at contract value. Contract value is the relevant measure for FBRICs because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Voya, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations, which may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the Plan's ability to transact at contract value with the contract issuer and that also would limit the ability of the Plan to transact at contract value with the participants.

Note 5 – Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

Note 6 – Tax Status

The Internal Revenue Service (IRS) has determined and informed the Plan's volume submitter sponsor by an opinion letter dated November 30, 2020, that the Non-Standardized Pre-Approved Profit Sharing Plan with CODA sponsored by Professional Benefit Services Inc, which has been adopted by the Plan, is acceptable pursuant to Section 401 of the Internal Revenue Code (IRC), and was designed in compliance with the applicable requirements of the IRC and therefore, believe that the Plan is qualified, and the related trust is tax-exempt. The Plan has been amended since receiving the opinion letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, they believe that the Plan was qualified and tax-exempt as of the financial statement date. No provision for income taxes has been included in the Plan's financial statements.

GAAP requires the Plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 – Information Certified by the Trustee

The Plan's investments are held by Voya Retirement Insurance and Annuity Company, the trustee of the Plan. The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

The Plan administrator has obtained certifications from the trustee as of December 31, 2024 and 2023, and for the year ended December 31, 2024, that the following information included in these financial statements and supplemental schedule provided to the Plan administrator by the trustee is complete and accurate.

- Investments, as reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net appreciation in fair value of investments and dividends reflected on the accompanying statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Investments reflected on the schedule of assets (held at end of year), except for participant loans.

Note 8 – Related-Party Transactions and Party-in-Interest Transactions

Plan investments are managed by Voya Retirement Insurance and Annuity Company. Fees paid by the Plan for investment management services were netted against the investment income and totaled \$50,000 in the year ending December 31, 2024. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.
