Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter — Supplemental Schedule Required by ERISA

The supplemental Schedule H, line 4i—Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor’s Rules and Regulations for Reporting and Disclosure under ERISA.

NOTE 1—DESCRIPTION OF PLAN

The following description of MRA-The Management Association 401k Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General. The Plan is a defined contribution plan covering all employees of MRA- The Management Association, Inc. (the Company) who have one hour of service in a one month-period and are age eighteen or older. For on-call employees who work less than 20 hours per week, they need to have one year of service and equal or over 1,000 hours of service to become eligible, unless they qualify to participate under long-term part-time employee rules. As of May 1, 2023, all eligible employees who were employed with Employers Resources Association (ERA) on that date are eligible immediately to participate in the Plan due to the acquisition of ERA by the Company. The Plan is subject to the provisions of the Employee Income Security Act of 1974 (ERISA). The investment committee is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Effective January 1, 2024 the Plan implemented SECURE Act and SECURE 2.0 Act provisions including updating the dollar limit for mandatory distributions (\$5,000 to \$7,000) and plan eligibility for long-term part-time employees. The Plan also was amended to exclude Lifestyle Spending Account (LSA contributions) and Wellness Premium Discount compensation from eligible Plan compensation as well as increasing the automatic increase for deferrals by 1% up to a minimum of 15%.

Contributions. Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a stable value fund as investment options for participants. The Company may contribute a matching contribution and/or profit sharing amounts at the option of the Company's management as determined quarterly. Participants with one month of service are eligible to receive matching contributions. All employees are eligible to receive profit sharing amounts regardless of participation in the Plan. An employee is required to have one month of service and be employed at the end of the applicable period to be eligible for profit sharing amounts. On-call employees should satisfy one year of service and 1,000 hours of service to be eligible for employer matching contribution and profit sharing contribution. In 2024, the Company contributed 100% of the first 3% of base compensation that a participant contributed to the Plan. An additional profit sharing amount of \$332,611 was contributed by the Company in 2024. Contributions are subject to certain statutory limitations.

Each eligible participant who has not elected to opt out of the Plan is automatically enrolled in the Plan at a deferral rate of 4% of eligible compensation. There is an auto escalation to increase by 1% to a maximum of 15% and the automatic escalation occurs for any eligible employee deferring less than the maximum escalation rate.

NOTE 1—DESCRIPTION OF PLAN (continued)

Participant accounts. Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contributions and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting. Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service.

Notes Receivable from Participants. Participants may borrow from their accounts a minimum of \$1,000 up to maximum equal to or the lesser of \$50,000 or 50% of their vested account balance. Participants are limited to two outstanding loans at any given time. The loans are secured by the balance in the participant's account and bear interest at rates that range from 4.25% to 9.50%. Interest is calculated at 1% over prime at the time the loan is issued. Principal and interest is paid ratably through bi-monthly payroll deductions.

Payment of Benefits. A participant may receive a lump sum amount equal to the value of the participant's vested interest in his or her account or a partial withdrawal, for all distributions other than death. After termination of employment with the Company, if the vested amount of the account does not exceed \$7,000, the vested account balance will be distributed from the Plan. Participants may also elect in-service distributions from the Plan on account of hardship or attainment of age 59 ½.

Forfeited Accounts. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$75,253 and \$5,240 respectively. These accounts will be applied against employer contributions and Plan expenses. In 2024, employer contributions were reduced by \$59,804 and expenses of \$416 were paid from forfeited nonvested accounts.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

NOTE 2—SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Contribution Receivable

The Plan uses the ERISA definition of plan assets to determine whether an accrual should be made for employee or the related employer contributions receivable based on when amounts have been withheld from employee compensation. A defined contribution plan can elect to recognize the employee and the related employer matching contribution either (1) in the period related to the participant's service or compensation (even if not yet withheld), or (2) in the period the employee contribution is withheld if the policy is applied on a consistent basis.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis and dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account. As of December 31, 2024 and 2023, no allowance for credit losses has been recorded and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payment of Benefits

Benefits are recorded when paid. There were no requested distributions that were not paid out by December 31, 2024.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. All the expenses of maintaining the Plan were paid by the Plan which include investment management expenses, general administrative service expenses, recordkeeping fees, investment consulting fees, and fees related to the administration of notes receivable and benefit disbursement. All those fees are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

Date of Management's Review of Subsequent Events

We have evaluated subsequent events through August 29, 2025, the date the financial statements were available to be issued.

NOTE 3—FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority, Level 2 inputs consist of observable inputs other than quoted prices for identical assets, and Level 3 inputs are unobservable and have the lowest priority.

Level 1 Fair Value Measurements

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Fair Value Measurements

Stable value fund: The fair value of stable value fund is valued at the net asset value (NAV) per unit as determined by the manager of the trust which is readily determinable. Such NAV is based on as the present value of future account values and participant benefit withdrawals. Benefit withdrawals are assumed to occur on the contract anniversary date. Present values are derived by discounting account values and benefit withdrawals by the appropriate market interest rates. Regardless of the activity of the fund, Empower pays the stated interest rate and backs the capital deposit where the “risk” is measured by its insurance credit rating. The fair value of stable value fund is readily determinable.

Collective trust fund: The fair value of the collective trust fund is valued at the net asset value (NAV) per unit as determined by the issuer which is readily determinable.

NOTE 4—TAX STATUS

The Company has adopted a pre-approved plan document that has received an opinion letter from the Internal Revenue Service dated June 30, 2020, stating that the form of the pre-approved plan document was in compliance with the applicable requirements of the Internal Revenue Code (IRC). Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

NOTE 5—PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in the Company contribution portion of their account.

NOTE 6—RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investments, it is at least reasonably possible that changes in risks in the near term would materially affect the amounts reported in the statement of net assets available for benefits and the statement of changes in net assets available for benefits.

NOTE 7—RELATED-PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Empower Trust Company, LLC. Empower Trust Company, LLC is the custodian and recordkeeper for the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan include investment management expenses, general administrative service expenses, and recordkeeping fees. These transactions are not, however, considered prohibited transactions under 29 CFR 408(b) of the ERISA regulations.

NOTE 8—CERTIFIED INVESTMENTS

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Empower Trust Company, LLC (the custodian of the Plan).

NOTE 9—SUBSEQUENT EVENTS

The Plan has implemented an optional provision of the SECURE 2.0 Act in 2025 to increase the catch-up limit for participants of ages 60 through 63.
