Management is responsible for maintaining a current plan instrument, including all plan amendments. Management is also responsible for administering the Plan and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.



- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter – Supplemental Schedules Required by ERISA

The supplemental Schedule H, line 4i- Schedule of Asset (Held at End of Year) as of December 31, 2024 and the supplemental Schedule H, Line 4a - Schedule of Delinquent Participant Contributions for the Year Ended December 31, 2024 are presented for purposes of additional analysis and are not a required part of the financial statements but are supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or



is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedules, we evaluated whether the supplemental schedules, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- The form and content of the supplemental schedules, other than the information in the supplemental schedules that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- The certified investment information in the supplemental schedules agrees to, or are derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Notes to Financial Statements

1. Plan Description

The following description of the ChildCareGroup 401(k) Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 2018 and is a defined contribution 401(k) Plan established by the ChildCareGroup (the Company or Employer) which covers substantially all employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Trustee and Administration of the Plan

The Company (the Plan Administrator) is responsible for the administration and operation of the Plan. BOKF, NA (BOK Financial), (the Trustee), serves as the Plan's record keeper and trustee. BOK Financial is responsible for the custody and management of the Plan's assets. The Plan Administrator determines the appropriateness of the Plans investment offerings and monitors investment performance.

Eligibility

Employees are considered eligible if they are employed by ChildCareGroup or any affiliate who has adopted the Plan. All classifications of employees of the Company are eligible to participate in the Plan after completing 30 days of service except for leased employees, employees whose benefits are governed by a collective bargaining agreement, and nonresident aliens with no income from a U.S. source.

There is no minimum age requirement to enter the Plan.

Contributions

Participants may contribute up to 100% of their eligible compensation, as defined in the Plan Document. Participants may contribute pre-tax contributions and/or Roth contributions (post-tax contributions) to the Plan, subject to the Internal Revenue Service (IRS) annual limit. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions, subject to the IRS annual limit. Participants may also contribute amounts representing rollover distributions from other qualified plans.

Effective June 1, 2022, the Plan was amended to remove profit sharing contributions and include non-safe harbor matching contributions.

The Company makes a Safe-Harbor matching contribution equal to a percentage of each participant's deferred compensation, within the limits of the IRS regulations. For the year ended December 31, 2024, the Company's Safe-Harbor matching contribution was equal to 100% of participant contributions up to 3% of eligible compensation, plus 50% of participant contributions for the next 2% of eligible compensation.

Participant Accounts

Each participant's account is credited with the participant's contributions, Employer's contributions and earnings or losses. Plan earnings or losses are applied to a participant's account balance based on the investment experience of the funds held and the number of shares owned in each fund by the participant. Participants accounts are charged an allocation of administrative expenses that are allocated to their accounts.

Investments

The Plan provides a variety of investment options from which participants may select. Participants direct how their funds are to be invested by notifying the Trustee either by phone or via online account access.

Vesting

Participants are immediately 100% vested in their pre-tax, Roth, catch-up, rollover, employer Safe Harbor matching, and qualified non-elective contributions. All participant contributions and related earnings are fully vested.

Vesting in the Company's discretionary non-Safe Harbor matching and profit sharing contributions, plus actual earnings thereon is based on years of continuous service according to the following schedule:

1 - 2	33
2 - 3	67
3 or more	100

Full and immediate vesting will occur upon normal retirement age (age 65) as defined in the Plan Document, death or disability or termination of the Plan.

Payment of Benefits

Upon termination of service, due to death, disability, retirement or separation, a participant receives the vested account balance in a lump-sum distribution or installment payments in accordance with provisions specified in the Plan Document. If the value of the vested balance is less than \$1,000, the participant account will be distributed directly to the participant in cash. If the value of the vested account is greater than \$1,000 but less than \$5,000, the participant account will be distributed from the Plan to an individual retirement account for the benefit of the participant. If the value of the vested balance is greater than \$5,000, the participant may elect to defer payment to a later date (but not beyond the participant's reaching the age of 73).

Notes Receivable from Participants

Participants may borrow up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The minimum loan amount is \$1,000. One loan is permitted at a time.

The loans are secured by the balance in the participant's account and bear interest at the prime rate on the day in which the loan is requested, plus 2%. The loans are repaid ratably through payroll deductions over a period of five years. The Plan Administrator may extend the term of the loan if the loan is used to acquire a dwelling unit. As of December 31, 2024 and 2023, the interest rates ranged from 6% to 10.5%, respectively, with maturities ranging from February 2025 to September 2029.

Forfeited Accounts

Forfeited account balances are used to reduce future employer contributions or to pay administrative expenses related to the Plan. During the year ended December 31, 2024, \$1,242 of forfeitures were used to reduce administrative expenses. At December 31, 2024 and 2023, there was \$0 and \$151, respectively, held in forfeited non-vested accounts.

Administrative Expenses

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and benefits paid to participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses paid to investment advisors, transfer agents, and others described in each fund prospectus or other published documents are deducted by the investment funds or accounts prior to the allocation of the Plan's investment earnings activity and are therefore included in net appreciation in fair value of investments.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan have been prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. The Plan presents, in the Statement of Changes in Net Assets Available for Benefits, the net appreciation in fair value of its investments which consists of realized gains and losses and unrealized appreciation on these investments.

Contributions

Participant contributions and any related employer matching contributions are recognized in the period related to the participant's service or compensation (even if not yet withheld).

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced, and a benefit payment is recorded.

Payment of Benefits

Benefits payments to participants are recorded upon distribution from the Plan.

3. Certified Investment Information

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental Schedule H, line 4i- Schedule of Asset (Held at End of Year), including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by BOK Financial, a qualified institution.

4. Fair Value Measurements

Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurements*, provides for a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets.
- Quoted prices for identical or similar assets or liabilities in inactive markets.
- Inputs other than quoted prices that are observable for the asset or liability.
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

A financial instrument's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual Funds - Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Stable Value Fund - The Morley Stable Value Fund is a collective investment trust composed primarily of fully benefit-responsive investment contracts. The stable value fund is valued at the net asset value (NAV), which is based on the fair value of the underlying investments less its liabilities. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV. The investment objective of the Morley Stable Value fund is to provide preservation of capital, relatively stable return with its comparatively low risk profile, and liquidity for benefit-responsive plan or participant payments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Related Party and Parties-in-Interest Transactions

Parties-in-interest are defined under Department of Labor Regulations as any fiduciary of the Plan, any party rendering services to the Plan, the Employer, and certain others. As such, transactions conducted by the Trustee qualify as party-in-interest transactions. Fees incurred by the participants for distributions are paid by the participants out of the distribution amounts. The Company pays directly any other fees related to the Plan's operations. The Plan issues loans to participants that are secured by the vested balance of the participants accounts. The above transactions qualify as party-in-interest transactions which are exempt from the prohibited transactions rule.

6. Income Tax Status

The Company adopted a pre-approved plan document sponsored by BOKF NA. BOKF NA received an opinion letter from the IRS, dated June 30, 2020, which states that the pre-approved plan document, as then designed, satisfies the applicable provisions of the internal revenue code (IRC). Although the Plan has been amended since the date of the opinion letter, Plan management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no IRS examinations for any tax periods in progress.

7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. Should the Plan be terminated, the assets of the Plan would be distributed to the participants based on their individual account balances as determined under the provisions of the Plan. To the extent not already vested, participants would become 100% vested.

8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

9. Delinquent Participant Contributions

During the Plan year ended December 31, 2024, participant contributions totaling \$5,000 were not remitted to the Plan within the period prescribed by DOL regulations. These transactions constitute non-exempt party-in-interest transactions or prohibited transactions as defined by ERISA. The related lost earnings were remitted to the Plan during 2025.

10. Subsequent Events

The Plan has evaluated subsequent events through August 22, 2025, the date the financial statements were available to be issued.
