### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Welsco, Inc. 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

## **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

### Notes to Financial Statements December 31, 2024 and 2023

#### (1) Description of Plan

The following description of the Welsco, Inc. 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

**General:** The Plan is a defined contribution plan intended to qualify under section 401(a) of the Internal Revenue Code and is subject to the provisions of the Employer Retirement Income Security Act of 1974, as amended (ERISA). All full-time employees of Welsco, Inc. (the “Company”) are eligible to participate in the Plan upon completion of 12 months of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

**Contributions:** Eligible employees may make either pre-tax or Roth elective deferrals of their compensation up to IRS allowed limits. Participants may also contribute amounts representing eligible rollover distributions from other qualified benefit or contributions plans. Participants direct the investment of all contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and a group annuity contract as investment options for participants. Annually, the Company may elect to make discretionary matching contributions. For the year ended December 31, 2024 and 2023, the Company made matching contributions of one-third of participant deferrals up to 6% of eligible compensation.

**Participant Accounts:** Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contribution(s) (if employed on the last day of the plan year with service of 1,000 hours or more for the year), (b) the account’s earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Automatic Enrollment:** Employees who have not affirmatively elected to contribute, or not contribute, to the Plan are automatically enrolled at a rate of 3% of compensation. The amount will increase by 1% each plan year until the amount withheld reaches 10% of compensation unless the plan is amended or the employee elects otherwise in writing.

**Investment Options:** Participants are permitted to direct the trustee as to the investment of the assets in their individual account balances into specific assets allowed under the Plan. Upon request, participants may obtain a complete listing of all investment options available under the Plan from the trustee. Participants can change their investment allocation elections at any time which take effect daily.

**Vesting:** The balance in each participant’s elective deferral contribution account and rollover account is 100% vested when made. Vesting in the Company’s contribution portion of a participant’s account plus earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service in the employer’s discretionary

contribution and in the employer's matching contribution. Upon death or disability while an employee, the participant's account is immediately 100% vested.

**Payment of Benefits:** Upon termination of service due to death, disability, or retirement, an employee may elect to receive either a portion or total lump-sum amount equal to the value of his or her respective account, or rollover to another qualified plan. If the value of the vested account is more than \$5,000, the participant may elect to defer any payment before reaching normal retirement age. If the value of the vested account is less than \$5,000, a distribution of the vested balance will be either automatically rolled over to an Individual Retirement Account (for balances over \$1,000) or made directly to the participant as soon as administratively feasible. The Plan also allows various in-service distributions.

**Forfeitures:** The Plan may, at its discretion, use available forfeitures to pay administrative expenses or reduce future employer contributions.

## (2) **Summary of Significant Accounting Policies**

The following is a summary of the significant accounting policies used by the Plan in the preparation of the accompanying financial statements. Such policies are in accordance with accounting principles generally accepted in the United States of America.

**Basis of Accounting:** The Plan prepares financial statements using the accrual method of accounting whereby additions and deductions to net assets available for benefits, other than benefit payments, are recognized when earned or incurred, respectively.

**Use of Estimates and Risks and Uncertainties:** The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America, requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Valuation of Investments:** The Plan's investments are stated at fair value, except for the group annuity contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value mutual funds. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain distributions are included in dividend income. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Benefits Paid to Participants:** Benefits are recorded when paid.

(3) **Tax Status**

The Plan obtained its latest determination letter on November 14, 2022, in which the Internal Revenue Service stated that the Plan and related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code and therefore not subject to tax. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe, that the Plan is qualified.

The Plan's information returns are subject to examination by the Department of Labor and the Internal Revenue Service generally for three years after they were filed.

(4) **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$8,254 and \$5,939, respectively.

(5) **Operating Expenses and Party-In-Interest Transactions**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. During the year, the Plan incurred and paid expenses totaling \$33,208 to outside service providers for general administration, investment advisory, and record keeping services. Fees related to the administration of benefit payments are charged directly to the participant's account. Certain investment fund options are subject to investment-related fees based on a percentage of invested assets, as disclosed in the applicable fund's prospectus and disclosed to participants through a participant disclosure notice. Such fees are charged directly against the fund's investment income and are not separately disclosed in the accompanying financial statements.

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employer association, or relatives of such persons.

(6) **Information Certified by Trustees**

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the following is a summary of the unaudited information included in the Plan's financial statements and supplemental schedule that was certified by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, the trustees, and furnished to the plan administrator. The plan administrator has obtained certifications from the trustees that such information is complete and accurate.

- Investments, at fair value
- Investments, at contract value
- Investment income
- Schedule of assets (held at end of year)

(7) **Fair Value Measurement**

Under FASB ASC 820-10, three prioritized valuation inputs may be used to determine fair value at the measurement date: Level 1 – quoted prices (unadjusted) in active markets for identical assets or liabilities; Level 2 – observable inputs other than the quoted prices included in Level 1; Level 3 – unobservable inputs. There have been no changes in valuation methodologies during the periods under audit, therefore no recognition of gain or loss is required for these financial statements.

(8) **Contract with Insurance Company**

Effective June 8, 2012, the Plan entered into a fully benefit-responsive investment contract with Empower Life & Annuity Insurance Company of America (Empower). Empower maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The crediting interest rate is based on a formula established by the contract issuer but may not be less than 0%.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan’s prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan or (4) the failure of the trust to qualify for

exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**(9) Plan Termination**

Although it has not indicated any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**(10) Subsequent Events**

The plan sponsor, Welsco, Inc. was purchased by another company during the year ended December 31, 2024. In August 2024, the plan sponsor resolved to merge the Plan into the nexAir, LLC Profit Sharing and 401(k) Plan. As a result all mutual fund investments were transferred from the Plan into nexAir, LLC Profit Sharing and 401(k) Plan on February 14, 2025, with participants of the Plan becoming participants in the nexAir, LLC Profit Sharing and 401(k) Plan.

As of the date of these financial statements, the group annuity contract investments have not been transferred to the nexAir, LLC Profit Sharing and 401(k) Plan. The group annuity contract investments are planned to transfer in October 2025.

The Plan has evaluated subsequent events through September 7, 2025, the date the financial statements were available to be issued.
