Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Center for Applied Behavioral Instruction 401(K) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023 and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

1 – DESCRIPTION OF THE PLAN

General

Center for Applied Behavioral Instruction 401(K) Plan (the "Plan") is a defined contribution plan that was established on July 1, 2017 for the benefit of employees of Center for Applied Behavioral Instruction, Inc. (the "Organization"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Eligibility for Participation

Employees are eligible to make voluntary deferral contributions as well as receive employer safe harbor matching or discretionary contributions after attaining age 21 and three consecutive months of service.

Employee Elective Deferral Contributions

Participants may elect to defer a percentage of their annual earnings as their contribution to the Plan, subject to limitations described in the Internal Revenue Code and Plan document. The Plan provides for employee pre-tax and Roth contributions. Employee contributions in the form of rollovers and transfers from other qualified retirement plans are allowed as defined in the Plan document.

Effective January 1, 2025, the Plan document was amended to include an automatic deferral provision. As of this date, all eligible participants who have not made an election to contribute to the Plan, will be enrolled in the Plan with a 4% deferral amount. The deferral percentage will increase by 1% annually up to a maximum of 10%.

Employer Safe Harbor Matching Contributions

The Organization makes matching contributions to the Plan equal to 100% of the participant's contributions up to 4% of eligible compensation.

Discretionary Employer Matching and Nonelective Contributions

The Organization may make discretionary matching and/or nonelective employer contributions that are determined on an annual basis. Nonelective contributions are allocated to participant accounts in the ratio that each participant's eligible compensation bears to total eligible compensation. The Organization did not make discretionary matching contributions for the years ended December 31, 2024 and 2023. The Organization made a nonelective contribution of \$395,000 for the year ended December 31, 2024. The Organization did not make a nonelective contribution for the year ended December 31, 2023.

Vesting

Participants are immediately vested in their voluntary contributions and employer safe harbor matching contributions, plus actual earnings thereon. Vesting in the employer's discretionary matching and nonelective contributions is based on a graded vesting schedule, starting in year 2, whereby the employee is fully vested after 6 years of service.

1 – DESCRIPTION OF THE PLAN (continued)

Participant Accounts

Accounts are maintained for each participant. Accounts are increased for contributions, transfers, and for an allocation of investment income based on the relationship of each participant's account within each investment fund to the total fund. Accounts are decreased for withdrawals made by participants, administrative expenses, and for an allocation of investment losses based upon the relationship of each participant's account within each investment fund to the total fund.

Investment Options

Reliance Trust Company ("Reliance") serves as the Plan's trustee. Upon enrollment into the Plan, participants may direct employee and employer contributions in whole number percentages into a variety of investments offered by Reliance.

Notes Receivable from Participants

A participant may borrow from their account a minimum of \$500 and up to a maximum amount equal to the lesser of \$50,000 or 50% of their vested account balance. A participant may not have more than one loan outstanding at any time. Notes receivable from participants are secured by the balance in the participant's account and bear interest at the prime rate plus 2%. Principal and interest is paid ratably through payroll deductions.

In-service Withdrawals

Participants may make withdrawals prior to termination of employment under the following circumstances:

- Hardship as defined in the Internal Revenue Code and the Plan document
- Upon attainment of age 59 ½
- Withdrawal of rollover contributions account

Retirement Benefits

The normal retirement age under the Plan is age 65. A participant who becomes disabled as defined in the Plan document is eligible for disability retirement.

Payment of Benefits

Upon termination of service from the Organization, a participant may elect to receive the vested portion of their account in the form of a lump sum payment or any other form of settlement available from the manager of the investment fund in which the participant's account or portion thereof is invested. Upon termination of service from the Organization, participants with an accumulated balance of \$7,000 or less will receive a distribution of their vested balance at the direction of the Organization.

Timing of Distributions

Distributions described above shall be made as soon as reasonably practicable following the date the participant's application for distribution is received by the trustee. As of December 31, 2024 and 2023, there were no distributions payable to participants.

Administrative Expenses

Certain administrative expenses incurred by the Plan are paid by the Organization, and certain administrative expenses are paid by the Plan.

Forfeited Accounts

Forfeitures shall be used to pay Plan expenses or reduce any future employer contributions to the Plan. Forfeitures available for use as of December 31, 2024 and 2023 totaled \$1,029 and \$916, respectively. During the years ended December 31, 2024 and 2023, \$19,738 and \$11,687, respectively, of forfeitures were used to offset employer contributions.

Participant-Directed Contributions, Withdrawals and Transfers

The election to allocate contributions between the investment options, and any decision to change such allocation, is made by each participant as permitted under the Plan. Withdrawals and transfers are recorded at the time such transactions take place.

2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared utilizing the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (“GAAP”) requires the Plan Administrator to make significant estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting periods, and, when applicable, disclosures of contingent assets and liabilities at the date of the financial statements. Actual results could differ from those estimates.

Investments

Investments are reported at fair value as described in Note 4. Security transactions are accounted for as of the date the securities are purchased or sold (trade date). Interest income is recorded as earned and may include amortization of discount and premium. Dividend income is recorded on the ex-dividend date or, for certain foreign securities, as soon as the investment funds are informed of the ex-dividend date. Net appreciation (depreciation) includes the Plan’s gains (losses) on investments bought and sold as well as held during the year.

Each participant’s assets are jointly invested and the return on assets is allocated monthly among the participants and recorded as income or loss. The basis of allocation is the unit of participation method. Under this method, contributions and income result in an increase of units of participation while benefits paid and losses result in a decrease of units of participation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

Payment of Benefits

Benefits are recorded when processed and approved for payment.

Risks and Uncertainties

The Plan provides for investment options in various mutual funds that are investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the accompanying Statements of Net Assets Available for Benefits.

Subsequent Events

The Plan evaluated events that occurred after December 31, 2024, the date of the Statement of Net Assets Available for Benefits, but before the date the financial statements were available to be issued, August 22, 2025, for potential recognition or disclosure in the financial statements. Except as described in Note 1, the Plan Administrator did not identify any subsequent events that had a material effect on the accompanying financial statements.

3 – INFORMATION CERTIFIED BY TRUSTEE

Unaudited information included in the Plan's financial statements and supplemental Schedule of Assets (Held at End of Year) was prepared by the Plan's trustee and furnished to the Plan Administrator and includes all Plan assets (except for the effects of participant and employer contributions receivables, if any) and all investment transactions. The Plan Administrator has obtained certifications from the trustee that such information is complete and accurate.

4 – FAIR VALUE MEASUREMENTS

The Plan applies the provisions of GAAP, which establish a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements), a lower priority to significant other observable inputs (Level 2 measurements), and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under these provisions are described below:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

4 – FAIR VALUE MEASUREMENTS (continued)

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

6 – PLAN TERMINATION

Although it has expressed no intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of termination of the Plan, each participant will become 100% vested in their aggregate account balance and will be entitled to a lump sum distribution.

7 – INCOME TAX STATUS

ADP, Inc. obtained an advisory letter from the Internal Revenue Service indicating that its “Non-Standardized Defined Contribution Pre-Approved Plan”, as then designed, is qualified under the Internal Revenue Code Section 401. The Organization has adopted ADP Inc.’s prototype plan for its Plan document.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.

8 – PARTY-IN-INTEREST TRANSACTIONS

Plan investments consist of shares of investment options managed by Reliance. Reliance is the trustee of the Plan’s assets, and therefore, these transactions qualify as party-in-interest.

Administrative services were provided to the Plan by ADP, Inc., the recordkeeper and Strategic Retirement Plan Consultants, the investment advisor, during the years ended December 31, 2024 and 2023.

The Organization provides certain administrative and accounting services at no cost to the Plan. The Organization also pays for certain administrative costs of the Plan.
