INDEPENDENT AUDITOR'S REPORT

To the Administrative Committee of
the Cortec Precision Sheetmetal Inc. 401(K) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Cortec Precision Sheetmetal Inc. 401(K) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Cortec Precision Sheetmetal Inc. 401(K) Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1 - Description of Plan

The following description of the Cortec Precision Sheetmetal Inc. 401(K) Plan (the “Plan”) of Cortec Precision Sheetmetal Inc. (the “Company”) provides general information only. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

a. General

The Plan is a defined contribution plan and was established on January 1, 2000 covering all eligible employees of the Company who have three months of service and are age 21 or older. The Plan is subject to the provisions of the Employment Retirement Income Security Act of 1974 (ERISA).

All salaried employees who are 21 years of age or older and have completed at least three months of service are eligible to contribute to the Plan. Any employee who is 21 years of age or older, has worked at least 1,000 hours each year and is employed on the last day of the plan year is eligible to receive the employer's matching contributions. Independent contractors, employees of a company or division acquired by the Company and nonresident aliens who have no earned income from sources within the United States, or employees represented under a collective bargaining agreement are not eligible to participate in the Plan.

b. Participant Contributions

Each year, participants may contribute any combination of pre-tax elective deferrals and Roth elective deferrals between 1% and 15% of eligible compensation, as defined in the Plan. Participants may contribute up to \$23,000 for the year ended December 31, 2024. Participants who are age 50 and over may make an additional catch-up contribution of \$7,500. Participants between the ages of 60-63 may contribute a higher catch-up contribution amounting to \$11,250. Participants may also contribute amounts representing distributions from other qualified retirement plans (rollover). Contributions are subject to certain IRS limitations.

c. Company’s Contributions

The Company may at its sole discretion, make matching contributions to all eligible participants at a certain percentage of the participant's elective deferrals at the end of the Plan year. The Company also at its discretion makes nonselective contributions to all eligible participants in the Plan. The employer matching contributions are 50% of on the first 6% of the Participants' compensation, which is deferred as an elective deferral. The Company contributed \$304,874 to the Plan in 2024.

d. Participant Accounts

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company's profit sharing contribution and Plan earnings. Participant accounts are charged with an allocation of any administrative expenses that are paid by the Plan to the extent that not paid by the Company. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

e. Rollovers

With the approval of the plan administrator, the Plan may receive any amounts received by an employee as a distribution from another qualified plan provided that the receipt of such amounts does not adversely affect the qualified tax status of the Plan. Participants are fully vested in these amounts.

An aggregate of \$15,000 was rolled into the Plan during the year ended December 31, 2024, and is included in rollovers on the statement of changes in net assets available for benefits.

f. Vesting

Participants are immediately and fully vested in their contributions and gains or losses thereon allocated to their accounts. Participants vest in the employer's discretionary contributions according to the following schedule:

Less than 2 years	0%
At least 2 years, but less than 3	20%
At least 3 years, but less than 4	40%
At least 4 years, but less than 5	60%
At least 5 years, but less than 6	80%
6 Years or more	100%

Participants will be fully vested with the employer's discretionary contributions in the event of death, disability, attainment of normal retirement age or complete or partial termination of the Plan. Forfeitures are allocated to the qualified participants in the ratio that the participant's compensation for the plan year bears to the total compensation of all participants for such plan year.

g. Investment Options

Participants may direct the investment of their contributions into various investment options offered by the Plan, and make changes on their investment options and allocations at any time.

h. Forfeited Accounts

Forfeitures are created when participants terminate employment before they become 100% vested. Forfeitures can be applied to reduce the employer's matching contribution or administrative expenses payable under the Plan. As of December 31, 2024 and 2023, forfeited nonvested accounts totaled \$2,182 and \$13,145, respectively. These accounts will be used to reduce future employer contributions. Also, in 2024, employer contributions were reduced by \$21,138 from forfeited nonvested accounts.

i. Notes Receivable from Participants

Participants may borrow from their accounts. Each participant may have no more than one loan outstanding at any one time. Loan fees and interest due are paid by the participants. Minimum loan amount is \$500; the maximum loan amount cannot exceed the lesser of:

- one-half of the present value of the vested accrued benefit of the participants; or
- \$50,000 (reduced by the excess, if any, of the highest outstanding balance of loans during the one-year period ending on the day before the loan is executed, over the outstanding balance of loans from the Plan on the date the loan is executed).

The maximum repayment period is generally not more than 5 years for a general purpose loan. If the loan is obtained for the purpose of purchasing a primary residence, the loan will be repaid within a period not to exceed 30 years. The loan will bear interest at the prime rate plus 2%. Principal and interest is paid ratably through each pay period. All loans must be secured by not more than 50% of the participant's vested account balance.

j. Deemed Distributions

The Plan treats participant loans that are in default due to a missed payment and outstanding loan balances when a terminated participant takes a distribution as deemed distributions. A loan to an active participant is considered in default on the last business day of the calendar quarter following the calendar quarter in which the loan repayment was due.

j. Deemed Distributions (continued)

In accordance with Internal Revenue Service ("IRS") regulations, a participant who repays a loan after a deemed distribution will receive tax basis credits for repayment of a loan pursuant to IRS rules.

k. Payment of Benefits

A participant may withdraw his or her vested account balance on their retirement date, or make withdrawals based on hardship, death, disability, loans and termination of employment, as defined in the Plan agreement.

A participant who attains normal retirement age shall be entitled to payment of the balance in his or her account. A participant who remains employed after attainment of normal retirement age shall continue to participate under the same terms and conditions as applied prior to reaching normal retirement age. A participant, unless he or she is a more than 5% owner of the Company, must begin receiving distributions no later than April 1 of the calendar year following the calendar year he or she turns 70 ½ or his or her employment terminates.

Note 2 - Summary of Significant Accounting Policies

a. Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles.

b. Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

c. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

d. Investment Valuation and Income Recognition

The Plan's investments are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Investment Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, custodians, and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments purchased and sold as well as held during the year.

e. Note Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses was recorded as of December 31, 2024 and 2023. Delinquent participant loans are recorded as benefit payments based on terms of the plan document.

f. Excess Contributions Payable

Account payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan did not pass the Actual Contribution Percentage ("ACP") Test for the 2024 plan year. The excess contributions of \$977 and \$0 were accrued as of December 31, 2024 and 2023, respectively. The Plan distributed the 2024 excess contributions to the applicable participant prior to March 15, 2025.

g. Payment of Benefits

Benefits paid to participants are recorded when paid.

h. Expenses

Certain expenses of maintaining the Plan are paid by the Company and are therefore excluded from these financial statements. Fees for the administration of notes receivable from participants are included in administrative expenses and charged directly to the participant's account. Investment related expenses are included in net appreciation of fair value of investments.

Note 4 - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

Mutual fund: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Note 5 - Notes Receivable from Participants

The Plan permits its participants to obtain loans against their account balance. Participant loans are collateralized by the respective participant's remaining account balance. At December 31, 2024 and 2023, notes receivable from participants amounted to \$312,196 and \$281,991, respectively.

Note 6 - Tax Status of the Plan

The Plan obtained its latest determination letter on July 8, 2014, in which the Internal Revenue Service stated that the Plan and the related trust, as then designed, were in compliance with the applicable requirements of the Internal Revenue Code. Although the Plan has been amended since receiving the determination letter, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan administrator to evaluate tax positions taken by the plan and recognize a tax liability if the Pan has taken an uncertain position is more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7 - Party-in-Interest Transactions

Certain Plan investments are managed by ADP Company. ADP Company is the trustee and record-keeper for the Plan, and, therefore, these transactions qualify as party-in-interest transactions. The Sponsor Company pays directly for other expenses related to the Plan's operation.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 8 - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts. Any unallocated asset of the Plan should be allocated to participant account and distributed in such a manner as the Company may determine.
