## INDEPENDENT AUDITORS' REPORT

### **Opinion**

A. Description of the Plan:

The following description of the Compass Strategy Solutions (“Company”) 401(k) Plan (“Plan”) provides only general information. Participants should refer to the Plan Agreement and Summary Plan Description for a more complete description of the Plan's provisions.

- (1) General -- The Plan is a defined contribution plan covering substantially all employees of Compass Strategy Solutions (“Employer”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).
- (2) Contributions -- The Company may make a discretionary profit sharing contribution determined annually. Rollovers into the Plan from another qualified plan may be permitted with the consent of the administrator. All Company contributions have met the minimum funding standards set forth by ERISA for the years ended December 31, 2024 and 2023, respectively. Profit sharing contributions for the years ended December 31, 2024 and 2023 were \$137,106 and \$133,152, respectively.
- (3) Participant Accounts -- Each participant's account is credited with the participant's contribution and an allocation of (a) the Company's contribution, (b) Plan earnings (losses), and (c) forfeitures of terminated participants' nonvested accounts and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

- (4) Vesting -- Participants are immediately vested in their voluntary contributions and the employer matching contributions.
- (5) Investment Options -- Upon enrollment in the Plan, participants may direct their contributions be invested in a range of mutual funds and related investments approved by the Trustees. The Plan's assets are invested in these funds through a contract with ADP Retirement Services, which provides record keeping services to the Plan.

ADP Retirement Services maintains the participants' balances in separate pooled accounts and credits each account with earnings on the selected investment options. Participants may change the investment option of their current contributions and account balances at the beginning of each pay period. If allocation percentages are not changed, ADP Retirement Services allocates contribution amounts according to the latest previously filed allocation election.

- (6) Payment of Benefits -- On termination of service due to retirement, death or disability, the participant's entire balance will become fully vested and may be received in a lump-sum distribution. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution.
- (7) Participant Loans-- Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or fifty percent of their vested account balance. The loans are secured by the balance in the participant's account. The loan interest rate is determined as one percent over the prime interest rate at the time of the loan. Principal and interest is paid ratably through monthly payroll deductions.

**B. Summary of Significant Accounting Policies:**

- (1) **Basis of Accounting** -- The financial statements of the Plan are prepared using the accrual method of accounting.
- (2) **Use of Estimates** -- The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.
- (3) **Investment Valuation and Income Recognition** -- The Plan's investments are stated at fair value. Fair value is determined based upon quoted market prices for the underlying registered investments. Investments of funds are recorded on a trade-date basis. Income is allocated to each participant's account and reflects income of the underlying investment fund. Distribution values are calculated to the date of sale of the participant's investments.
- (4) **Payment of Benefits** -- Benefits are recorded when paid.
- (5) **Administrative Expenses** -- The Plan's expenses are paid either by the Plan or the Plan sponsor, as provided by the plan documents. Expenses that are paid directly by the Plan sponsor are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation in fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

C. Investment Contract with Investment Company:

In 2020, the Plan entered into an investment contract with ADP Retirement Services. ADP Retirement Services maintains all contributions in separate, self-directed accounts. The accounts are credited with actual earnings on the underlying investments and charged for participant withdrawals as outlined in the contract. ADP Retirement Services invests the account balances in set mutual funds chosen by the Plan Trustee, Administrator, and Custodian. Each participant may direct his or her own investment mix of the allowed mutual funds and may change the mix at the beginning of any pay cycle via either written paperwork submitted to ADP Retirement Services or electronically via ADP Retirement Services' online, password-protected account services.

D. Fair Value Measurements:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under *FASB ASC 820* are described as follows:

E. Tax Status:

The Plan was effective on January 1, 2020. The Plan is a standardized plan which as designed, is in compliance with the applicable requirements of the Internal Revenue Code. The plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting policies generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. Plan Termination:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan shall be allocated to participant accounts and distributed in such a manner as the Company may determine.

G. Risks and Uncertainties:

The Plan's assets held by ADP Retirement Services are invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

H. Subsequent Events:

The Company has evaluated subsequent events through July 31, 2025, the date these financial statements were available to be issued.

There were no material subsequent events that require recognition or additional disclosure in these financial statements.
