Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Schewel Furniture Company, Inc. 401(k) Retirement Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) audit. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Schewel Furniture Company, Inc. 401(k) Retirement Plan's financial statements performed in accordance with ERISA section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained a certification from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion on the Financial Statements

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section –

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of Schewel Furniture Company, Inc. 401(k) Retirement Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.





Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Schewel Furniture Company, Inc. 401(k) Retirement Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Note 1 - Description of Plan

The following description of the Schewel Furniture Company, Inc. 401(k) Retirement Plan, (the "Plan"), provides only general information. Participants should refer to the Plan agreement or the summary plan description for a more complete description of the Plan's provisions.

General

The Plan, established April 1, 2001, is a defined contribution plan covering substantially all employees of Schewel Furniture Company, Incorporated. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was amended effective April 1, 2020 to add automatic enrollment. The Plan was most recently amended on February 1, 2021 for a change in the third party administrator from Branch Banking and Trust to ADP Retirement Services.

Administration

Schewel Furniture Company, Incorporated (the "Corporation" or the "Employer") is the Plan administrator. As of February 1, 2021, the Plan is administered by ADP Retirement Services. Reliance Trust Company is the Trustee of the Plan.

Eligibility

All employees who have reached 18 years of age and have completed six months of service are eligible to participate in the Plan. Employees who are leased or governed by a collective bargaining agreement are excluded from participating in the Plan. Entry into the Plan is the coinciding or next first date of the quarter.

Contributions

Each year, eligible employees may contribute any whole percentage of annual compensation up to certain limitations in the Internal Revenue Code. Effective April 1, 2020, all participants are automatically enrolled at 4% unless a separate election is made upon entry. Participants may also make Roth elective contributions. A participant's Roth elective contributions are allocated to a separate account maintained for such contributions. Qualified distributions from other qualified retirement plans can also be contributed to the Plan and retained as a rollover contribution.

The Plan provides for an employer discretionary matching provision. In 2024 and 2023, the Corporation matched 100% of the first 2% contributed by the participant, and 50% of the next 2% contributed by the participant. The Corporation can also make a qualified non-elective contribution in an amount determined annually by the Corporation. There were no discretionary non-elective contributions during 2024 and 2023.

Participant accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and, (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the Plan. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Corporation contributions or future Corporation administrative fees. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

A participant normally becomes eligible for benefits after reaching age 65. A participant who becomes permanently disabled, dies, or reaches the normal retirement date while in the employment of the Corporation will have a 100% vested interest in his or her account.

Vesting (continued)

Each participant is 100% vested at all times in his or her salary reduction contributions. Amounts funded by the Corporation for the benefit of each participant become 100% vested after three years of credited service. A participant's vesting schedule is as follows:

Investment options

Upon enrollment in the Plan, participants may direct the custodian of the Plan as to the investment of their account balances in accordance with guidelines established by the Plan.

Notes receivable from participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum of \$50,000. Total loans outstanding may not exceed 50% of a participant's vested account balance. Repayment terms for the loan are five years, unless the loan is for the purchase of a principal residence, in which case, the Plan administrator may permit a longer repayment term, with the loan balance amortized in equal installments over the life of the loan. The loans are secured by the participant's vested account balance. The interest rate will be determined on the first business day of each month and apply to all loans applied for in that month. The interest rate will be the current prime rate listed by the trustee plus 1%. Principal and interest are paid ratably through monthly payroll deductions.

Payment of benefits

Distribution of the vested portion of a participant's account will occur upon the participant's termination, death, disability, hardship withdrawal or retirement, as defined in the Plan. A participant is entitled to payment as a lump sum or in installments.

The Plan allows, in certain hardship situations as defined by the Plan, participants to withdraw from their account balances while actively employed. These hardship withdrawals are subject to Internal Revenue Code restrictions and penalties. In-service distributions may also be made if the participant has attained age 59 ½.

Forfeitures

Plan forfeitures are to be used to pay admin expenses or to reduce the discretionary matching or non-elective contribution for the Plan year immediately following the Plan year in which the forfeitures occur. Forfeited employer contributions used to reduce employer contributions or pay admin fees, including accumulated earnings, totaled \$44,245 and \$35,945, for the years ended December 31, 2024 and 2023, respectively. The total amount forfeited during the years ending December 31, 2024 and 2023 was \$44,179 and \$34,331, respectively. The balance of forfeited employer contributions available to be used to reduce future employer contributions as of December 31, 2024 and 2023 was \$11 and \$10, respectively.

Note 2 - Summary of Accounting Policies

Basis of accounting

The accounting records of the Plan are maintained on the cash basis of accounting. The accompanying financial statements reflect all material adjustments required to place these statements on the accrual basis of accounting.

Investment valuation and income recognition

Investments in mutual funds are stated at quoted market price as of the last day of the year. The collective trust is based on the net asset value (NAV) of the fair value of the underlying assets held at year-end as a practical expedient. Purchases and sales of securities are recorded on a trade-date basis. Participant notes receivable are valued at unamortized loan balances, which approximates fair value. In accordance with the policy of stating investments at current fair value, net realized and unrealized appreciation and depreciation are reflected in the statements of changes in net assets available for plan benefits.

Notes receivable from participants

Participant loan receivables are measured at their unpaid principal balance plus any accrued interest, which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document. Interest income on participant loan receivables is recognized in the period in which it is earned and is recorded as interest income on the statements of changes in net assets available for benefits.

Investment income

Income from investments is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Investment income as shown in the financial statements includes interest, dividends, and appreciation (depreciation) in the fair value of investments, net of investment and asset management fees.

Payment of benefits

Benefit payments to participants are recorded upon distribution.

Administrative expenses

Certain trustee and other fees are paid by the Plan. All other significant costs are paid by the Corporation.

Use of estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Actual results could differ from those estimates.

Credit risk

The Plan invests in various investments securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 3 – Fair Value Measurements

FASB ASC 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.
Level 2	Inputs to the valuation methodology include <ul style="list-style-type: none"> • quoted prices for similar assets or liabilities in active markets; • quoted prices for identical or similar assets or liabilities in inactive markets; • inputs other than quoted prices that are observable for the asset or liability; • inputs that are derived principally from or corroborated by observable market data by correlation or other means. <p style="text-align: center;">If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.</p>
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Interest-bearing cash: Shares of a money market portfolio are valued using amortized cost which approximates fair value.

Mutual Funds: Valued at quoted market prices determined in an active market, which represents the net asset value of the shares held by the Plan at year-end.

Collective trust: Net asset value (“NAV”) as reported by the investment manager based on the value of the underlying assets. The NAV is used as a practical expedient to estimate fair value.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 4 – Plan Termination

Although it has not expressed any intent to do so, the Corporation has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

Note 5 – Tax Status

The Internal Revenue Service has determined by letter dated October 6, 2020, that the Plan is a qualified plan under section 401(a) of the Internal Revenue Code (IRC) and is, therefore, not subject to tax under present income tax laws. The Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan's legal counsel believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes is included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Department of Labor. The plan administrator has analyzed the tax positions taken by the plan, and has concluded that as of December 31, 2024 and 2023, no uncertain positions are taken or are expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to December 31, 2021.

Note 6 - Financial Information Certified by the Trustees of the Plan

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (the trustee of the Plan).

Administrative fees paid by the Plan to ADP, Inc. totaled \$77,140 for the year ended December 31, 2024 and \$77,639 for the year ended December 31, 2023, respectively.

Note 8 – Return of excess contributions

There were no excess employer contributions for 2024 and 2023. In 2024 and 2023, there were excess deferral contributions of \$72 and \$11,970 respectively, which were returned to the participants.

Note 9 – Subsequent Events

The Plan has evaluated subsequent events through August 28, 2025, the date the report is available for issuance. No other events requiring disclosure have been noted.
