INDEPENDENT AUDITORS' REPORT

To the Trustees
Hakes Brothers 401(k) Profit-Sharing Plan and Trust
Las Cruces, New Mexico

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Hakes Brothers 401(k) Profit-Sharing Plan and Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. Basis for Opinion

Our audit did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedules Required by ERISA

The supplemental schedule is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF PLAN

Nature of Activities

Hakes Brothers 401(k) Profit-Sharing Plan and Trust (the Plan) was established and became effective in January of 2012. The following description of the Plan provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

Hakes Brothers, LLC is the Plan sponsor. Employees of Hakes Brothers, LLC may be eligible to participate based on the Plan requirements.

On March 14, 2023 the plan was amended to disallow forfeitures from reducing employer contributions on a per-payroll basis, limiting this adjustment to an annual basis.

General

The Plan is a defined contribution plan that covers all employees of the plan sponsors. Employees may elect to participate through salary deductions and are eligible for employer matching contributions. The Plan is designed to comply with Section 401 and the regulations thereunder of the Internal Revenue Code (the Code), as amended. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Eligibility

The Plan requires participants to be at least 21 years old to be eligible to receive contributions under the plan. Participants must also complete 6 months of service to be eligible to receive contributions under the plan. For service requirements that include an hours requirement, a participant will have met the service requirements as soon as they have met the service requirements regardless if the entire period has passed. For purpose of receiving a contribution, entry date will be the first day of the quarter coincident with or next following the date the participant satisfies the eligibility requirements.

1. DESCRIPTION OF PLAN (CONTINUED)

Contributions

Each year, participants may contribute up to 75 percent of pre-tax annual compensation up to the limitations prescribed by law as defined in the Plan. Participants may also contribute rollover or transfer amounts from other qualified retirement plans or other special individual retirement arrangements.

Upon an annual voluntary election, the trustees make discretionary matching contributions and may make qualified non-elective contributions to the Plan. For the year ended December 31, 2024, the employer elected to make a discretionary matching contribution based on a fixed formula related to the participant's compensation totaling \$913,543. The amount contributed may not exceed the maximum amount deductible under the limitations prescribed by law.

For the year ended December 31, 2024, the Plan Sponsor made safe harbor matching contributions, as required, in amounts equal to 100 percent of each participant's total elective deferral up to the first 3 percent of the participant's compensation and 50 percent matching between 3 and 5 percent of the participant's compensation. The Plan Sponsor has the option to make additional discretionary matching contributions of which there were none made for the year ended December 31, 2024.

Investment Options

All contributions under the Plan are currently invested and are participant directed. Upon enrollment in the Plan, a participant may direct employee and matching contributions in a number of investment options offered by Reliance Trust Company, and also a self-directed brokerage account option.

Participant Accounts

Each participant's account is credited with the participant's contribution and allocations of:

- 1) the employer's contributions
- 2) investment earnings and losses
- 3) investment option fees

Participant Accounts

Allocations are based on salary or account balances as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes Receivable from Participants

Participants may not establish loans from their fund accounts within the Plan.

Vesting

Participants are immediately 100% vested in their respective employee deferrals, the safe harbor matching contributions, rollover contributions, transfer contributions and related earnings or losses.

The Plan utilizes a graded-vesting schedule for profit-sharing contributions as follows:

Payment of Benefits

Upon attaining normal retirement age, early retirement age, retirement due to disability, death and upon termination of the Plan, the participant or designated beneficiary is entitled to the full vested balance of his or her account in the form of a lump-sum amount, installments over the beneficiary's assumed life expectancy, or partial withdrawals if the vested balance exceeds \$5,000. If the vested balance of the participant is less than \$5,000 the beneficiary will receive the full vested balance in the form of a lump-sum amount.

For termination of service due to other reasons, rollover distributions will not count towards the \$5,000 threshold. A participant may receive the value of the vested interest in his or her account as a lump-sum distribution, installments over the beneficiary's assumed life expectancy, or partial withdrawals.

Hardship Withdrawals

Withdrawal of a portion of a participant's account will be permitted due to an immediate and heavy financial need, if it meets IRS requirements.

Forfeited Accounts

Forfeitures are used to reduce employer contributions. For the years ended December 31, 2024 and 2023 forfeited amounts were used to reduce employer contributions by \$230,195 and \$95,113, respectively.

Plan Termination

Although they have not expressed any intent to do so, Hakes Brothers, LLC has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Tax Status

On January 12, 2012, the Plan adopted a Non-Standardized Pre-Approved Profit Sharing/Money Purchase/CODA, whereby the Internal Revenue Service issued an opinion and informed the Plan Sponsor by a letter dated October 6, 2020, that the prototype plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (the Code). The Plan Administrator believes the Plan, as amended, is designed and is currently being operated in compliance with the applicable requirements of the Code.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements presented have been prepared under the accrual method of accounting.

Use of Estimates in Preparing Financial Statements

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amount of assets, liabilities, and changes therein, and in disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

In compliance with the Department of Labor's Rules and Regulations for Reporting and Disclosure Under ERISA, the Plan values its investments at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Realized and unrealized gains and losses on investments are reflected in the Statement of Changes in Net Assets Available for Benefits. Purchases and sales of investments are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Investment Valuation and Income Recognition

Investments held are stated at fair market value and, as such, their reported value for financial statements purposes is subject to market fluctuations. Accordingly, the price which may be realized upon the sale of the respective investment may not be equal to its value as currently presented.

Payment of Benefits

Benefit distributions are recorded when paid.

Administrative Expenses

The Plan permits the payment of Plan expenses to be made from the Plan's assets. These expenses will generally be allocated either proportionately based on the value of the account balances or as an equal dollar amount based on the number of participants in the Plan. The method of allocating the expenses depends on the nature of the expense itself. Other material administrative expenses incurred by the Plan are paid by the Company. For the year ended December 31, 2024, the participant accounts were charged \$32,506.

Subsequent Events

Management evaluated subsequent events through September 3, 2025, the date the financial statements were available to be issued.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

6. INVESTMENT CONTRACTS

8. RISK AND UNCERTAINTIES

Certain The Plan invests in various investment securities. Investment securities that are exposed to various risks such as interest rate, market, and credit risk, Due to the level of risk associated with certain investments securities, it is at least reasonably possible that changes in values of investments securities will occur in the near term and that such changes could materially affect the participants' account balances and the amounts reported in the statements of net assets available for benefits.

9. LEGISLATIVE CHANGES

On December 23, 2022, Congress passes the Consolidated Appropriations Act of 2023 which included SECURE Act 2.0. SECURE Act 2.0 contains over 90 new retirement provisions, with varying effective dates through 2027. Since SECURE Act 2.0 provisions include both required and optional elements, the plan administrator will determine the optional provisions to elect and amend the Plan document accordingly. Most of the significant provisions became effective in 2024 and thereafter.
