- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters – Supplemental Schedule Required by ERISA

Note 1. Plan Description

The following description of the Chicago Review Press Retirement Savings Plan provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was established on January 1, 1994. The Plan is a defined contribution plan that provides benefits to eligible employees of Chicago Review Press Inc. (Company) and its wholly owned subsidiary Triumph Books, LLC. The Plan is subject to the provisions of *the Employee Retirement Income Security Act of 1974* (ERISA), as amended by subsequent legislation.

Eligibility

All employees of the Company, as defined, who have completed one month of service and are age 21, or older, are eligible to participate in the Plan. Participation in the Plan may begin on the first day of the month following satisfaction of the eligibility requirements.

Contributions

The Plan Provides for employee 401(k) deferral contributions up to a maximum of 99% of the annual pretax compensation, subject to limitations established by the Internal Revenue Code (IRC). Participants are also allowed to make after-tax Roth 401(k) contributions, which are also subject to IRC limitations.

Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan.

The Company makes a safe harbor matching contribution equal to 100% of each participant's deferral contribution not to exceed 4% of each participant's compensation. For purposes of calculating this safe harbor matching contribution, the participant's compensation and deferrals will be computed for each payroll period. Each year, the employer may also make a discretionary non-elective profit-sharing contribution. Employees must be employed on the last day of the year or have worked 499 hours during the plan year in order to receive a reliable share of the discretionary contribution. No such contributions were made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and related employer contributions and allocations of plan earnings or losses and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Payments of Benefits

Upon termination of service, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or annual installments if the participant is subject to required minimum distributions. In-service withdrawals starting at age 59 ½ and hardship withdrawals are also permitted by the Plan. Hardship withdrawals are allowed under the provisions of the Plan and cannot exceed the amount required to meet the immediate financial need created by the hardship. The participant will be suspended from making contributions for six months after the hardship withdrawal.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The maximum number of Plan loans that a participant may have outstanding at any time is 2. The loans are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined quarterly by the plan administrator.

Principal and interest are paid ratably through payroll deductions over a period not to exceed five years. However, if the loan is for the purchase of a principal residence, the plan administrator may permit a longer repayment term.

Vesting

Participants are immediately vested in all employee deferral and employer contributions and any income or loss thereon.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$7,799 and \$7,422, respectively. Forfeited account balances can be used to pay plan expenses or used to reduce cash requirement of company discretionary contributions. No forfeitures were used to reduce employer contributions or plan expenses during the year ended December 31, 2024.

Administrative Expenses and Revenue Sharing Account

The Company may directly pay some Plan administration expenses rather than using Plan assets to pay the expenses. To the extent the Company does not pay Plan expenses, the Plan generally will pay the expenses of Plan administration and will assess the expenses paid against the accounts of all participants in the Plan.

The Plan shares in investment related revenue, which Reliance Trust Company (Reliance), the trustee, receives from mutual funds or collective trusts attributable to the Plan assets invested in such mutual funds and trusts. The Plan receives a credit for the revenue share on a quarterly basis which is deposited into an ERISA Budget Account. The Company can use the funds in the account to pay for certain approved plan related expenses. During 2024, the total revenue share deposited into the ERISA Budget Account was \$8,628, all of which was applied to Plan administrative expenses during 2024.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and the disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Investment Committee determines the Plan's valuation policy. See Note 4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold during the year as well as held at year end.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in the administrative expenses when incurred. As of December 31, 2024

and 2023, no allowance for credit losses has been recorded. If a participant does not make loan repayments and the plan administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Payments of Benefits

Benefit payments to participants are recorded upon distribution.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Reliance Trust Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income and interest income from notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023:

- Mutual funds - Mutual funds are valued at the daily closing price, as reported by the fund. The mutual funds held by the Plan are actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Related Party and Party-in-Interest Transactions

Certain officers and employees of the Company provide administrative and trustee services to the Plan which are not reimbursed by the Plan. The Company pays for certain other administrative fees related to the Plan.

Reliance Trust Company is the Plan's trustee and, therefore, qualifies as a party-in-interest. Certain Plan assets are managed by Reliance Trust Company and its affiliates. Transactions in such investments qualify as party-in-interest transactions which are exempt under the prohibited transaction rules.

ADP Retirement Services is the Plan's record keeper and, therefore, qualifies as a party-in-interest. Administrative fees paid to ADP Retirement Services amounted to \$3,780 during the year ended December 31, 2024.

ADP, LLC (ADP) provides certain administrative services to the Plan pursuant to an Administrative Services Agreement (the Agreement) between the Plan and ADP. ADP receives revenue from investment funds for services ADP provides to the funds. If revenue received by the ADP from such investment funds exceeds the amount owed under the Agreement, ADP remits the excess to the Plan's trust on a quarterly basis. This revenue is used to offset certain amounts owed to ADP for its administrative services to the Plan. The Plan paid service fees of \$21,006 from this account during the year ended December 31, 2024.

Revenue credits amounted to \$28,510 during the year ended December 31, 2024. The Plan had \$12,024 revenue credits available at December 31, 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

Note 6. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to terminate the Plan at any time subject to the provisions of ERISA. In the event of termination, participants become 100% vested and Plan assets will be distributed to participants based on their individual account balances.

Note 7. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Ascensus, LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 8. Risks and Uncertainties

The Plan invests various investment instruments. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Note 9. Reconciliation of Financial Statements to Form 5500 Financial Information
