Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Sterling Drive Ventures/Rodon Employees 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). (1) Description of Plan

Effective January 1, 2017, Sterling Drive Ventures, L.P. (the Company) created The Sterling Drive Ventures/Rodon Employees 401(k) Plan (the Plan). The Plan is a spin-off of the Rodon/K'NEX Employees 401(k) Plan. The following description of the Plan provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Sterling Drive Ventures, LP, Rodon Group, LLC and Rodon Limited Partnership (collectively, the Employers) who have completed three months of continuous employment.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Rodon Group 401(k) Plan Retirement Committee (Committee) is responsible for oversight of the Plan, determines the appropriateness of the Plan's investment offerings, monitors investment performance and reports to the Plan's trustees.

Contributions

Each year, participants may contribute between 1% and 100% of their eligible pre-tax compensation, as defined in the Plan. Annual salary deferrals are limited to the maximum allowable under the Internal Revenue Code (IRC) (\$23,000 in 2024). Participants who have attained age 50 before the end of the year are eligible to make catch-up contributions (a maximum of an additional \$7,500 during 2024). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contributions plans (rollover). The Plan also permits Roth deferral contributions. Participants direct the investment of all contributions into various options offered by the Plan. The Plan includes an auto-enrollment feature whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 5% of eligible compensation and their contributions invested in a designated hybrid collective investment fund until changed by the participant. Automatically enrolled participants will have their deferral rate increased each April 1 by 1% of eligible compensation until their elective deferral percentage equals 15%, unless otherwise specified by the participant.

For each plan year, the Company may contribute to the Plan, at its discretion, a matching contribution, a profit-sharing contribution, and/or a safe harbor 401(k) contribution. There were no discretionary matching contribution, profit-sharing contribution, or safe harbor employer contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's contribution and the Company's discretionary matching contributions, as well as allocations of the Company's discretionary profit-sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Participants are also immediately vested in safe harbor 401(k) contributions and Qualified Non-Elective Contributions made by the Company. Vesting in the Company's matching and profit-sharing contribution portion of their accounts is based on years of service according to the following schedule:

Years of Service	Vested Percentage
Less than 3	0%
3 or more	100%

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms are for a period not to exceed five years unless the loan qualifies for the purchase of a principal residence. The loans are secured by the balance in the participants' accounts and bear interest at a rate as determined by the plan administrator. The interest rates on loans outstanding at December 31, 2024 range between 4.25% and 9.50%. Principal and interest are paid through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement or for other reasons, a participant with an account balance in excess of \$7,000 may elect to receive the value of the vested interest in his or her account as a lump sum distribution, annuity, direct rollover distribution, or as a combination of cash and direct rollover distribution. A terminated participant with an account balance less than \$7,000, without respect to rollover balances, will receive a lump-sum payment of the balance.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$9,708 and \$8,016, respectively. These accounts will be used to pay administrative expenses of the Plan or reduce future employer contributions. During 2024, the Plan did not use any forfeitures to pay plan expenses or to reduce employer match contributions.

Administration

The Plan's administration and discrimination testing are performed by The MandMarblestone Group, LLC.

(2) Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's Committee determines the Plan's valuation policies utilizing information provided by the investment advisers, plan trustees and insurance company. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Contributions from plan participants and matching and profit sharing contributions from the Employers, as applicable, are recorded in the year in which the employee contributions are withheld from compensation.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants and participant fees are charged directly to the participants' accounts and are included in administrative expenses. Investment related expenses are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through September 5, 2025, the date the financial statements were available to be issued.

(3) Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Reliance Trust Company (Reliance), the qualified institution.

(4) Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology on adjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement.

Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to methodologies used in December 31, 2024 and 2023.

Registered investment companies: Valued at the daily closing price as reported by the fund. Registered investment companies held by the Plan are open end registered investment companies that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. Registered investment companies held by the Plan are deemed to be actively traded.

Common investment trusts: Valued at the NAV of units of bank collective trusts. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the funds less their liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

(5) Related Party and Party-In-Interest Transactions

Plan investments includes units of common investment trusts managed by Reliance. Reliance is the trustees of the Plan, Automatic Data Processing, Inc (ADP), is the recordkeeper, and, therefore, transactions with these entities qualify as party-in-interest transactions, which are exempt under the prohibited transaction rules. Fees incurred by the Plan for the investment management services are included in net appreciation in the fair value of the investments.

(6) Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become 100% vested in their accounts.

(7) Tax Status

The Plan utilizes a non-standardized pre-approved plan document sponsored by MandMarblestone PC. The non-standardized pre-approved plan document received a letter from the IRS dated June 30, 2020, as to the prototype plan's qualified status. The plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting policies generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

(8) Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that, such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
