Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Indian Nation Wholesale 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for plan benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for plan benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained a certification from Delaware Charter Guarantee and Trust Company d/b/a Principal Trust Company, a qualified institution, as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP).
- The certified investment information in the accompanying financial statements agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).



Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audit* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. 1. Plan Description

Effective January 1, 2001, Stephenson Wholesale Company, Inc. d/b/a Indian Nation Wholesale Company (the Company, Employer, or Plan Sponsor) adopted the Indian Nation Wholesale Employee 401(k) Plan (the Plan). The following plan description provides only general information. Participants should refer to the Plan agreement for a complete description of the Plan's provisions.

General

The Plan is a defined contribution plan generally covering full-time employees who are 21 years of age or older and who have completed one year of service at the Plan's entry date on the first day of each calendar month. The Plan is intended to conform to and qualify under Section 401 and 501 of the Internal Revenue Code of 1986 (IRC), as amended. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Plan Administration

The Company is responsible for the administration and operation of the Plan. The Plan's Trustee and recordkeeper is Principal Trust Company (the Trustee or Recordkeeper).

Contributions

Participants may elect to defer up to 100% of their regular pay up to the maximum allowed by the IRC. Participants are automatically enrolled in the Plan with contributions of 1%. Participants who are age 50 or older can make additional pre-tax contributions known as "Catch-Up Contributions", subject to certain limitations. Rollover contributions are also permitted from a participant's personal or prior employer tax deferred retirement accounts. Participants can change or suspend their contributions at any time.

Participants may receive the Employer matching contributions if they are a participant in the Plan on at least one day of the Plan's fiscal year, which ends on December 31, and make employee contributions during the year. The Employer matching contribution for each pay period is equal to 100% of a participant's contribution, up to a maximum of 3% of the participant's regular pay. The Employer also may elect to make a profit-sharing contribution based on a formula designed to ensure that each participant receives the same profit-sharing contribution when expressed as a percentage of the participant's regular pay. For the 2024 plan year, there were no profit-sharing contributions made by the Employer.

Participant Accounts

Each participant account is credited with the participant's contributions and allocations of the Employer contributions and plan earnings or losses thereon.

Vesting

Participants are immediately vested in their employee contributions plus actual earnings thereon. Participants vest ratably at a rate of 33% per year starting after one year of employment and become fully vested in the Employer matching contributions and profit-sharing contributions upon the completion of the participant's third year of service.

Forfeitures

Forfeitures may be used to reduce future plan expenses or to offset Employer contributions. As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$562 and \$5,116, respectively. For the year ended December 31, 2024, the Company used \$7,904 of forfeitures to reduce the Company's administrative expenses.

Administrative Expenses

Substantially all costs and expenses of the Plan and its administration, including recordkeeping service fees, accounting services and trustee services, are paid by the Plan Sponsor. Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company, including recordkeeping service fees, accounting services and trustee services are excluded from these financial statements. Fees related to the administration of distributions not paid by the Company are charged directly to the participant's account and are included in administrative expenses.

Payment of Benefits

The benefit to which a participant is entitled is that which can be provided from the participant's vested account. The Plan provides retirement benefits for participants at the normal retirement date or later if the participant desires to continue employment. Benefits are also payable to participants or their designated beneficiaries upon the death, disability, or other limited circumstances of the participant. The Plan allows in-service and hardship withdrawals if certain criteria are met.

Notes Receivable from Participants

Loans are not permitted under the Plan.

2. Significant Accounting Policies

Basis of Accounting

The Plan's financial statements have been prepared on the accrual method of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (GAAP) requires management to make estimates and assumptions that affect certain reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions and Contribution Receivables

Contributions are recorded in the period the Plan Sponsor makes payroll deductions from compensation. There were no participant and employer contribution receivables at December 31, 2024. Participant and employer contribution receivables at December 31, 2023 were \$5,875 and \$3,609, respectively.

Investment Valuation and Income Recognition

Investments are stated at fair value or contract value. Fair value is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements. The guaranteed investment contract is recorded at contract value (see Note 5). Contract value is the relevant measurement attributable to fully benefit-responsive investment contracts because the contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The contract value of the fully benefit-responsive investment contracts represents contributions plus earnings, less participant withdrawals and administrative expenses.

Purchases and sales of investments are recorded on a trade date basis. Dividends are recorded on the ex-dividend date and interest income is recorded on the accrual basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Subsequent Events

On April 8, 2024, the Company acquired Standard Distributing Company, dba Sapulpa. Although the acquisition occurred during the plan year ended December 31, 2024, the Sapulpa 401(k) Plan was not merged into the Plan until after December 31, 2024. As a result, all assets and liabilities of the Sapulpa 401(k) Plan, which had a net asset value of \$706,659, were transferred to the Plan subsequent to December 31, 2024. Accordingly, the accompanying financial statements as of and for the year ended December 31, 2024, do not reflect the effects of the plan merger.

The Plan has evaluated subsequent events through August 28, 2025, the date the financial statements were available to be issued, and has determined that no other events have occurred that require disclosure.

3. Certified Investment Information

Certain information disclosed in the accompanying financial statements and ERISA-required supplemental schedule, related to investments held as of December 31, 2024 and 2023, and net appreciation in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by Principal Trust Company, a qualified institution.

4. Fair Value Measurement

The accounting standards establish a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions. A financial instrument's level within the fair value hierarchy is based on the lowest

level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 or 2023.

The following is a description of the valuation methodologies used for the investments measured at fair value, including the general classification of such instruments pursuant to the valuation hierarchy.

Mutual Funds - The shares of registered investment companies are valued at quoted market prices in an exchange and active market, which represent the net asset values of shares held by the Plan at year end and are classified as Level 1 investments.

Collective Investment Trusts - The fair value of participation units held in collective investments trusts are based on the net asset values (NAV) reported by the fund managers as of financial statement dates and recent transaction prices. The NAV is used as a practical expedient to estimate fair value. The investment objective of the collective investments trusts is to provide preservation of capital and provide relatively stable returns consistent with a low risk profile. The collective investments trusts provide for daily redemptions by the Plan at reported net asset values per share, with no advance notice requirement.

5. Investment Account with Insurance Company

Contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits of a defined-contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The fixed income guaranteed account with Principal Life Insurance Company is fully benefit-responsive, therefore contract value is the relevant measurement attribute for that portion of the net assets available for plan benefits attributable to the investment contract. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The guaranteed investment contract promises contract value for a benefit event, such as a termination, death, disability, or retirement. However, there is a market value adjustment, which is also called a surrender charge, when funds are withdrawn prior to their maturity, such as a withdrawal from the account for a change in investment option. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

The guaranteed investment contract earned a fixed rate of return of 1.90% to 2.55% in 2024.

6. Income Tax Status

The Plan adopted a prototype plan agreement established by an affiliate of the Trustee. The Internal Revenue Service (IRS) has determined in an opinion letter dated June 30, 2020, that the prototype plan agreement, as amended, complies with the appropriate sections of the IRC. The Plan has not filed for its own determination letter. However, Plan management believes that the Plan is designed and is currently being operated in compliance with the applicable sections of the IRC.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions

taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of the liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

7. Risk and Uncertainties

Plan assets are invested in funds and securities as directed by plan participants. These investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Accordingly, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements and participant account balances.

8. Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants' accounts will become fully vested and nonforfeitable.

9. Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are managed by Principal Life Insurance Company and Principal Trust Company and as such these transactions qualify as party-in-interest transactions, which are exempt from prohibited transaction rules.
