We have performed audits of the financial statements of TriValley Primary Care, P.C. 401(k) Profit Sharing Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). **1. DESCRIPTION OF PLAN**

The following brief description of the TriValley Primary Care, P.C. 401(k) Profit Sharing Plan (the Plan) is provided for general information purposes only. Plan participants should refer to the Plan agreement for more complete information.

**Organization and Participation**

The Plan is a defined contribution plan established for the purpose of providing employees of TriValley Primary Care, P.C. (the Company) with certain retirement benefits. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Employees of the Company are eligible to participate in the Plan once they have completed one year of service of at least 1,000 hours and are age 21 or older. The enrollment period for the Plan is on the first day of January or July following the date the eligibility requirements are met.

**Contributions**

Each year participants may contribute a percent of pretax annual compensation, as defined in the Plan, subject to limitations imposed by the Internal Revenue Code. The Plan also allows catch up contributions. The Plan permits that amounts may be rolled over from other qualified plans and shall always be fully vested. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants may increase or decrease their deferral percentage on the first day of January, April, July, and October of each year. The Plan is a safe harbor plan. The safe harbor Company matching contribution is 3% of annual participant compensation. The safe harbor match allows the Plan to maintain “safe harbor” status.

In addition to the safe harbor match, the Company also has a discretionary match for non-highly compensated employees. The discretionary match is 25% of the first 4% of participant contributions to the Plan.

Each year, the Company can elect to make a discretionary contribution to the Plan’s profit sharing feature at the option of the Company’s Board of Directors. An employee must be 21 years of age, have completed 1,000 hours of service during the Plan year and be employed on the last day of the Plan year in order to receive the profit sharing contribution. For the years ended December 31, 2024 and 2023, the discretionary profit sharing contribution was \$0 and \$95,750, respectively.

**Participant Accounts**

Each participant’s account is credited with the participant’s contribution and allocations of (a) the Company’s contributions, and (b) Plan earnings, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their contributions and the safe harbor match contributions plus actual earnings thereon. Vesting in the Company’s discretionary match and profit sharing contributions is based on years of continuous service. A participant is fully vested in the discretionary match and discretionary profit sharing after six years of service. Participants are fully vested upon normal retirement age, death or disability.

**Notes Receivable from Participants**

Participants may borrow from the vested portion of their fund accounts a minimum of \$1,000 up to a maximum of \$50,000, with no maximum number of loans outstanding. The notes are secured by the balance in the participant's account and bear interest at rates which are commensurate with local prevailing rates as determined by the Plan administrator. Interest rates are 9.5% per annum. Principal and interest are paid ratably through payroll deductions.

**Payment of Benefits**

Participants may receive distributions due to termination, retirement or death. For any distribution for reasons other than death, a participant will receive a lump sum payment. For a distribution on account of death before the distribution of the account begins, distribution of the entire account must be completed by December 31 of the calendar year containing the fifth anniversary of the participant's death.

**Forfeitures**

The non-vested portion of accounts of participants who terminate employment are either reallocated to the remaining participant accounts or they may be used to reduce the Company's contributions to the Plan. For the years ended December 31, 2024 and 2023, the Company used \$4,182 and \$7,913, respectively, to reduce the employer contributions.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are presented on the accrual basis of accounting.

**Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Capital gain dividends are reported as dividends. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

**Payment of Benefits**

Benefits are recorded when paid.

**Operating Expenses**

Certain operating expenses are paid by the Company and are therefore excluded from these financial statements. Certain administrative expenses as well as mutual fund fees are charged directly to the participant's account.

**3. FAIR VALUE MEASUREMENTS**

Accounting standards provide a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under generally accepted accounting principles are described on the next page.

**4. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become fully vested in their accounts.

**5. TAX STATUS**

The Internal Revenue Service has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

The Plan's federal Form 5500, *Annual Return/Report of Employee Benefit Plan*, for the previous three years remains subject to examination by the Internal Revenue Service.
