As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

Opinion

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Freeman Employee Savings Plan's ability to continue as a going concern within one year after the date that these financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Note 1. Description of the Plan

General

The following description of the Freeman Employee Savings Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by Freeman Health System (Health System) for the benefit of its employees. Related employers who also participate in the Plan include Freeman Neosho Hospital and Ozark Center. An employee is eligible to participate in the Plan and has salary reduction contributions made on his or her behalf on his or her first day of employment. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Lincoln Financial Group Trust Company, Inc. is the trustee of the Plan. In addition, Lincoln National Life Insurance Company and Empower Retirement serve as Plan custodians for certain plan assets.

Contributions

The Plan permits eligible employees through a salary deferral election to have the Health System make annual contributions of up to 100% of eligible compensation. Employee rollover and catch-up contributions are also permitted. The Plan allows for special code Section 403(b) catch-up contributions for those participants with 15 years of service. Contributions are subject to certain limitations. The Plan also allows for Roth contributions to the Plan. These contributions are made on an after-tax basis subject to the rules contained in the Internal Revenue Code (IRC).

Participant Investment Account Options

Investment account options available include various funds offered by the Plan. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily. Alternatively, participants may elect to have a self-directed brokerage account.

Participant Accounts

Each participant's account is credited with the participant's contribution and plan earnings and is charged with administrative expenses as defined by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefits to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their voluntary contributions plus earnings thereon.

Payment of Benefits

Upon termination of service, participants with account balances that do not exceed \$1,000 will receive a lump-sum distribution. Participants with account balances exceeding \$1,000 but less than \$5,000 will have their balance directly rolled over to an individual retirement account as designated by the plan administrator, unless the participant elects a direct distribution or other eligible direct rollover. Participants with account balances of \$5,000 or more may elect to receive a lump-sum amount equal to the value of their account.

Notes Receivable from Participants

The Plan Document includes provisions authorizing loans from the Plan to active eligible participants. Loans are made to any eligible participant demonstrating a qualifying need. The minimum amount of a loan shall be \$500 and only one loan may be outstanding at any given time. The maximum amount of a participant's loan is determined by the available loan balance restricted to the lesser of \$50,000 or 50% of the participant's vested account balance. All loans are covered by demand notes and are repayable over a period not to exceed five years (except for loans for the purchase of a principal residence) through payroll withholdings unless the participant is paying the loan in full. Interest on the loans is fixed at 1% (1%) above the prime rate.

Notes receivable from participants are reported at amortized principal balance plus accrued but unpaid interest. If a participant terminates employment, all outstanding loans must be repaid in full or the loan will be considered to be in default and reported as a taxable distribution to the participant. A loan is also considered to be in default if any scheduled payment is not paid in the amount required by the terms of the loan. The participant can cure the default by making all overdue payments within the last day of the calendar quarter following the calendar quarter in which the participant missed the scheduled payment. In the event of default, the outstanding balance of the loan, including accrued interest, will be treated as a deemed distribution subject to federal income tax.

Notes receivable from participants are repaid using direct debit from the participants' bank account. This function is facilitated by the Plan's trustee, Lincoln Financial Group Trust Company, Inc.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Charles Schwab self-directed brokerage account holds investments which are not standard options of the Plan and are directed by the participants. Self-directed brokerage account primarily consists of mutual funds that are valued on the basis of readily determinable market prices.

Fully benefit-responsive investment contracts are valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administrative expenses.

Pooled separate accounts are valued at the net asset value (NAV) of shares held by the Plan at year-end, net of an investment management fee, as estimated by Lincoln National Life Insurance Company as a practical expedient to estimate fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefit payments to participants are recorded upon distribution.

Administrative Expenses

Administrative expenses may be paid by the Health System or the Plan, at the Health System's discretion.

The Plan has established a nonallocated plan expense account to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Health System is responsible for determining what expenses the third-party administrator will reimburse from the account. All funds utilized from this account are treated as administrative expenses on the statement of changes in net assets available for benefits. Increases to the account from revenue sharing were \$260,824 and \$221,232 for 2024 and 2023, respectively. From the total revenue sharing received in 2024 and 2023, \$0 and \$104,900 were allocated to participants' accounts as earnings, respectively. Administrative expenses of \$156,105 and \$164,950 were paid from the account in 2024 and 2023, respectively. The account's balance at December 31, 2024 and 2023, was \$302,331 and \$164,304, respectively, and is included in the stable value account, which is included in investments at contract value, on the statements of net assets available for benefits.

Note 3. Certification of Plan Trustee and Custodians

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc., and Lincoln National Life Insurance Company, qualified institutions, have certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule are complete and accurate:

- Investments and notes receivable from participants as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Net investment income and interest income on notes receivable from participants as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information and notes receivable from participants included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Related Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments include an insurance contract and pooled separate accounts managed by Lincoln National Life Insurance Company, which is a custodian of the Plan and an entity related to Lincoln Retirement Services Company, LLC (LRSC), which is the record-keeper for the Plan. Certain plan investments include an insurance contract managed by Empower Retirement, which is a custodian for the Plan. These custodians qualify as parties-in-interest. The Plan paid direct administrative expenses of \$456,278 and \$401,702 to LRSC during 2024 and 2023, respectively.

The Plan incurs expenses related to general administration and record-keeping. A part of these expenses and certain legal and accounting and auditing fees relating to the Plan are paid by the Health System.

Note 5. Disclosure About Fair Value of Plan Assets

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Investments

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 securities held by the Plan.

Investments Measured Using the Net Asset Value per Share Practical Expedient

The following table summarizes investments for which fair value is measured using the net asset value per share practical expedient as of December 31, 2024 and 2023. There are no participant redemption restrictions for these investments; the redemption period is only applicable to the Plan.

(A) Pooled separate accounts invest primarily in domestic and international stocks, bonds, or mutual funds. The pooled separate accounts investment is based on the value of accumulation units or price per share of the underlying investments beginning with a price determined by the custodian and the number of units issued is calculated to match the current fair value of the underlying securities. There is no restriction on the redemption of these funds.

Note 6. Investment Contracts with Insurance Companies

The Plan holds investment contracts. These contracts meet the fully benefit-responsive investment contract criteria and therefore are reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses.

There are no reserves against contract value for credit risk of the contract issuers or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuers. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contracts do not permit the insurance companies to terminate the agreements prior to the scheduled maturity date.

Note 7. Plan Termination

Although it has not expressed an intention to do so, the Health System has the right under the Plan to terminate the Plan, subject to the provisions of ERISA.

Note 8. Tax Status

The Plan operates under a volume submitter 403(b) plan document sponsored by Lincoln Retirement Services Company LLC. This volume submitter plan document has been filed with the appropriate agency and has obtained an advisory letter from the Internal Revenue Service stating that the volume submitter satisfies the requirements under section 403(b) of the Internal Revenue Code. The Plan has not requested or obtained a determination letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and not subject to tax.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
