### ***Scope and Nature of the ERISA Section 103(a)(3)(C) Audit***

We have performed audits of the financial statements of Freeman Retirement Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Freeman Retirement Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in *Note 3* to the financial statements, is complete and accurate.

### ***Opinion***

## **Note 1. Description of the Plan**

### ***General***

The following description of Freeman Retirement Plan (Plan) provides only general information. Participants should refer to the Plan Document and *Summary Plan Description* for a more complete description of the Plan's provisions, which are available from the plan administrator.

The Plan is a defined contribution plan sponsored by Freeman Health System (Health System) covering substantially all employees who are age 21 or older. In order to receive a contribution, participants must have worked at least 1,000 hours per year and be employed on the last day of the plan year or terminated employment during the plan year due to death, disability, retirement, or early retirement. Related employers who also participate in the Plan include Freeman Neosho Hospital and Ozark Center. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA). Lincoln Financial Group Trust Company, Inc. is the trustee of the Plan.

### ***Contributions***

Each year, the Health System contributes a discretionary percentage, determined by the Health System's Board of Directors, of each participant's covered compensation. The contribution is based on a participant's contribution to the Health System's 403(b) plan. For 2024 and 2023, a matching contribution of the participant's contributions to the 403(b) plan was made by the sponsor to the participant's account, but not more than 3% of the participant's compensation for the plan year. Certain rollover contributions may be permitted. Contributions are subject to certain limitations.

### ***Participant Investment Account Options***

Investment account options available include various funds offered by the Plan. Each participant has the option of directing their contributions into any of the separate investment accounts and may change the allocation daily. Alternatively, participants may elect to have a self-directed brokerage account.

### ***Participant Accounts***

Each participant's account is credited with the Health System's contribution, plan earnings, or forfeitures of terminated participants' nonvested accounts and is charged with administrative expenses as defined by the Plan. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### ***Vesting***

Participants are 100% vested in their voluntary rollover contributions plus earnings thereon for rollover contributions made to the Plan. Vesting in the Health System's contribution portion of their accounts plus earnings thereon is based on years of continuous service. A participant is fully vested after five years of continuous service. The nonvested balance is forfeited upon distribution following termination of service or a five-year break in service.

### ***Payment of Benefits***

Upon termination of service, death, disability, or retirement, participants who were employed prior to July 1, 2000, may elect to receive either a lump-sum amount equal to the value of their vested account or choose from a list of annuity options. Participants employed after July 1, 2000, will receive a lump-sum payment equal to the value of their vested account for balances less than \$1,000. Balances greater than \$1,000 but less than \$5,000 are to be rolled over to an individual retirement account designated by the Plan, absent an election by the participant. Effective November 1, 2024, the Plan was amended such that all balances of \$5,000 or less are rolled over to an individual retirement account absent an election otherwise. Participant balances of \$5,000 or more may remain in the Plan until such time the participant elects to receive a lump-sum payment.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$334,100 and \$196,086, respectively. These accounts will be used to pay plan administrative expenses or to reduce future employer contributions, and the remaining balances are available to be reallocated to participants in the proportion that each participant's compensation for that plan year bears to the total compensation paid to all such participants for that plan year. For the years ended December 31, 2024 and 2023, plan administrative expenses were reduced by \$0, and employer contributions were reduced by \$196,620 and \$447,813, respectively, from forfeited nonvested accounts.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The accompanying financial statements are prepared on the accrual basis of accounting.

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts. Contract value is the relevant measure for the portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value is the amount participants normally would receive if they were to initiate permitted transactions under the terms of the Plan.

***Use of Estimates***

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of net assets, changes in net assets, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Quoted market prices, if available, are used to value investments. Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year-end. The Charles Schwab self-directed brokerage account holds investments which are not standard options of the Plan and are directed by the participants. Self-directed brokerage accounts primarily consist of mutual funds and common stocks that are valued on the basis of readily determinable market prices.

The stable value account is a fully benefit-responsive investment contract valued at contract value. Contract value represents contributions made under the contract, plus interest at the contract rate, less participant withdrawals and administration expenses.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains on investments bought and sold as well as held during the year.

***Payment of Benefits***

Benefit payments to participants are recorded upon distribution.

***Administrative Expenses***

Administrative expenses may be paid by the Health System or the Plan, at the Health System's discretion.

The Plan has established a nonallocated plan expense account to pay necessary and reasonable plan related expenses in accordance with the Department of Labor's guidance. The Health System is responsible for determining what expenses the third-party administrator will reimburse from the account. All funds utilized from this account are treated as administrative expenses on the statement of changes in net assets available for benefits. Increases to the account from revenue sharing for 2024 and 2023 were \$142,385, and \$123,171, respectively. From the total revenue sharing received in 2024 and 2023, \$0 and \$81,800 were allocated to participants' accounts as earnings, respectively. During 2024 and 2023, administrative expenses of \$92,740 and \$97,341, respectively, were paid from the expense account. The account's balance at December 31, 2024 and 2023, was \$162,720 and \$109,922, respectively, and is included in the stable value account, which is included in investments at contract value on the statements of net assets available for benefits.

**Note 3. Certification of Plan Trustee**

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Lincoln Financial Group Trust Company, Inc., a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate.

- Investments as shown in the statements of net assets available for benefits and related disclosures as of December 31, 2024 and 2023.
- Investment income as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the accompanying schedule of assets (held at year-end) as of December 31, 2024.

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

**Note 4. Related Party and Party-in-Interest Transactions**

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such persons.

Certain plan investments include an insurance contract managed by Lincoln National Life Insurance Company, an entity related to Lincoln Retirement Services Company, LLC (LRCS), which is the record-keeper for the Plan. The Plan paid direct administrative expenses of \$250,397 and \$225,945 to LRSC during 2024 and 2023, respectively.

The Plan incurs expenses related to general administration and record-keeping. A part of these expenses and certain legal and accounting and auditing fees relating to the Plan are paid by the Health System.

**Note 5. Disclosures About Fair Value of Plan Assets**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value measurements must maximize the use of observable inputs and minimize the use of unobservable inputs. There is a hierarchy of three levels of inputs that may be used to measure fair value:

- Level 1** Quoted prices in active markets for identical assets or liabilities.
- Level 2** Observable inputs other than Level 1 prices, such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.
- Level 3** Unobservable inputs supported by little or no market activity and are significant to the fair value of the assets or liabilities.

Following is a description of the valuation methodologies and inputs used for assets measured at fair value on a recurring basis and recognized in the accompanying statements of net assets available for benefits, as well as the general classification of such assets pursuant to the valuation hierarchy. There have been no significant changes in the valuation techniques during the years ended December 31, 2024 and 2023. The Plan had no liabilities measured at fair value on a recurring basis. In addition, the Plan had no assets or liabilities measured at fair value on a nonrecurring basis.

### ***Investments***

Where quoted market prices are available in an active market, securities are classified within Level 1 of the valuation hierarchy. If quoted market prices are not available, then fair values are estimated by using quoted prices of securities with similar characteristics or independent asset pricing services and pricing models, the inputs of which are market-based or independently sourced market parameters, including, but not limited to, yield curves, interest rates, volatilities, prepayments, defaults, cumulative loss projections, and cash flows. Such securities are classified in Level 2 of the valuation hierarchy. In certain cases where Level 1 or Level 2 inputs are not available, securities are classified within Level 3 of the hierarchy. There were no Level 2 or Level 3 securities held by the Plan.

### **Note 6. Investment Contract with Insurance Company**

The Plan invests in the Lincoln Financial Group Stable Value Account, a fully benefit-responsive fixed annuity investment contract with Lincoln National Life Insurance Company (Lincoln). Lincoln maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. At the end of the year a renewal interest rate is established. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan.

The Stable Value Account is fully benefit responsive; therefore, contract value is the relevant measurement. Contract value, as reported to the Plan by Lincoln, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against the contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

At December 31, 2024 and 2023, contract value for the Stable Value Fund is \$12,226,051 and \$11,512,541, respectively.

### **Note 7. Plan Termination**

Although it has not expressed an intention to do so, the Health System has the right under the Plan to discontinue its contributions at any time and to terminate the Plan, subject to the provisions of ERISA. In the event of plan termination, participants will become 100% vested in their accounts.

**Note 8. Tax Status**

The Plan operates under a nonstandardized adoption agreement in connection with a pre-approved retirement plan and trust document sponsored by Lincoln Retirement Services Company LLC. This pre-approved plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
