Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Jimcor Retirement Savings Plan, an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Jimcor Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Note 1. Description of Plan

General

The Jimcor Retirement Savings Plan (Plan) is a defined contribution plan covering all employees of Jimcor Agency, Inc. and its affiliate DTM Consulting, LLC (collectively, the “Employer” or “Company”). The Plan was established on January 1, 2000 and was restated on January 1, 2015 and January 1, 2022. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

A brief description of certain provisions of the Plan agreement follows. A more detailed description of the Plan's provisions, including those related to vesting and forfeitures, is maintained in the Summary Plan Description available to all Plan participants.

Eligibility

Employees, upon satisfaction of six months of service, who attained the age of twenty-one, become eligible for Plan enrollment and participation and, upon satisfaction of one year of service, become eligible for employer discretionary contributions.

Employee Elective Deferral Contributions

Participants may elect to contribute pre-tax, Roth, or after-tax deferral contributions, up to the maximum amount permitted by the Internal Revenue Code (“IRC”).

Employer Discretionary Matching Contributions

All active participants during the contribution period who meet the continuing eligibility requirements and make eligible elective deferral contributions are eligible for a discretionary employer matching contribution. For the year ended December 31, 2024, the Company elected to make contributions at the lesser of 50% of employee contributions, 50% of 5% of compensation or \$5,000. For the year ended December 31, 2023, the Company made contributions totaling \$271,723.

Employer Discretionary Non-Elective Contributions

The Company may also make a discretionary non-elective contribution to the Plan in accordance with the provisions contained in the plan document. For the year ended December 31, 2024, the Company made a contribution of \$73,956, which was allocated to participants in the Plan based on the provisions contained in the plan document.

Rollover Contributions

The Plan permits the acceptance of rollover contributions upon approval of the administrator. Rollover contributions generally consist of pre-tax lump-sum distributions received by a participant from a qualified retirement plan.

Participant Accounts

Investments in the Plan are participant directed. Each participant may elect from one or more of the investment vehicles offered pursuant to the provisions of the Plan. Each participant's account is credited with the participant's contribution and an allocation of (a) the employer matching contributions, (b) profit sharing contribution, and (c) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

The participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts is according to the following schedule:

Notes Receivable From Participants

Each participant is permitted to borrow up to 50% of his or her vested account balance. The term of a loan may not exceed five years, unless it is used to purchase a primary residence. Loans are measured at their unpaid principal balance plus any accrued, but unpaid interest. Principal and interest are paid ratably through payroll deductions and monitored by the plan administrator. The loans are collateralized by the balance in the participant's account and bear interest at a rate of prime plus 1%. Interest rates at December 31, 2024 ranged from 4.25% to 9.50%.

Payment of Benefits

Participants' vested interest in the Plan's assets are distributable generally upon termination, disability, retirement, or death. In addition, participants may request withdrawals pursuant to specific guidelines as set forth in the plan document.

Forfeitures

The portion of a participant's balance, which is not vested upon termination of employment, is forfeited and remains in the Plan. Forfeitures can be used to reduce any future employer contributions or to pay administrative expenses of the Plan. During the year ended December 31, 2024, forfeitures approximated \$3,100 and no forfeitures were utilized. At December 31, 2024 and 2023, available forfeitures approximated \$6,000 and \$2,900, respectively.

Other Income

The Plan shares in investment related revenue the custodian receives attributable to the Plan assets invested in pooled separate accounts. The Plan receives a credit for the revenue share on a quarterly basis which is deposited into an ERISA Budget Account from which the Plan may pay allowable Plan expenses. For the year ended December 31, 2024, \$53,888 was made available to the Plan and a total of \$53,822 has been used to pay for Plan administrative expenses.

Note 2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value and contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussions of fair value measurements.

Purchases and sales of investments are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

All administrative expenses are paid by the Plan.

Subsequent Events

The Plan has evaluated subsequent events through September 3, 2025, the date these financial statements were available for issuance. All subsequent events requiring recognition or disclosure have been incorporated in these financial statements.

Note 3. Certification of Plan Trustee

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya Retirement Insurance and Annuity Company, a qualified institution, has certified the following investment information included in the accompanying financial statements and ERISA-required supplemental schedule is complete and accurate:

- Investments as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023
- Investment income as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024
- Investment information, excluding notes receivable from participants, included in the accompanying schedule of assets (held at end of year) as of December 31, 2024

The Plan's independent auditors did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

Note 4. Fair Value Measurements

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques need to maximize the use of observable inputs and minimize the use of unobservable inputs. Valuation techniques used to measure fair value are defined as follows:

- Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2** Inputs to the valuation methodology include: (a) quoted prices for similar assets or liabilities in active markets; (b) quoted prices for identical or similar assets or liabilities in inactive markets; (c) inputs other than quoted prices that are observable for the assets or liability; and (d) inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled separate accounts: Stated at the fair value based on the year end market value of each unit held, which is based upon the market value of the underlying assets of the funds less management fees. The pooled separate accounts do not have any unfunded commitments relating to their investments, or any significant restrictions or redemptions. Participant-directed redemptions can be made on any business day and do not have a redemption notice period.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Investment Contract with Insurance Company

The guaranteed investment contract is credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Voya. The contract is fully benefit-responsive and is reflected in the financial statements at contract value. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with Voya. Such events include the following: (1) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Company or other Company events that cause a significant withdrawal from the Plan, or (4) the failure of the Plan to qualify for exemption from Federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable. The guaranteed investment contract does not permit Voya to terminate the agreement prior to the scheduled maturity date.

Note 6. Related-Party and Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association or relatives of such persons.

Voya, the trustee of the Plan, manages certain plan investments and therefore these transactions qualify as party-in-interest transactions. Fees paid to Voya approximated \$3,200 for the year ended December 31, 2024.

Intac Actuarial Services, Inc. (Intac) is the record keeper for the Plan and therefore, these services qualify as party-in-interest transactions. During the Plan Year Intac's name officially changed to Ascensus who had acquired Intac in 2018. Total fees paid by the Plan to Intac and Ascensus for record keeping and administrative services approximated \$19,100 for the year ended December 31, 2024.

Morningstar provides investment advisory services for participants in the Plan and therefore, these services qualify as party-in-interest transactions. Fees paid by the Plan for investment advisory services approximated \$16,600 for the year ended December 31, 2024.

Raymond James provides financial advisement services for participants in the Plan and therefore, these services qualify as party-in-interest transactions. Fees paid to the Plan for financial advisement services approximated \$47,500 during the year ended December 31, 2024.

Note 7. Plan Termination

Although it has not expressed any intent to do so, the Company has the right to change or terminate the Plan subject to the provisions of ERISA. In the event of termination, participants become 100% vested in their employer contributions and Plan assets will be distributed to participants based on their individual account balances.

Note 8. Tax Status

The Plan operates under a nonstandardized adoption agreement in connection with a prototype retirement plan and trust/custodial document sponsored by Ascensus LLC. This prototype plan document has been filed with the appropriate agency. The Plan has not obtained or requested a determination letter. However, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that the Plan was qualified and the related trust was tax exempt as of the financial statement date.

Note 9. Risks and Uncertainties

The Plan invests in various investment securities. Such securities are subject to various risks that determine the value of the funds. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of these securities, it is at least reasonably possible that changes in market conditions in the near term could materially affect participants' account balances and the value of investments reported in the financial statements.
