We have performed audits of the financial statements of Fraunhofer USA, Inc. 401(a) DC Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). As explained in Note 5, the financial statements include investments in the TIAA Real Estate Account and the TIAA Traditional Annuity valued at approximately \$6.5 million (15 percent of net assets) at December 31, 2024 and \$6.9 million (18 percent of net assets) at December 31, 2023, whose fair values have been estimated by management in the absence of readily determinable market values. Management's estimates are based on information provided by TIAA-CREF. Our opinion has not been modified with respect to this matter.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

Auditor's Responsibilities for the Audits of the Financial Statements

Note 1 - Plan Description

The following description of Fraunhofer USA, Inc. 401(a) DC Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Fraunhofer USA, Inc. (the "Company") who are not visiting faculty employed by partnering universities. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and qualifies under Internal Revenue Code Sections 401(a) and 403(a).

Plan Administration

Teachers Insurance and Annuity Association (TIAA) investments consist of a group annuity contract, registered investment companies, mutual funds, and a pooled separate account. College Retirement Equities Fund (CREF) investments consist of registered investment companies.

Contributions

The Plan provides for employer contributions of 12.5 percent of the participant's compensation, as defined in the plan agreement. Employee contributions are not permitted.

Participant Accounts

Each participant's account is credited with employer contributions and charged with an allocation of administrative expenses. Allocations are based on participants' compensation or account balances, as applicable. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

Vesting

Vesting in the Company's contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants vest in contributions made by the Company 40 percent after two years of service and another 20 percent per year thereafter until they become fully vested after five years of service. Participants are credited with a year of service for each 12-month period during which 1,000 or more hours of service are completed. Participants can also become fully vested after a qualifying event, such as death or retirement.

Benefit Payments

On termination of service due to death, disability, termination of employment, or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account or various installment annuities. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Certain amounts invested in the TIAA Traditional Annuity may not be distributed in a lump sum (see redemption restrictions below).

Redemption Restrictions

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Transfers from the Group Retirement Annuity (GRA) and the Transfer Payout Annuity (TPA) contracts must be paid out in 10 annual installments. Withdrawals from the GRA contracts are available within 120 days after termination of employment subject to a 2.5 percent surrender charge; otherwise, they must be paid over 10 annual installments.

Note 1 - Plan Description (Continued)

Forfeitures

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future company contributions. The total amount of funds forfeited by participants for the plan year ended December 31, 2024 was \$160,126. There was \$183,800 in forfeitures applied during the year to employer contributions.

Party-in-interest Transactions

Certain plan assets are investment funds managed by Teachers Insurance and Annuity Association and College Retirement Equities Fund (collectively, TIAA-CREF) and TIAA Trust, N.A. or their affiliates. TIAA-CREF is a service provider of the Plan, and TIAA Trust, N.A. is a custodian of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

Termination

While it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances.

Note 2 - Summary of Significant Accounting Policies

Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value. Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 5 for further discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend rate.

Benefit Payments

Benefits are recorded when paid. There were benefit payments requested but not paid (due to redemption restrictions) totaling \$82,680 and \$27,081 as of December 31, 2024 and 2023, respectively.

Allocated Contracts

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact and additional contracts have been purchased. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

Administrative Expenses

Various administrative costs are paid by the Company.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

Note 2 - Summary of Significant Accounting Policies (Continued)

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

Subsequent Events

The financial statements and related disclosures include evaluation of events up through and including September 2, 2025, which is the date the financial statements were available to be issued.

Note 3 - Certified Information

TIAA-CREF and TIAA Trust, N.A. hold the Plan's investments and execute all investment transactions. The investment balances and related investment income and losses included in the accompanying financial statements and supplemental schedule of assets held at end of year are based solely on information certified by TIAA-CREF and TIAA, as agent for TIAA Trust, N.A.

Note 4 - Tax Status

The Plan is a prototype plan. The prototype plan has received a favorable opinion letter from the Internal Revenue Service (IRS) indicating that the Plan, as designed, is qualified for federal income tax-exempt status. The Plan has received a determination letter from the IRS.

Note 5 - Fair Value Measurements

Accounting standards require that certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

Level 1

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

Level 2

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

Level 3

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

Note 5 - Fair Value Measurements (Continued)

The following valuation methodologies have been used to value the Plan's investments:

Mutual Funds

Mutual funds are valued at quoted prices reported in active markets.

Pooled Separate Account

The pooled separate account is valued at net asset value per share (NAV) or its equivalent based on the fair value of the fund's net underlying assets, which consist primarily of rental property subject to long-term leases, and has been estimated on the basis of future rental receipts and estimated residual values discounted at interest rates commensurate with risks involved. There are no redemption restrictions or unfunded commitments on this investment.

Unallocated Contract

The group annuity contract is not considered benefit responsive and is presented at fair value. The group annuity contract is a guaranteed annuity account issued by Teachers Insurance and Annuity Association that invests in the general assets of TIAA. Since there are no specific securities in TIAA's general account related to these contracts and due to the contract terms, including the frequency of the interest rate reset intervals, contract value is the best estimate of fair value for the non-benefit-responsive contract. Contract value represents principal invested, plus interest earned, less any withdrawals.

Registered Investment Companies

The registered investment companies are valued at net asset value per share (or its equivalent) based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments.
