## **INDEPENDENT AUDITORS' REPORT**

To the Administrator and Participants of the

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of Asurint Retirement Savings Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Asurint Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following brief description of Asurint Retirement Savings Plan (the Plan), is provided for general information purposes only. Participants should refer to the Plan document for more complete information.

**General**

The Plan is a 401(K) and profit sharing plan established to provide retirement benefits for all employees of One Source Technology, LLC. Employees of the Company are eligible to participate immediately upon hire due to no age or service requirement necessary. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

Each year, plan participants may contribute to the Plan, on a pretax basis, an amount not to exceed 90% of their compensation, subject to a limit of \$23,000 and \$22,500 for 2024 and 2023, respectively. Eligible employees may elect to make additional “catch up” contributions. Participants may also contribute amounts on an after-tax basis through Roth contributions subject to the same limitations as pretax basis contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. The Plan has an auto-enrollment provision whereby all newly eligible employees and active participants without a deferral election or have a zero election are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 3% of eligible compensation.

The Company may make matching contributions on behalf of each participant equal to a discretionary percentage of the participant’s elective deferrals, where the amount of elective deferrals matched is a discretionary dollar amount or percentage of a participant’s compensation determined by the Company on a uniform basis.

**Participant Accounts**

A separate account is maintained for each investment option selected by the participant. Each participant’s account is credited with the participant’s contributions, the Company’s discretionary non-elective and matching contributions, and the Plan’s earnings. Allocation of the Plan’s earnings is based on participant’s account balances.

Participants direct the investment of their contributions and those made by the Company into various investment options offered by the Plan. The plan currently offers twenty-eight funds as investment options for participants.

**Vesting**

Participants are immediately vested in employee contributions. A 5 year graded vesting schedule is used for employer non-elective profit sharing contributions and employer matching contributions. The schedule is based on a participant’s period of service using the elapsed time method.

**Notes Receivable From Participants**

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance, reduced by the participant's highest outstanding loan during the previous twelve month period. Loan terms can be up to 5 years, or up to 30 years for the purchase of a primary residence. The loans are secured by the balance in the participant's account and bear interest at a rate determined at the time the loan is made. As of December 31, 2024, the interest rates on all outstanding loans ranged from 5.25% - 10.50%. Principal and interest are repaid ratably through bi-weekly payroll deductions. The initial loan origination fee of \$75 is paid by the participant requesting the loan. A \$25 annual administration fee will be assessed on the annual anniversary of the issuance of each loan.

Notes receivable from participants are measured at their unpaid principal balance. Interest income is recorded on the cash basis. Related fees are recorded as administrative expenses and are expensed when incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

**Payment Of Benefits**

Distributions of a participant's account are made upon retirement from the Company at age 65, in cases of financial hardship, termination from service with the Company, death, or disability. Participants still employed who have reached the age of 59½ are eligible for in-service distributions from accounts which are fully vested. Distributions are made in single lump-sum payments, in cash. Partial distributions or installments are only permitted for required minimum distributions. Vested account balances \$1,000 or less of terminated participants are automatically distributed as a cash, lump-sum payment. Distributions of vested account balances greater than \$1,000 may be made as soon as administratively feasible and require consent from the terminated participant.

**Forfeitures**

Forfeitures resulting from a break in participant service without the attainment of 100% vesting are used to reduce employer contributions. At December 31, 2024 and 2023, forfeited non-vested amounts totaled \$31,980 and \$31,535, respectively. At December 31, 2024 the balance in the forfeiture account at year end is \$3.

**NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting**

The financial statements of the Plan are prepared under the accrual basis of accounting, in conformity with generally accepted accounting principles.

**Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan administrator and management to make estimates and assumptions that affect certain reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

**Valuation of Investments**

The Plan's investments are administered by the Plan's custodians and are stated at fair value. For 2024, mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year end. Common Collective Trusts are valued at the NAV of units of a bank collective trust.

Participant loans are valued at cost, which approximates fair value.

**Benefit Distributions**

Benefit distributions are recorded and expensed when paid to participants.

**Administrative Services**

The expenses necessary to administer the Plan are paid by the Plan or Plan sponsor including, but not limited to, those involved in retaining necessary professional assistance from an attorney, an accountant, an actuary, or an investment adviser. Fees related to the administration of notes receivable from participants and distributions are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation of fair value of investments.

**Risk and Uncertainties**

The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest rate, market and credit. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value in the near term would materially affect participant account balances and the amounts reported in the statements of Net Assets Available for Benefits and the Statements of Changes in Net Assets Available for Benefits.

**NOTE 3 - INVESTMENTS AND INFORMATION CERTIFIED BY THE CUSTODIAN**

The Plan's investments are currently held by Fidelity Management Trust Company, as custodian. Fidelity Management Trust Company maintains the investments in separate accounts, which comprise a significant portion (99.4% - year ended December 31, 2024, 99.1% - year ended December 31, 2023) of the Plan's assets. The accounts are credited with earnings on the underlying investment and charged for plan withdrawals. Fidelity Management Trust Company certified as of December 31, 2024 and 2023, respectively, as to the completeness and accuracy of the information reported. Net interest and dividend income totaled \$262,861 and \$178,438 for the years ended December 31, 2024 and 2023, respectively. Net appreciation (depreciation) in the value of investments totaled \$998,692 and \$1,032,077 for the years ended December 31, 2024 and 2023, respectively. The funds listed below were the investment options for the years ended December 31, 2024 and 2023. The assets that comprise these funds may be invested in registered investment companies or collective trust funds.

**NOTE 4 - TAX STATUS**

The Plan uses a volume submitter plan document sponsored by Fidelity Management & Research Company, which received an opinion from the IRS, dated June 30, 2020, which states that the volume submitter document satisfies the provisions of Section 401 of the IRC. The Plan itself has not received a determination letter from the IRS. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

**NOTE 5 - PARTICIPANTS SEPARATED FROM SERVICE WITH A DEFERRED VESTED INTEREST**

As of December 31, 2024, seventy-eight participants with account balances totaling \$3,152,007 have separated from service and have not been paid.

**NOTE 6 - TRANSACTIONS WITH PARTIES-IN-INTEREST**

Fidelity Management Trust Company is the custodian of the Plan. Certain fees for custodian services are with Fidelity Management Trust Company and are not considered prohibited transactions under ERISA. Participant loans also qualify as party-in-interest.

**NOTE 7 - FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board Statement *Accounting Standards Codification (ASC) 820, Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the assets or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or by other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and December 31, 2023.

*Common Collective Trust:* Valued at the NAV of units of a bank collective trust. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment adviser reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual Funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
