Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the financial statements of the First Security Bancorp 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audits"). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audits of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America ("GAAP").

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Notes to Financial Statements

December 31, 2024 and 2023

1. Summary of Significant Plan Provisions

The following brief description of the First Security Bancorp 401(k) Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

- a. **General** – The Plan is a defined contribution plan for the benefit of the employees of First Security Bancorp and affiliates (the “Employer”) who adopt the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.
- b. **Eligibility** – All employees, except leased employees, nonresident aliens, and employees covered by collective bargaining agreements that do not provide for participation in the Plan, are eligible to participate in the salary deferral portion of the Plan at the next entry date after attaining age 18. Employees are eligible to receive an Employer matching contribution after attaining age 18 and completing a year of service during which 1,000 hours or more of service are accrued. The entry date for participant deferral contributions is the first day of each month of the Plan year. The entry dates for Employer matching contributions are January 1 and July 1.
- c. **Contributions** – Participants may elect to make salary deferrals to the Plan through payroll deductions. These salary deferrals may not exceed 75% of a participant’s compensation. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan also allows employees to rollover balances from other qualified plans. The Employer will make a safe harbor matching contribution equal to 100% of a participant’s contributions up to 3% of the participant’s eligible compensation, plus 50% of a participant’s contributions up to the next 2% of the participant’s eligible compensation. The Employer may also make nonelective contributions. The Employer did not make a nonelective contribution for 2024. There are limitations on the maximum annual additions that can be made to a participant’s account.
- d. **Participant accounts** – Each participant’s account is credited with the participant’s and Employer contributions and allocations of Plan earnings/losses, and is charged with applicable withdrawals and an allocation of any administrative expenses. Allocations are based on participant’s earnings, contributions, or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.
- e. **Investment options** – Participants shall direct the investment of their elective deferral and matching contribution accounts in the investment options offered under the Plan. Participants may change their investment elections at any time.
- f. **Vesting rights** – The benefits attributable to a participant that result from participant and safe harbor matching contributions and the earnings/losses thereon are always fully vested and nonforfeitable. If a participant terminates employment other than because of their death, disability, or retirement they are entitled to their vested percentage of Employer nonelective contributions and earnings/losses thereon.

- g. **Payment of benefits** – Upon retirement, death, disability, or termination, a participant may elect to have their account paid either in a lump sum or installments, or may elect to defer payment of their account balance if it exceeds \$5,000. If the participant's account balance is equal to or less than \$5,000, the balance will be automatically distributed. Any distribution greater than \$1,000 that is made to a participant without the participant's consent before the participant's normal retirement age will be rolled over to an individual retirement account designated by the Plan administrator. In-service withdrawals are available to participants who meet certain hardship requirements. In addition, the portion of a participant's account resulting from rollover contributions may be withdrawn at any time.
- h. **Notes receivable from participants** – As a result of the acquisition of First National Bank of Springdale ("FNB of Springdale"), First Security Bank of Conway ("FSB of Conway"), and Union Bank of Benton ("UB of Benton"), the Plan document was amended to allow former FNB of Springdale, FSB of Conway, and UB of Benton participants to roll their existing notes receivable into the Plan. These notes are secured by the participants' accounts and bear interest at rates which are commensurate with local prevailing borrowing rates. Principal and interest are paid through payroll deductions. No new notes receivable are permitted under the Plan.
- i. **Termination of the Plan** – Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. Summary of Significant Accounting Policies

- a. **Basis of accounting** – The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").
- b. **Estimates** – The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

2. Summary of Significant Accounting Policies (cont.)

- c. **Investment valuation and income recognition** – Investments are reported at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net change in fair value of investments includes the gains and losses on investments bought and sold, as well as held during the year.

- d. **Notes receivable from participants** – Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan documents.
- e. **Payment of benefits** – Benefits are recorded when paid.
- f. **Administrative expenses** – Fees related to distributions are charged directly to the participant's account. Record keeping and custodial fees are netted against revenue sharing receipts and allocated pro rata based on each participant's account balance. Certain other administrative expenses paid by the Employer are not included in the Plan's financial statements.

3. Investments

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by Fidelity Management Trust Company ("Fidelity"), the trustee of the Plan, and was not subjected to any audit procedures, except for comparing the information with the related information included in the financial statements and supplemental schedule:

- a. Investments at fair value as shown on the accompanying statement of net assets available for benefits of \$82,449,302 and \$72,111,985 as of December 31, 2024 and 2023, respectively.
- b. Interest and dividends as shown on the accompanying statement of changes in net assets available for benefits of \$3,125,689 (excluding \$4,050 of interest from notes receivable from participants) for the year ended December 31, 2024.
- c. Net change in fair value of investments as shown on the accompanying statement of changes in net assets available for benefits of \$6,784,175 for the year ended December 31, 2024.
- d. All investment transactions that occurred during the year ended December 31, 2024.
- e. All information included in the supplemental schedule, excluding participant loans.

3. Investments (cont.)

The Plan provides for investments in various investment securities which, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility risk. Further, due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

4. Fair Value Measurements

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Fair value is categorized based on a hierarchy that gives the highest priority to unadjusted quoted prices in active markets for identical assets (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 or 2023.

Money market fund: This investment is valued at the fair value of the underlying investments, which is valued based on quoted market prices at the end of the Plan year. The underlying investments' objective is to achieve \$1 per share value.

Mutual funds: These investments are valued at quoted market prices on the last business day of the Plan year.

4. Fair Value Measurements (cont.)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. Tax Status

The Plan is utilizing a non-standardized pre-approved profit sharing plan document (the "Plan Document"), which received an opinion letter dated June 30, 2020, in which the IRS stated the Plan Document is designed in accordance with the applicable sections of the Internal Revenue Code ("IRC"). As allowed by the IRS, the Plan is relying on the opinion letter of the Plan Document for its own qualification. Although the Plan Document has been amended since receiving the opinion letter, the Plan administrator believes the Plan is designed and currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in process.

Notes to Financial Statements**December 31, 2024 and 2023****6. Parties-in-Interest Transactions**

Fidelity is the trustee and third-party administrator of the Plan. The Plan pays Fidelity for its services. Inasmuch as Fidelity serves as trustee and third-party administrator of the Plan's assets, Fidelity is by definition a party-in-interest and, as a result, all investments and investment transactions with Fidelity were with a party-in-interest. The Plan also holds notes receivable from participants. As a result, these notes receivable and all related transactions were with parties-in-interest. All of these transactions are exempt from being prohibited transactions under ERISA.

7. Subsequent Events Evaluation Date

Management of the Plan evaluated the events and transactions subsequent to its December 31, 2024 financial statement date and determined there were no significant events necessary for disclosure through September 8, 2025, which is the financial statement issuance date.
