Scope and Nature of the ERISA Section 103(a)(3)(c) Audit

We have performed audits of the accompanying financial statements of Hillsborough Title Inc 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(c) [ERISA Section 103(a)(3)(c) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Hillsborough Title Inc 401(k) Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(c) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Basis for Opinion

NOTE 1 - DESCRIPTION OF PLAN

The following represents a summary of key provisions of Hillsborough Title Inc 401(k) Plan (the "Plan") but does not purport to be complete and is qualified in its entirety by the terms of the Plan. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution safe harbor plan, covering all employees of Hillsborough Title Inc and affiliated companies who have signed agreements to participate under the Plan (collectively, the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended, ("ERISA") and the Internal Revenue Code ("Code"). The eligibility requirements to participate include attaining age 18 and completing 3 months of service. The eligibility requirements are waived if participants were employed as of January 1, 2015, the inception date of the Plan. The Board of Trustees oversees the governance of the Plan, determines the appropriateness of the Plan's investment offerings and monitors investment performance.

The employees of Celebration Title Group of Florida LLC (EIN 81-1819130) were permitted to contribute to the plan on their first payroll date of August 26, 2024. The Plan was amended to recognize service from the employees of the company and to participate in the Plan effective August 26, 2024.

Smart Title II, LLC an affiliate participating in the Plan was dissolved on 12/31/2024 and all employees of that company were transferred to other affiliated companies.

The Plan which was effective January 1, 2015, was amended and restated effective January 1, 2022, as part of the Cycle 3 Restatement. The Plan trustee and administrator elected to adopt the Plan provisions of Southern Pension Services Defined Contribution Prototype Plan and Trust (basic plan document #02).

Contributions

Each year, participants may contribute up to the maximum allowed by the Internal Revenue Service from their participating compensation as defined in the Plan document. Participants may elect to make contributions to the Plan in any combination of before-tax, after-tax and Roth 401(k) contributions. Participants who have attained age fifty before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers). The Company makes a safe harbor matching contribution equal to 100% of the first 3% of participant's eligible compensation plus 50% of contributions that exceed 3% of eligible compensation but that do not exceed 5% of compensation. All employer contributions are invested in the same proportion as the employee contributions. Participants' eligible compensation for safe harbor matching is compensation for the plan year.

The Company may make discretionary contributions and nonelective contributions. To be eligible, Plan participants must be employed by the Company as of the Plan's year end and have completed 1000 hours of service. Discretionary contributions have not been made for the years ended December 31, 2024 and 2023.

Participant Accounts

Participants direct their contributions, the Company's matching and discretionary contributions into any investment option available within the Plan. Participants may change their investments options daily. Each participant's account is credited with the participant's contributions, allocations of the Company's safe harbor contributions, discretionary matching contributions, rollovers from other plans, Plan earnings (losses), and charged with an allocation of any administrative expenses paid by the Plan. Allocations are based on the participant's earnings or account balances, or specific participant transactions as defined in the Plan agreement. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. The participants are one hundred (100) percent vested in the Company's safe harbor matching contribution portion of their accounts in accordance with the safe harbor provisions of the Plan. For any discretionary nonelective or additional matching contributions, a graded vesting schedule of 1-5 years would be used, where a participant would vest after one year of service at 20% and increase in 20% increments until fully vested after five years of service.

Loans

Participants may not borrow from their 401(k) account and employer contribution account.

Payment of Benefits

The entire vested balance of a participant's account may be distributed at the date of the participant's retirement from the Company, termination from service from the Company, death, or permanent disability. Partial withdrawals or installments are only allowed to participants/beneficiaries who must receive required minimum distributions under code 401(a)(9). Annuities are not allowed. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan will make a mandatory distribution of a participant vested account balance following severance from employment up to a maximum of \$7,000 for those participants who do not return their signed forms. If the amount of the distribution is less than \$1,000, it will be distributed to the participant in cash. If the amount of the distribution is between \$1,000 and \$7,000, it will be rolled into an individual retirement account on the participant's behalf. In-Service-Distributions are permitted at age 59 ½. Hardship distributions are permitted from elective deferrals, matching contributions and nonelective contributions if applicable.

Forfeited Accounts

The Plan is a Safe Harbor Plan where the participants are one hundred percent (100%) vested in the safe harbor matching contributions. Forfeited amounts, if any, will be used to fund employer safe harbor matching contributions and then pay any plan expenses.

NOTE 2 - SUMMARY OF ACCOUNTING POLICIES

The financial statements of the Plan are prepared under the accrual basis of accounting.

Use of Estimates

The preparation of the financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments held by a defined contribution plan are required to be reported at fair value, except for fully benefit-responsive investment contracts which is reported at contract value. The Plan's mutual funds are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's trustee determines the Plan's valuation policies. See Note 6 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain administrative expenses of the Plan are paid by the Company and are therefore excluded from these financial statements. A one-time distribution fee related to the administration of distribution requests are charged directly to the participants' account and are included in administrative expenses. Investment-related expenses are included in net appreciation in fair value of investments.

NOTE 3 - PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue their contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 4 - PLAN ADMINISTRATION

Certain administrative functions are performed by employees of the Company. None of the employees receive any compensation from the Plan.

NOTE 5 – CERTIFIED INVESTMENTS

The following information included in the accompanying financial statements and supplemental schedules was obtained from the data that has been prepared and certified to as complete and accurate by the trustee, a qualified institution in accordance with 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974.

NOTE 6 - FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority. Level 2 inputs consist of observable inputs other than quoted prices for identical assets and Level 3 inputs are unobservable and have the lowest priority.

The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Level 1 Fair Value Measurements

The fair value of mutual funds is based on quoted net asset values of the shares as reported by the fund. The funds held by the Plan are open-end mutual funds registered with the U.S. Securities and Exchange Commission. The funds must publish their daily net asset value and transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

NOTE 7 - TAX STATUS

Effective January 1, 2019, the Plan administrator elected to adopt the Plan provisions within the prototype document of Southern Pension Services Defined Contribution Prototype Plan and Trust (basic plan document #11). The Plan was restated and amended effective January 1, 2022 and the Internal Revenue

Service had determined by letter dated June 30, 2020, that the Plan and related Trust was designed in accordance with applicable sections of the Internal Revenue Code.

The Plan administrator believes the Plan, as currently amended and restated, is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require the plan administrator to evaluate tax positions taken by the Plan and recognize a tax liability for any uncertain position that more likely than not would not be sustained upon examination by the IRS.

As of December 31, 2024 and 2023, the Plan had no uncertain tax positions that qualify for either recognition or disclosure in the financial statements. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examinations for years prior to 2022.

NOTE 8 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

NOTE 9 - PARTIES-IN-INTEREST

Section 3(14) of ERISA defines a party-in-interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan, or an employer whose employees are covered by the Plan. Plan investments and the related transactions as of December 31, 2024 were in investment funds managed by the Trustee; therefore, these investments and transactions qualify as party-in-interest transactions. These party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

NOTE 10 - SUBSEQUENT EVENTS

Subsequent events have been evaluated through August 29, 2025, which is the date the financial statements were available to be issued.
