Report of Independent Auditors

To the Participants and Trustees of
Iron Workers' Tri-State Welfare Plan

Opinion

We have audited the financial statements of Iron Workers' Tri-State Welfare Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), which comprise the statements of net assets available for benefits and of benefit obligations as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits and of changes in benefit obligations for the years then ended, and the related notes to the financial statements.

In our opinion, the accompanying financial statements present fairly, in all material respects, the net assets available for benefits and benefit obligations of Iron Workers' Tri-State Welfare Plan as of December 31, 2024 and 2023, and the changes in its net assets available for benefits and benefit obligations for the years then ended, in accordance with accounting principles generally accepted in the United States of America.

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Notes to Financial Statements

December 31, 2024 and 2023

Note 1. Summary of Significant Accounting Policies

Method of Accounting - The accompanying financial statements of Iron Workers' Tri-State Welfare Plan (the Plan) have been prepared using the accrual basis of accounting.

Investments - The investments of the Plan are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell that asset (or paid to transfer a liability) in an orderly transaction between market participants at the measurement date (the exit price). Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well held during the year.

Purchases and sales of the investments are reflected on a trade-date basis.

Dividend income is recorded on the ex dividend date. Interest income is recorded on the accrual basis.

Contributions Receivable - Employer contributions due and unpaid prior to year end are recorded as contributions receivable. Employer contributions due as determined by payroll compliance audits are recorded upon settlement with the employer. An allowance for uncollectible accounts was not considered necessary and has not been provided.

Revenue Recognition - Revenue derived from employer contributions is recognized in the period in which covered work is performed, based on the number of hours worked in covered employment and the contribution rates currently in effect, as set forth in the collective bargaining agreements. Employers are required to remit contributions monthly. The Plan carries out its purpose described in Note 2 within a jurisdiction primarily located throughout Illinois, Indiana and Iowa.

Note 1. Summary of Significant Accounting Policies (continued)

Reciprocal Contributions - The Plan is signatory to reciprocity agreements with various other welfare plans for its participants who perform work outside the geographic jurisdiction of the local unions. Participants who are normally employed within the territory of one local union (home local) may be temporarily employed within the territory of another local union (reciprocating local). When a participant of the home local works in the territory of a reciprocating local, the latter is to make contributions to the former's fringe benefit plans on the participant's behalf. Monies received by the Plan on behalf of persons from outside participating local unions are forwarded to their home local fringe benefit plans. The Plan uses the same recognition and measurement criteria for contributions received on behalf of its participants under the terms of reciprocity agreements, as for all other employer contribution revenue. Amounts paid to other plans under the terms of reciprocity agreements are not reflected in the statements of changes in net assets available for benefits, as the amounts received are not revenue earned by the Plan, and the corresponding payments are not an expense of the Plan. The Plan recognizes a liability upon receiving reciprocal contributions on behalf of non-participants working within the jurisdiction of the local union, and recognizes a decrease in that liability upon remitting those contributions to the appropriate plan. Employer contributions included reciprocal contributions of \$2,043,393 and \$2,138,375 for the years ended December 31, 2024 and 2023, respectively, from various other welfare plans under the terms of reciprocity agreements. The Plan remitted a total of \$2,213,436 and \$2,188,657 in reciprocal contributions to various other welfare plans under the terms of reciprocity agreements for the years ended December 31, 2024 and 2023, respectively.

Prescription Drug Rebates - The Plan utilizes a pharmacy benefit manager (PBM) who periodically makes refunds to the Plan based on the Plan's actual utilization pattern of specific drugs. Refunds due from the Plan's PBM are recorded when earned. Refunds due at year end have been reported as a receivable.

Stop-Loss Insurance - The Plan maintains a stop-loss insurance arrangement in an effort to limit its exposure for self-insured benefits. Under the terms of the contract, individual participant claims incurred in excess of specific limits within the contract year are reimbursed to the Plan. Specific limits were \$350,000 for the years ended December 31, 2024 and 2023.

Subrogation Recoveries - Claims that are reimbursed pursuant to subrogation matters are recorded upon settlement. Subrogation matters involve third parties considered to be responsible for claims paid by the Plan from whom the Plan seeks reimbursement.

Deferred Participant Contributions - Participant contributions received in advance of the corresponding eligibility period are recognized as deferred income.

Note 1. Summary of Significant Accounting Policies (continued)

Benefit Obligations - Benefit obligations are determined by the Plan's actuary using accepted actuarial principles, based on paid and incurred claims cost studies, Plan benefits, claims experience and other data as considered necessary.

The obligation for participants' accumulated eligibility credits represents an estimate of claims which will be due the following year for participants who had been credited with sufficient hours prior to December 31 to maintain eligibility after year end.

Health Reimbursement (Healthy Foundations) Accounts (HFA) - Included in net assets available for benefits are amounts available to reimburse participants for qualifying expenses, totaling approximately \$6,880,000 and \$6,354,000 as of December 31, 2024 and 2023, respectively. Claims payable from HFA accounts totaled \$20,500 and \$400,300 as of December 31, 2024 and 2023, respectively. The HFA accounts are considered a defined contribution component of the Plan.

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect certain reported amounts and disclosures in the financial statements. Actual results could differ from those estimates.

Subsequent Events - Subsequent events have been evaluated through August 25, 2025, which is the date the financial statements were available to be issued.

Note 2. Description of the Plan

The Plan was established during 1954 as a result of collective bargaining agreements to provide health benefits for eligible participants and their dependents. The Plan provides medical, death, disability, dental and vision benefits. The Plan is a multiemployer welfare plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Participants become eligible for benefits after any nine consecutive calendar month period in which they have been credited with at least 500 hours of contributions. If 500 hours of contributions are accumulated in less than nine months, the individual becomes eligible on the first day of the calendar month after accumulating 500 hours of contributions. To maintain eligibility, the participant is required to accumulate 350 hours per quarter, 700 in the prior two quarters, 1,050 in the prior three quarters or 1,400 in the prior four quarters. A three month eligibility period begins with the third month after the look-back period.

After attaining initial eligibility for benefits, participants accumulate credit amounts (expressed in hours) for future eligibility. Under the Plan, accumulated credits may be carried forward and used for future benefits when a participant would otherwise be ineligible for benefits. A participant may accumulate a maximum of 750 credits.

Note 2. Description of the Plan (continued)

Certain participants who work less than the required number of hours necessary for a full contribution by their employer may maintain eligibility by making self-payments to the Plan for the difference between the required contribution and the amount contributed by the employer.

The Plan also provides to eligible participants an individual health reimbursement arrangement account, referred to as a Healthy Foundations Account (HFA). An HFA is an account that the Plan sets up and maintains on behalf of a participant to keep track of contributions, reimbursements and a participant's available balance. Each account is funded exclusively through contributions made on a participant's behalf by an employer that contributes to the Plan under a collective bargaining agreement or participation arrangement. The amount of contributions is determined by the Board of Trustees and is subject to change or discontinuance at any time. Participants are not vested in the contributions made on their behalf, and their available balance may be used only for qualifying health care expenses that are not otherwise covered under the Plan or to make self-payments to maintain eligibility. The HFA benefit to which a participant is entitled is the benefit that can be provided from the participant's HFA account. No earnings are credited to a participant's account. Any unused amount each year may be accumulated in the participant's HFA account for future periods if the participant maintains eligibility. Balances are not portable and are forfeited if the participant leaves covered employment with a contributing employer. During the years ended December 31, 2024 and 2023, \$0 and \$23,500 in HRA accounts were forfeited under the provisions of the Plan. In general, forfeited amounts revert back to the Plan to pay future expenses of the Plan.

All benefits, except life insurance and accidental death and dismemberment benefits, are self-funded. Life insurance and accidental death and dismemberment benefits are provided through insurance contracts with Union Labor Life Insurance.

Once credited with 2,000 or more contribution hours for work performed in a calendar year, a participant is eligible to receive a \$100 reimbursement of the family deductible for that year. During the years ended December 31, 2024 and 2023, the Plan paid \$21,000 and \$19,000 respectively, in deductible refunds.

Continuation of health care benefits to persons who would otherwise lose those benefits due to certain events, as mandated by Consolidated Omnibus Budget Reconciliation Act (COBRA), was adopted by the Plan.

Participants should refer to the summary plan description, recent Plan amendments and summary of material modifications for more complete information.

Note 3. Priorities upon Termination

It is the intent of the Trustees to continue the Plan in full force and effect; however, to safeguard against any unforeseen contingencies, the right to discontinue the Plan is reserved to the Trustees. In the event of termination, the Trustees shall first satisfy or make provisions to satisfy the obligations of the Plan. Any remaining Plan assets will be distributed in such manner as will, in the opinion of the Trustees, bring about the purpose of the Plan. Termination shall not permit any part of the Plan to be used for or diverted to purposes other than the exclusive benefit of the participants.

Note 4. Tax Status

The Plan obtained a notice of exemption in which the Internal Revenue Service stated that the trust established under the Plan, as then designed, was in compliance with the applicable requirements of Section 501(c)(9) of the Internal Revenue Code. The Plan has been amended since receiving the notice of exemption. The Trustees and the Plan's legal counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. They therefore believe that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require the Plan to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by tax authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax period in progress.

Note 5. Funding Policy

The Plan is primarily funded by employer contributions and participant self-payments. Employer contributions to the Plan are made under negotiated collective bargaining agreements between various local unions affiliated with International Association of Bridge, Structural and Ornamental Iron Workers and participating employers. Employer contribution rates during the years ended December 31, 2024 and 2023 ranged from \$10.79 to \$12.86 per hour worked.

A total of \$.35 per hour worked is segregated from employer contributions received on behalf of participants to fund the HFA accounts. In addition, the participating local unions have negotiated for their collective bargaining agreement to provide an additional employer contribution at various hourly rates ranging from \$0.65 to \$2.50 to fund participants' HFA accounts.

Participant contributions are allowed to provide COBRA benefits, retiree benefits and to provide continued coverage under certain circumstances to otherwise terminated participants. Participant contribution rates are determined annually based on claims experience. For the years ended December 31, 2024 and 2023, quarterly COBRA rates ranged from \$2,312 to \$10,606 and quarterly retiree contribution rates ranged from \$2,725 to \$8,885 depending on the coverage option in place.

Note 6. Concentration of Cash

Cash consists of monies held in checking and highly liquid interest bearing accounts without significant withdrawal restrictions. The Plan places its cash with a financial institution deemed to be creditworthy. Balances are insured by the FDIC up to \$250,000. Balances may at times exceed insured limits.

Note 7. Fair Value Measurements

The *Fair Value Measurements and Disclosures* Topic of the FASB Accounting Standards Codification established a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

The methods used to measure fair value may produce an amount that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 7. Fair Value Measurements (continued)

The following tables set forth, by level within the fair value hierarchy, the Plan's investment assets at fair value for the years ended December 31, 2024 and 2023. As required, assets and liabilities are classified in their entirety based on the lowest level of input that is significant to the fair value measurement. In accordance with generally accepted accounting principles, certain investments that are measured at fair value using the net asset value per share (or its equivalent) practical expedient have not been classified in the fair value hierarchy. The fair value amounts presented in the following tables are intended to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

Level 1 Measurements

The fair values of the mutual funds are determined by reference to the funds' underlying assets, which are principally marketable equity and fixed income securities. Shares held in mutual funds are traded on national securities exchanges and are valued at the net asset value on the last business day of each period presented.

Level 2 Measurements

The money market fund is valued at cost, which approximates its fair value.

Measurements Using Net Asset Value as a Practical Expedient

The Plan's investments in a common collective trust and a real estate investment fund are valued at the net asset value per share, used as a practical expedient to estimate fair value. The net asset value is based on the fair values of the underlying investments held by the fund less its liabilities. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported net asset value.

Note 8. Related Organizations

The Plan shares common governance with Iron Workers' Mid-America Pension Plan and Iron Workers' Mid-America Supplemental Monthly Annuity Fund.

Note 9. Postretirement Benefit Obligations

The postretirement benefit obligation represents the total actuarial present value of those estimated future benefits that are attributed to employee service rendered to December 31, reduced by the actuarial present value of contributions expected to be received in the future from current Plan participants. Postretirement benefits include future benefits expected to be paid to or for (1) currently retired or terminated employees and their beneficiaries and dependents and (2) active employees and their beneficiaries and dependents after retirement from service with the participating employers. Prior to an active employee's full eligibility date, the postretirement benefit obligation is the portion of the expected postretirement benefit obligation that is attributed to that employee's service in the industry rendered to the valuation date.

The present value of the expected postretirement and postemployment benefit obligations is determined by an actuary and is the amount that results from applying actuarial assumptions to historical claims-cost data to estimate future annual incurred claims costs per participant and to adjust such estimates for the time value of money (through discounts for interest) and the probability of payment (by means of decrements such as those for death, disability, withdrawal or retirement) between the valuation date and the expected date of payment.

For measurement purposes, medical and prescription drug trend rates are as follows:

2024:

Participants under age 65: 7.45% trending down to 4.50% over 9 years

Participants over age 65: 9.50% trending down to 4.50% over 10 years

2023:

Participants under age 65: 7.8% trending down to 4.50% over 10 years

Participants over age 65: 30%, then 9.50% trending down to 4.50% over 10 years

A 1% increase in these rates would increase the present value of the benefit obligation by \$10,678,000 in 2024 and \$11,412,660 in 2023.

Note 9. Postretirement Benefit Obligations (continued)

Disabled - 110% of the Pri-2012 Blue Collar Disabled Retiree Headcount Weighted Mortality Table, projected generationally from 2012 with Scale MP-2021

During the year ended December 31, 2024, the change in the discount rate from 4.75% in 2023 to 5.40% in 2024 increased the benefit obligation by approximately \$7,000,000. Higher than expected projected claim costs and changes in the self-pay rates also increased the postretirement benefit obligation by approximately \$6,600,000. Changes in demographics decreased the postretirement benefit obligation by approximately \$3,900,000.

During the year ended December 31, 2023, an actuarial experience gain lowered obligations by \$6,284,640, primarily due to demographic changes. Valuation assumptions increased obligations by \$2,890,362. The assumption changes included updating the future trend on health costs (which includes the estimated impact of the Inflation Reduction Act on future prescription drug costs for Medicare eligible retirees), updating the retiree contribution rates and decreasing the discount rate from 5.00% to 4.75%.

The cost of the postretirement benefit obligations is shared by the participating employers and retirees. For the years ended December 31, 2024 and 2023, retirees were projected to contribute approximately 24% and 23%, respectively, of the estimated cost of providing their postretirement benefits.

The foregoing assumptions are based on the presumption that the Plan will continue. Were the Plan to terminate, different actuarial assumptions and other factors might be applicable in determining the actuarial present value of the postretirement benefit obligation.

Note 9. Postretirement Benefit Obligations (continued)

The Plan's deficiency of net assets over benefit obligations relates primarily to the postretirement benefit obligation, the funding of which is not covered by the contribution rate provided by the current collective bargaining agreements. However, the Plan empowers the Board of Trustees to increase or decrease annually the amount of self-payments by eligible retired participants and to modify the terms and conditions under which retiree eligibility may be maintained; therefore, the annual cost to the Plan can be reduced or eliminated prospectively by action of the Board of Trustees.

Note 10. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits. The current economic environment has increased the degree of uncertainty.

The real estate investment fund owned by the Plan may use interest rate swaps and caps in order to reduce the effect of interest rate fluctuations of certain real estate investments' interest expense on variable rate debt. The estimated fair value of this fund, as determined by the investment manager, may vary significantly from the prices at which the real estate investments within the fund would sell, and the amounts could be material.

The actuarial present value of benefit obligations is reported based on certain assumptions pertaining to interest rates, health care inflation rates, and employee demographics, all of which are subject to change. Due to uncertainties inherent in the estimations and assumptions process, it is at least reasonably possible that changes in these estimates and assumptions in the near term would be material to the financial statements.

The Plan has a significant portion of its assets invested in two mutual funds that represented approximately 47% and 39% of the Plan's net assets available for benefits at December 31, 2024 and 2023, respectively. It is reasonably possible that changes in the fair value of these funds could materially affect the amounts reported in the statements of net assets available for benefits. If a significant decline in the fair values of these investments during the next year occurred, a change in the assumed rates of return used to calculate the present value of postretirement benefit obligations may be needed.

For the years ended December 31, 2024 and 2023, contributions from one employer accounted for approximately 12% and 9%, respectively, of total employer contributions. In the event this employer were to suspend contributions, the Plan would terminate coverage to the employer's participants, as outlined in the Plan document, and retain the risk of meeting current fixed administrative expenses until the approximate adjustments were made.
