NOTE 1. DESCRIPTION OF THE PLAN

General information pur-
mation.

Generally all employees of
the Company are eligible for the Plan. It is subject
to the provisions of the Internal Revenue Code of 1974 (ERISA).

The Plan is a defined contribution plan in the form of salary de-
posits up to the maximum permitted allowable, but to exceed the limits of Code Sections

C. Participant Accounts. Each participant's account is credited with the participant's contri-

earnings, account balances, or specific performance objectives. The benefit to
which a participant is entitled is the benefit accrued from the participant's
vested account.

D. Vesting. Participants are immediately 100% vested in their Company match

- D. *Expenses.* Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.
- E. *Estimates.* The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from these estimates.
- F. *Subsequent Events.* In preparing these financial statements, the Company has evaluated events and transactions for potential recognition or disclosure through the date of the independent Auditor's Report, which is the date the financial statements were available to be issued.

NOTE 3. FEDERAL INCOME TAX STATUS

The Company adopted a non-standardized profit sharing 401(k) plan using a prototype 401(k) plan document sponsored by PFC Advisors, Inc. The Company is relying on the opinion letter dated June 10, 2020 as obtained and updated by the sponsor and has not applied for an individual determination letter. The Company believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code and that therefore the Plan qualifies under the section 401(a) and the related trust is tax exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

The Plan's Form 990 information returns are subject to examination by the Department of Labor generally for three years after they are filed. Management has evaluated the tax positions taken and the net economic consequences and are not more likely than not to be sustained upon examination.

NOTE 4. PLAN REGISTRATION

Although it has not exercised any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA.

NOTE 5. CERTIFIED INFORMATION

Certain information related to investments disclosed in the accompanying financial statements and ERISA required supplemental schedule, including investments held at December 31, 2024 and 2023 and appreciation in the value of investments, and interest and dividends for the year ended December 31, 2024 was obtained by management and agreed to or derived from independent sources that are complete and accurate by Citicorp Bank, the trustee of the Plan.

NOTE 6. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities, and the lowest priority to unobservable inputs. The fair value measurement hierarchy is defined in FASB ASC 820 and the hierarchy is as follows:

Level 1. Fair value inputs include unadjusted quoted prices in active markets for identical assets or liabilities that the plan can access at the measurement date. The fair value of mutual funds is based on quoted net asset values of the shares held by the Plan at year-end.

Level 2. Fair value inputs include significant other observable inputs (other than Level 1 inputs such as quoted prices for similar assets, quoted prices in markets that are not active or other observable inputs that can be corroborated by observable market data). There were no fair value measurements requiring the use of Level 2 inputs for the period presented.
