**NOTES TO FINANCIAL STATEMENTS**

**NOTE 1 - DESCRIPTION OF THE PLAN**

The following description of the RBG Management Local 1262 Profit Sharing Plan (the “Plan”), sponsored by RBG Management Company, Inc. (the “Company”), provides general information only. Participants should refer to the plan agreement for a more complete description of the Plan’s provisions.

**General** - The Plan is a defined contribution plan covering all members of Local 1262 in the Company’s Jersey City, New Jersey supermarket who have met the eligibility requirements. The Plan was established by the Company as of August 1, 2010. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

**Eligibility** - Employees are eligible on the first day of the month following the completion of at least one year of service.

**Contributions** - The Company contributes an amount equal to \$0.70 per hour worked by each eligible employee subject to a maximum of 2,080 hours per plan year. Effective May 1, 2024, the Company contribution increased to \$0.80 per hour

**Participant Accounts** - Each participant's account is credited with the Company’s contribution and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined by the Plan Document.

**Vesting** - Participants are vested immediately in the Company contributions plus actual earnings thereon.

**Payment of Benefits** - Participants or their beneficiaries are entitled to receive the entire amount of their interest in the Plan upon retirement, death, disability, employment or plan termination, reaching normal retirement age as defined in the Plan. Upon termination of service, a participant may elect in writing to defer benefit payments until a date no later than his/her normal retirement date. A terminated employee may elect to receive the balance in his/her account in the form of a single lump-sum payment, a direct rollover.

**Investment Options** - The Plan’s assets are held in an unallocated brokerage account which invests primarily in mutual funds. All investment transactions are directed by the Plan Administrator.

**NOTE 1 - DESCRIPTION OF THE PLAN (Continued)**

**Plan Expenses** - All costs and expenses with regard to the purchase or sale of investments are paid by the Plan. The Company pays administrative expenses. Personnel and facilities of the Company have been used by the Plan for its accounting and other activities at no charge to the Plan.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Accounting** - The Plan's financial statements are presented on the accrual basis of accounting.

**Investment Valuation and Income Recognition** - The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits** - Benefits are recognized when paid.

**Use of Estimates** - The preparation of financial statements in accordance with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Risks and Uncertainties** - The Plan's investment options may include any one or a combination of stocks, bonds, fixed income securities, mutual funds, and other investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

**Fair Value Measurements** - ASC Topic 820 *Fair Value Measurements* defines fair value, establishes guidelines for measuring fair value, and expands disclosure regarding fair value measurements.

Plan management is not aware of any events subsequent to the balance sheet date which would require additional adjustment to, or disclosure in, the accompanying financial statements.

ASC Topic 820 provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC Topic 820 are described as follows:

*Level 1* - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the plan has the ability to access.

*Level 2* - Inputs to the valuation methodology include quoted prices for similar assets and liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

*Level 3* - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at June 30, 2024 and 2023.

*Mutual funds*: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's assets at fair value as of June 30, 2024 and 2023.

**NOTE 4 - TERMINATION PRIORITIES**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would remain 100% vested in their employer contributions.

**NOTE 5 - TAX STATUS**

The Plan uses a prototype plan document sponsored by Fair Fitzgerald & Hershaff PC. Fair Fitzgerald & Hershaff PC obtained a favorable determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype document satisfies the applicable requirements of the Code. The Plan itself has not received a determination letter from the IRS.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain tax position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Plan management believes it is no longer subject to income tax examination for years prior to 2020.
